Motion M2020-56 authorizing the City Manager or his designee to apply for a grant of \$226,169 from the SC Department of Public Safety's Office of Highway Safety and Justice Programs (OHSJP) for the purpose of purchasing an IBIS Trax-HD3D system which will provide access for inhouse gun cartridge casing review and the ability to enter casings into NIBIN (National Integrated Ballistic Information Network), to record the appropriation of such grant funds in the amount that may be approved, and to execute and deliver the grant agreement and such related documents as may be required to put the grant into effect. No match is required.

The IBIS technology contributes to the investigation process by helping the Police Department to solve more firearm-related crimes. The use of NIBIN will allow the Police Department to provide investigative support to our community and our neighbors to investigate incidents that involve a firearm. The focus of the Myrtle Beach Police Department would be to serve as a hub for where we can process this information and provide the investigative lead to assist in solving cases.

NIBIN is the only national network that allows for the capture and comparison of ballistic evidence to aid in solving and preventing violent crimes involving firearms. It is a resource that is vital to any violent crime reduction strategy because it provides investigators with the ability to compare their ballistics evidence against evidence from other violent crimes on a local, regional and national level, thus generating investigative links that would rarely be revealed absent the technology.

The Myrtle Beach Police Department has partnered with the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) in utilizing the National Integrated Ballistic Information Network (NIBIN) to identify and investigate violent crime in the Grand Strand region of South Carolina. To maintain this successful collaboration and to expand ongoing NIBIN initiatives, ATF strongly supports the addition of a grant-funded unit to your agency.

Most recently, our ATF Columbia and Charleston Field Offices collaborated with your evidence technicians to coordinate the examination of ballistic evidence using one of ATF's NIBIN mobile units.
