This will be Myrtle Beach Golf Carts 7th rental season. I am also co-owner in Ace Golf Carts in North Myrtle Beach. We currently have 6 rental locations and in previous years have had up to 12 at one time. We'd also like to add that we ONLY rent golf carts and NOT mopeds. We are asking for the same 185 units we were approved for in the 2017, 2018 and 2019 seasons. Unlike our competitors, we personally own all of our carts and purchased them for the sole intention of renting. We have also explained at previous ordinance committee meetings, workshops and council meetings that at no time in the year are all 185 carts available for use in Myrtle Beach. More than half of our rentals are located at sub-locations within North Myrtle Beach while many others are used in Surfside, Garden City, and Murrells Inlet. We simply like to make them all comply with the City of Myrtle Beach requirements so they can easily be moved around in the event any are being serviced, damaged indefinitely or in need of minor repair. It makes our daily operations much easier when we have this ability. For example, we may need to replace a 6 passenger with a dead battery to a customer in Myrtle Beach and the only comparable cart available can come on a truck already on its way back from a North Myrtle Beach location. We leave the same carts at each sub location unless we are sold out, one breaks down and we need to move one from another location. Our locations in Myrtle Beach are as follows:

- 1. Myrtle Beach Golf Carts Main Location 408 3rd Avenue S.
- 2. \$7.99 Beachwear 2nd Avenue S. (Sub Location)
- 3. USA Beachwear- 13th Avenue S. (Sub Location)

It is imperative to maintain our sublocations approval as well as our own in order for us to succeed as a family owned and operated business as sales were down 29% in 2018. We wanted you to have this explanation so you can better understand how our business works.
