1. Next week's [meeting schedule](#) is attached.
2. **On Monday, February 3, look for improvements to begin at five pedestrian crossings on Coventry Drive in the Market Common area.** Public Works staff will install high-visibility pavement markings at the crosswalks, along with additional pedestrian crossing signs. The effort enhances drivers' awareness of pedestrian crosswalk locations. The goal is to complete one intersection per week, weather permitting. The five Coventry intersections will be completed in the following order: Thornbury Drive, Yorkshire Parkway, Heritage Loop, Berkshire Avenue and Prescott Circle/Golden Chestnut Way.
3. **Everyone's invited to the South Carolina Hall of Fame Induction Ceremony at 10:30 a.m., Friday, February 7, in the ballroom of the Myrtle Beach Convention Center, 2101 North Oak Street.** The event is free and the South Carolinians to be inducted include Dr. Leo Twiggs, Elizabeth Evelyn Wright and Darius Rucker. The hall of fame celebrates South Carolinians who have made honorable contributions to our state and country.
4. **Beginning February 10, some 425 Myrtle Beach customers will switch their solid waste and recycling collection day from Monday (Zone 1) to Tuesday (Zone 2).** All customers affected will be notified via hang tags on pelican containers in the coming weeks. 5. **Looking for something to do in Myrtle Beach?** Visit our [Events](#) webpage for a comprehensive list of activities. This file of city-related festivals, concerts, programs and more is updated weekly.

6. **The first session of this year's *MyBeach 101* class met Thursday evening, and that's the subject of our [Photos of the Week](#).** *MyBeach 101* is a citizens' course in general government for residents of Myrtle Beach. During the eight weeks, class members will hear from every city department and learn about their operations, from Parks to Public Works and Finance to Fire. Thirty participants were accepted for the program, and the first meeting was held at the Historic Myrtle Beach Colored School Museum and Education Center. Future meetings will be held at locations around the city to give students a full appreciation of city services.

7. **Did you know...** That the Myrtle Beach Fire Department answered 14,492 calls for service during 2019? Of those, 9,310 were for medical calls (EMS and Rescue, including car wrecks), by far the most common reason. Of the remaining calls, 1,679 were false alarms; 1,685 were general service calls; 1,341 were "good intent" calls; 158 were for hazardous materials; and only 278 were for actual fires. The Fire Department also conducted 4,428 property inspections during the year, discovering 3,983 code violations.
