1. Next week's [meeting schedule](#) is attached.
2. **The City of Myrtle Beach is standardizing its business license year with other communities across the state.** City Council approved in the change in January, and it takes effect in April 2020. The new due date for business license renewal payments is April 30, with late payments becoming delinquent on June 1, 2020. However, the delinquency date is being delayed one year so that businesses have time to adjust to the new due date. In the following year (2021), payments will be considered delinquent on May 1. This puts Myrtle Beach on the same business license year as other cities. Myrtle Beach already accepts the uniform business license application form. Statewide, a shared portal is being developed which will allow all license holders to renew licenses with one application for all participating jurisdictions where the business is licensed.
3. **16th Avenue South will be closed to traffic between Kings Highway and Yaupon Drive for the next few days.** The closure is needed to install storm drain pipes as part of the Yaupon Drainage Project. The \$900,000 effort includes two new storage ponds and underground drains at the South Seas condominium complex. The closure is during daytime hours only, through Wednesday, February 26.
4. **As part of the underground utility conversion project, a road closure will affect the intersection of Swallow Avenue and Pampas Drive on Monday, February 24.** The closure will occur from 7:00 a.m. to 5:00 p.m., weather permitting.

5. **As you may have noticed on our Facebook page earlier this week, work is progressing on the Charlie's Place project on Carver Street.** The city will say "thank you" to the contractor, Grand Strand Builders, with a pizza lunch for the crew at 12:00 p.m., Wednesday, February 26. The contractor is recreating the Whispering Pines Motel at Charlie's Place. The media will be able to view the project, too, for an update.
6. **Courtesy of a grant from the South Carolina Department of Commerce's Office of Innovation, the City of Myrtle Beach's Technology Advisory Group offers a free, eight-session "Angel Investing 101" series in 2020.** The series is taught by experienced investors and participants are under no obligation to invest. The first session is set for 8:00 a.m. to 1:00 p.m., Thursday, February 27, at the Sea Captain's House, 3002 North Ocean Boulevard. **2nd Reading Ordinance 2020-005 granting a franchise agreement for operation of rental business of conveyances regulated by Chapter 12, Article V, of the Code of**

**Ordinances of Myrtle Beach to Austin Shelley d/b/a Ajax Golf Cart Rentals, located at 1307 Nature's Way, North Myrtle Beach, SC 29582, for a period of one year. The agreement includes 24 golf carts.**

*This company was approved for a franchise agreement covering 24 golf cart rentals in 2019. For 2020, the applicant requests 24 rentals.*

**2nd Reading Ordinance 2020-008 granting a franchise agreement for operation of rental business of conveyances regulated by Chapter 12, Article V, of the Code of Ordinances of Myrtle Beach to David Stone d/b/a Go Fast Motorsports LLC, Go Fast Scooters, located at 609 South Kings Highway, Myrtle Beach, SC 29577, for a period of one year. The agreement includes 31 golf carts and 84 mopeds.**

*This company was approved for a franchise agreement covering 31 golf cart rentals and 84 mopeds in 2019. For 2020, the applicant requests 19 additional golf carts.*

**2nd Reading Ordinance 2020-009 granting a franchise agreement for operation of rental business of conveyances regulated by Chapter 12, Article V, of the Code of Ordinances of Myrtle Beach to David Stone d/b/a Go Fast Motorsports, Sunshine Scooters, located at 713 North Ocean Boulevard, Myrtle Beach, SC 29577, for a period of one year. The agreement includes 10 golf carts and 25 mopeds.**

*This company was approved for a franchise agreement covering 10 golf cart rentals and 25 mopeds in 2019. For 2020, the applicant requests 10 additional golf carts.*

**2nd Reading Ordinance 2020-018 amending the Code of Ordinances, Chapter 14, Offences and Miscellaneous Provisions, Article 11, Public Place Restrictions, Division 7 Public Parks, Section 14-316, Specific Public Park Restrictions, to clarify the restrictions regarding dogs in public parks, to clarify the authority to promulgate additional parks rules and regulations pertaining to the use of public parks, and the purposes for which such rules may be promulgated.**

*This proposed ordinance:*

- *Codifies a long-standing practice that dogs are allowed in public parks, provided they are under the control of their owner and on a leash (except for “dog parks”).*
- *Allows the City Manager to set additional regulations applicable to specific parks for up to 30 days without Council’s approval. Currently, the Parks, Recreation and Sports Tourism Director has that authority, subject to the City Manager’s review.*
- *Authorizes Council to promulgate rules for specific parks “which may complement or enhance any specific use for which that park is designated.”*

*Changes made at first reading:*

- *Park rules and regulations intended to be permanent must be approved by Council. See M2020-036 designating Nance Plaza, Chapin Park, Plyler Park, Grand Park and Valor Memorial Garden as “special purpose parks” and proposing regulations relating to each.*
- *The proposed closing time for Valor Memorial Garden was revised to 11 p.m. (originally sunset).*
- *Restaurants participating in the café uses envisioned for Nance Plaza are required to assist with the clean-up.*

**1st Reading Ordinance 2020-019 to amend Appendix A Zoning of the Code of Ordinances Sec. 1603.B to increase the maximum height in the R-15 (Single Family) Zoning District from 35 feet to 43 feet.**

*The current height limit in the R15 Single-Family District is 35’ with a minimum combined side-yard setback of 22.5’ (minimum of 10’ on each side). Current regulations provide a height “bonus” of up to 50’ with an additional 1.5’ of additional setback on each side yard per 1’ of additional height. The applicant wishes to build an oceanfront home of 43’ in height without adjusting the side yard set-backs. The proposal would affect all properties located in R-15 zones, including Dunes Club, Dunes Cove, Cliffwood Drive, Myrtle Beach schools and the Myrtle Heights Historic District.*

**Resolution R2020-012 to accept dedication of a certain roadway known as 3rd Avenue South (S-26-84), located between U.S. Highway 501 and U.S. 17 Business (South Kings Highway), from the South Carolina Department of Transportation.**



*Per agreement with SCDOT, upon completion of the 3rd South widening project, the city must take this street into the municipal street system and assume responsibility for maintenance going forward. This action formally accepts that portion of the improved road.*

**Resolution R2020-013 to accept the dedication of a certain roadway know as Rock Dove Road (50' public right-of-way), and portions of certain roadways known as Goldfinch Drive (50' public right-of-way), Lark Sparrow Street (50' public right-of-way) within the Belle Harbor Phase 1A Section of the Belle Harbor Subdivision.**

*Typically, when a subdivision is initially built, the developer will build the road to city standards. When that phase of the subdivision is completed and the city has determined that all standards are met, the city accepts those roads into the municipal street system. Upon acceptance, the city is responsible for all maintenance of that street going forward.*

**Resolution R2020-014 to accept the dedication of portions of certain roadways known as Lark Sparrow Street (50' public right-of-way) and Golden Chestnut Way (50' public right-of-way) within the Belle Harbor Phase 1B Section of the Belle Harbor Subdivision.**

*Typically, when a subdivision is initially built, the developer will build the road to city standards. When that phase of the subdivision is completed and the city has determined that all standards are met, the city accepts those roads into the municipal street system. Upon acceptance, the city is responsible for all maintenance of that street going forward.*

**Resolution R2020-015 to accept the dedication of a certain portion of roadway known as Withers Swash Drive (S-26-542), located southwest of 3rd Avenue South from the South Carolina Department of Transportation.**

*Upon the city's acceptance of 3rd Avenue South as a city street (see M2020-012), Withers Swash Drive will also need to be accepted per SCDOT policy. The policy states that a state owned road (Withers Swash Drive) cannot be accessed by a city owned road (3rd Avenue South). Upon dedication, maintenance of the road and rights-of-way will become the city's responsibility.*

**Resolution R2020-016 granting a special event permit to Ground Zero Ministries, Inc., for the "2020 Dragon Boat Festival" on April 25, 2020, and affirming the city's co-sponsorship.**

*Ground Zero's Annual Dragon Boat Festival is the non-profit's largest fundraising event of the year. For April 25, 2020, the proposed venue is Grand Park at The Market Common. Practice days will be scheduled at the park from April 20-24, 2020, from 3:00 to 9:00 p.m. The event is expected to include more than 50 teams (with 21 paddlers on each team), live entertainment, family fun zone, inflatables, food vendors and sponsor tents. In 2019, Ground Zero Ministries raised \$124,000 from the festival, which helped to sustain the non-profit's numerous community outreach programs.*

*This proposed resolution:*

- *Recognizes the "Dragon Boat Festival" as a community-wide festival event.*
- *Authorizes area businesses to display temporary welcome signs.*
- *Waives the park rental fees for the practice, move-in and move-out days, which total \$1,750.*
- *Extends a warm invitation to all to enjoy the "2020 Dragon Boat Festival."*

**Resolution R2020-017 to seek membership in the AARP Network of Age-Friendly Communities, and matters relating thereto.**

*The network educates local leaders and encourages them to implement changes that make communities more livable for people of all ages, especially older adults. The network provides resources to assist communities to accomplish the following: tap into national and global research, create planning models and form best practices. Membership does not require any financial assistance from the city.*

**Resolution R2020-018 to authorize the temporary obstruction for construction purposes of 2,600 square portion of an alley located adjacent to 918 North Ocean Boulevard to Spann Roofing and Sheet Metal, Inc., for a construction and staging area for the structure located at 918 North Ocean Boulevard to run from March 1-31, 2020.**

*The owners of 918 North Ocean Boulevard will be doing roof work. Their contractor is requesting a temporary obstruction of 2,600 square feet of an adjacent alley to serve as a construction staging area. The public's use of the adjacent alley will be temporarily closed and restricted during the construction period. The contractor is required to return the staging area to a condition equivalent to the pre-construction conditions, and to hold the city harmless from any claims which may arise.*

**Resolution R2020-019 to adopt the Myrtle Beach Housing and Community Development Annual Action Plan and Budget for Fiscal Year 2020-2021.**

*Per the agreement with Horry County, the Myrtle Beach CDBG allocation is expected to be \$394,075 (an increase of \$24,300). CDBG regulations require funds to primarily benefit low/moderate income persons through projects located in low/moderate areas. For Fiscal Year 2020-21, staff propose that funds be programmed for "Neighborhood Infrastructure Improvements," including:*

- *Gray Street Improvements: Curb, Gutter, Sewer, Drainage, etc.*
- *Mary C. Canty Center Parking Lot Expansion*

**Resolution R2020-020 to amend R2019-067 setting out the City's 2020 Legislative Agenda to indicate City Council's support for Senate Bill 869, the "Beach Preservation Trust Act."**

*Senate Bill 869 is proposed to set aside 25% of the state's 5% Admissions Tax for beach renourishment purposes. The funds would be placed in a trust fund managed by the South Carolina Parks Recreation and Tourism Department and would be used to pay half of the local share of future renourishment projects. The fund may also be used to repair significant storm damage to the beach or sand dunes.*
