- 1. Next week's meeting schedule is attached.
- 2. Myrtle Beach Mayor Brenda Bethune will extend the Emergency Declaration for COVID-19 through March. The action automatically extends the city manager's executive order requiring residents and visitors to wear a cloth face mask in enclosed areas of retail stores, grocery stores, pharmacies, personal care businesses, professional services, gyms and fitness centers, among other locations. Retail, restaurant and accommodation staff also must wear masks whenever they are in public areas or working with the public. Failure to wear a mask when required is a civil infraction with a fine of up to \$100 upon conviction. The City of Myrtle Beach thanks our residents, visitors and businesses for following the mask requirement. The Emergency Declaration is valid through March 31 and can be extended or rescinded, as needed.
- 3. Parking meters and pay stations return to service in areas east of Kings Highway on Monday, March 1. In Myrtle Beach, the pay-to-park season is March 1 through October 31. - 8. New playground equipment is in place at Chapin Park, and that's the subject of our Photos of the Week. The new equipment was installed in late December and has been well-received by youngsters. Included are climbing structures, swings, slides and more, for two groups ages two-to-five and ages five-to-12. The playground is part of Chapin Park, adjacent to Chapin Memorial Library, near the intersection of Chester Street and 16th Avenue North. A state grant helped fund the upgrade.
- **9. Did you know...** That the "back gate" intersection of US 17 and Farrow Parkway/SC 707 is officially known as the Bellamy Interchange in honor of the Bellamy Family? The Bellamys originally owned 75 acres in the area, including land on which the interchange sits. The United States government acquired the property in 1941 as part of a larger land acquisition for what would become the Myrtle Beach Air Force Base. The \$100-million-plus flyover bridge was named for the Bellamys in late 2014, in recognition of their history at that site.
