**Re: Meeting Schedule and Agendas**

1. Next week's [meeting schedule](#) is attached.
2. **Construction begins shortly on a new stormwater project that will take four more drainage pipes off the beach between 25th and 27th Avenues South.** A contractor will install 1,110 feet of header pipe parallel to the dunes. The new pipe will connect to the deepwater ocean outfall at 25th Avenue South and pick up stormwater drainage for those two blocks. As a result, four additional pipes will be removed from the beach when the work is complete. Look for mobilization to occur next week, followed by the start of construction on March 15. The \$156,000 project should be completed by April 30.
3. **A section of Withers Drive between 14th and 15th Avenues North will be closed to traffic for the next three weeks during construction of the FunPlex amusement facility.** Withers Drive will reopen to traffic each night. In addition, a portion of 15th Avenue North will be closed for six days following the Withers Drive closure. Detours to Ocean Boulevard or Chester Street will be posted.
4. **Look for the following road sections to be repaved in Myrtle Beach this spring.** The work will occur sometime between now and May 1, thanks to funding from city resources and the CTC (County Transportation Committee).
  - Robert Grissom Parkway, from 21st Avenue North to 29th Avenue North
  - Greens Boulevard, from 21st Avenue North to Mohawk Drive
  - Osceola Street, from Mohawk Drive to Mr. Joe White Avenue

- Louise Drive, from Country Club Drive to Canterbury Lane
  - Oleander Drive, from 38th Avenue North to 48th Avenue North
  - North Oak Street, from First Avenue to Main Street (US 501)
  - South Oak Street, from Collins Avenue to First Avenue

These are “before” photos, although some work already has been accomplished in just two short weeks. Deteriorated roofs are being removed, new laminated beams have been added for support and some interior walls have been torn out. When complete, the now-dilapidated buildings will be ready-to-finish, with new roofs, new HVAC systems and new or restored facades, both front and back. The co-work space, to be known as the HTC Aspire Hub, will be fully finished and ready for entrepreneurs to occupy in late summer, complete with office and conference space. Mashburn Construction is the contractor. Stay tuned for the “after” images in a few months!

**13. Did you know...** That the Myrtle Beach Police Department responded to 124,142 calls for service during 2020? That includes 72,006 calls that were self-initiated by the police officers. In all, the Police Department wrote 10,550 incident reports during 2020 and issued 22,022 citations and warrants during the last calendar year.

Resolutions are actions through which City Council reinforces or makes policy not rising to the level of law. Motions are related to direction from City Council to city staff to take certain actions.*

**REGULAR AGENDA**

**2nd Reading Ordinance 2021-002 to rezone 1.36 acres located at 1002 29th Avenue North from MU-M (Mixed Use Medium Density) to HC-1 (Highway Commercial) for the purpose of holding events.**

*The applicant is the owner of El Cerro Mexican restaurant located at 1002 29th Avenue North. Applicant would like to expand the use of the restaurant and hold special events, such as Cinco de Mayo celebrations; the applicant intends to utilize floor space for bands and dancing as well as charge a cover fee at the door.*

*This description is in line with the "nightclub" use in the zoning ordinance, even though the applicant has stated that they do not want to turn the restaurant into a typical "nightclub." Applicant's property is adjacent to two other zoning districts that allow for nightclubs: E (Entertainment) and HC1 (Highway Commercial).*

*Item was continued from the last meeting to allow the applicant an opportunity to meet and discuss this request with concerned neighbors. The meeting between the parties was scheduled for February 19, 2021.*

*Planning Commission recommends approval as requested (7-0).*

**1st Reading Ordinance 2021-005 granting a franchise agreement for operation of rental business of conveyances regulated by Chapter 12, Article V of the Code of Ordinances of Myrtle Beach, to Austin Shelley doing business as Ajax Golf Cart Rentals, located at 1307 Nature's Way, North Myrtle Beach, SC 29582, for a period of one year. The agreement includes 24 vehicles.**

*This company was approved for a franchise agreement covering 24 golf cart decals in 2020. For 2021, the applicant requests 24 decals.*

- *Nola's Stuffed Snoballs, LLC – Requests selling shaved ice with choice of flavoring.*
- *Big T's Hotdogs and More – Requests selling cheesesteaks, sausage sandwiches, chips and sodas.*
- *VD Vending, LLC – Requests selling cups of fruit.*

**1st Reading Ordinance 2021-019 to rezone 0.11 acres located at 500 First Avenue North/501 Second Avenue North (PIN #443-05-01-0053) from RMM (Residential Multifamily Medium Density) to HC1 (Highway Commercial) to use the property for short-term rental.**

*Applicant owns property on Second Avenue North in the Withers Swash neighborhood and wants to rezone the property from RMM to HC2 in order to utilize the property for short-term rentals. At the March 2, 2021, Planning Commission meeting, the commission recommended denial based on:*

- *Site's inability to meet proposed HC-2 zoning requirements (parking, landscaping and setbacks);*
- *Commercial intrusion into established neighborhood;*
- *Conflict with Comprehensive Plan and Withers Swash plan;*
- *And, public comment in opposition to the rezoning.*

**Motion M2021-033 to re-name the Myrtle Beach Sports Center as, “John T. Rhodes Myrtle Beach Sports Center.”**

*John Rhodes served the City of Myrtle Beach as mayor for 12 years. During his tenure, the city significantly expanded its sports tourism, recreation and athletic facilities, including construction of the Grand Park Athletic Complex and the Myrtle Beach Sports Center and the renovation of several recreation centers. As Executive Director of the Beach Ball Classic, John Rhodes was at the forefront of the sports tourism industry long before it was recognized as such. It is only fitting that we name the Myrtle Beach Sports Center in his memory, in recognition of his decades of support and advocacy for the youth of our community and the growth and development of our tourism industry, especially through athletic events. Mayor Rhodes died suddenly in January 2020 from COVID-19.*

**Motion M2021-034 to declare certain vehicles abandoned or derelict pursuant to the authority of Article 41 of Title 56 South Carolina Code of Laws 2001.**

*This declaration is an effort to improve the appearance of both commercial and residential neighborhoods. The report includes vehicles that staff has tagged as abandoned or derelict. Council's approval allows these vehicles to be towed from their private property locations to a tow yard where they may be reclaimed by the current owner upon payment of the applicable towing and storage fees. If the vehicles are not claimed by the owner within 30 days of the required notice, then the tow company may sell the vehicle and keep the proceeds as compensation.*

**Motion M2021-036 to appoint/reappoint three members to the Planning Commission.**

*The terms of Sally Howard, Don Shanks and Robby Warner expired on February 22, 2021. Ms. Howard and Mr. Shanks both wish to be reappointed; Mr. Warner does not wish to be reappointed. On file, the city has resumes for Steven Jordan (city resident), Michelle Whetstone (city resident), Thomas Robinson (city resident), Thomas Muller (city resident) and Wayne Gray (city resident). All three terms will expire on February 22, 2024.*

**Motion M2021-037 to appoint/reappoint one member to the Beach Advisory Committee.**

*P.G. Winstead's term expires on February 22, 2021. Mr. Winstead does wish to be reappointed. On file, the city has resumes for Michael Hussey (city resident) and Jim DeFeo (city resident).*
