Re: Meeting Schedule and Agendas

- 1. Next week's meeting schedule is attached.
- 2. Myrtle Beach's population grew by nearly 32 percent during the last 10 years! According to the US Census, 8,573 more people called Myrtle Beach "home" in the past decade. Official 2020 US Census numbers released on Thursday show that the City of Myrtle Beach's population increased from 27,109 residents in 2010 to 35,682 residents by April 1, 2020. That's a jump of 31.6 percent in 10 years. Note that these numbers are only for the city limits of Myrtle Beach, which consistently has been one of the fastest growing cities in the country in recent years. Horry County also experienced rapid growth during the past decade. The county's total population jumped from 269,291 in 2010 to 351,029 in 2020, according to today's Census release. That's an increase of 30.35 percent, slightly less than the city's percentage of growth.

The walk begins at Doug Shaw Memorial Stadium, 705 33rd Avenue North, and continues around the grounds of the Myrtle Beach schools. - 5. Myrtle Beach's municipal election is set for Tuesday, November 2, 2021. Registered city voters will choose a mayor and three Council members for four-year terms, 2022-2025. The candidate filing period opens at 12:00 p.m., Thursday, August 19, and closes at 12:00 p.m., Friday, September 3, 2021. The election is both at-large and non-partisan. Prospective candidates must file a Statement of Candidacy (no filing fee) with the City Clerk by the filing deadline on September 3. The South Carolina Ethics Commission also requires a statement of economic interest and a campaign disclosure form. Questions? Contact the city clerk at jadkins@cityofmyrtlebeach.com for information. Myrtle Beach city residents who desire to vote in the upcoming election must be registered by October 1, 2021. Contact the Horry County Voter Registration Office at 843-915-5440 or visit www.horrycounty.org. Absentee ballots must be obtained through Horry County Voter Registration at 1515 Fourth Avenue, Conway, SC.
- 6. Motorists can expect a road closure on Ocean Boulevard, between Third and Sixth Avenues South, next Monday through Wednesday, August 16-18. Detours will be posted. The closure is for removal of a tower crane at the Westgate Resort. In case of inclement weather, the closure will be rescheduled for the following week, August 23-25.
- **7.** Here's your chance to get the COVID Vaccine. The Myrtle Beach Fire Department hosts a weekly vaccination clinic from 8:00 a.m. to 5:00 p.m. on Thursdays at the City Services Building, 921 North Oak Street. Crews administer the Moderna vaccine to registered individuals. To sign up, see https://bit.ly/MBFDVaccine. Please arrive 30 minutes prior to your appointment to allow for pre-screening. - **8.** A comprehensive list of activities and city events is available on our **Events** webpage. This file of city-related festivals, programs and more is updated weekly.
- 9. A street is named in honor of PFC Joe McGarry, one of three Myrtle Beach police officers who died in the line of duty, and that's the subject of our Photos of the Week. Earlier this year, the Myrtle Beach Planning Commission officially renamed Corsair Street at The Market Common as PFC Joe McGarry Street. During ceremonies today, the Police Department welcomed the new street sign. McGarry was shot and killed in 2002 while attempting to apprehend a murder suspect. In addition to the street name, Police Chief Amy Prock also unveiled a historic marker about PFC McGarry and gave copies of the marker and street sign to his parents. A four-year veteran of the force, McGarry was well-known and well-liked by his fellow officers. PFC Joe McGarry Street is next to the Warren S. Gall Police Annex, where officers will see it every day when they come to work. Right-of-way renamings are also underway for two other Myrtle Beach police officers who gave the ultimate sacrifice.
- **10. Did you know...** That a gallon of drinking water costs Myrtle Beach city residents less than one-fourth of a penny? That's the price-per-gallon for the first 4,000 gallons of water each month, even with the small rate increase that took effect August 1. The cost includes the \$3.17 base charge per month and the new use charge of \$1.66 per 1,000 gallons, per month. Put another way, Myrtle Beach residents get four gallons of water for less than a penny, delivered on-demand, directly to your home, around-the-clock. At just 24.5 cents for

100 gallons, that's a bargain. Residential customers who live outside the city limits pay twice as much as in-city residents, so a gallon of water costs them about half a cent, and 100 gallons is about 50 cents.
