



- Pedestrian Safety
 - High visibility crosswalks with artistic design
 - Audible pedestrian signals for the visually impaired
- Traffic signal cameras replacing in-pavement loops
- Scope of Work Update Resurfacing the entire intersection to address defects in pavement and improve aesthetics
- Preconstruction Meeting Held October 26th
 - Balancing material lead time of 16 weeks and cold weather conditions
 - Phased Construction January 2022 to April 2022
 - Underground boring of conduit & traffic camera and audible pedestrian equipment installation
 - Sidewalks and handicap ramps
 - Milling/resurfacing of the intersection and decorative crosswalks










38th Ave N widening R. Grissom Pkwy to Kings Hwy




Kings Hwy Corridor Study
