White-Tailed Deer Regulated Archery Hunting Program

RULES AND REGULATIONS



MANAGEMENT GOALS and OBJECTIVES

White tail deer are an important big game species in the Commonwealth of Pennsylvania, the overpopulation of which can generate public health and safety concerns related to traffic accidents, Lyme disease density, Chronic Wasting Disease, depletion of the understory of woodlands, and damage to private landscaping. It is the responsibility of the Township to recommend and enact means of deer population controls that help mitigate these concerns. Regulated hunting using guidelines established by the Pennsylvania Game Commission is an important tool. Through a regulated white tail deer hunting program on the Township's Properties, New Hanover Township seeks to better manage the white tail doe population by permitting the harvesting of white tail doe populations on such property consistent with current seasons, bag limits and objectives established by the Pennsylvania Game Commission.

The regulated hunting on the Township's Properties will be permitted in limited areas, as depicted on the attached Deer Management Program Maps, and will only be authorized by permit issued by the Township to qualified archery hunters. This controlled hunting permit is limited to antlerless deer only using **Pennsylvania Game Commission's Deer Management Assistance Program (DMAP)**. Participants will be issued a DMAP coupon which they can use at any issuing agent to purchase their DMAP tag.

SAFETY STATEMENT

Hunting within the boundaries of New Hanover Township's Properties is a privilege granted by the New Hanover Township Board of Supervisors through the New Hanover Township Deer Management Program. Archery hunting will be allowed by permit only. New Hanover Township conducts these hunts in an effort to scientifically manage wildlife populations within the Township and in an effort to preserve a balanced ecosystem while providing ongoing viewing opportunities for the general public. The future success of these hunts depends on the ethical and safe conduct of all those who participate in these hunting programs. If these programs are to continue, each participant must make their personal safety and the safety of the public, the first and foremost priority.

All applications must be completed and returned to New Hanover Township by July 31, 2025.

- PA State deer archery deer season runs from September 20, 2025, to December 13, 2025, and from December 26, 2025, to January 24, 2026.
- We will split those dates into an Early Season (9/20/25 – 10/31/25), a Middle Season (11/1/2025 – 12/13/25), and a Late Season (12/26/25 – 1/24/26)
- Half of those picked will be placed in the Early Season slots and half will be placed in the Middle Season Slots. Both groups of individuals will be eligible to hunt the Late Season slots within their zone.
- For this year we will have slots for 32 hunters.

I. APPLICANT SELECTION PROCESS

1. Applications must be submitted to and received by New Hanover Township 2943 N Charlotte St Gilbertsville, PA 19525 either in person or by mail no later than 5:00 PM on 7/31/2025.
2. Applicants must be 18 years old by September 20, 2025
3. New Hanover Township residents who submit an application, and who satisfy all requirements herein will be issued a hunting permit unless the total number of applicants outnumbers the total number of permits to be issued as established by the Township. Under those circumstances, applicant permits will be issued by random drawing conducted on 8/5/2025 at New Hanover Township Municipal Building at 6:30 PM.
4. The Township has authorized a total of 32 permits. Non-Residents of New Hanover Township may also submit an application. When more than the maximum number of permits are received for a zone, the second-choice zone will be used. If there is more than the maximum in the second choice, then the 3rd,

until space is found in a zone. If space is not available in the applicant's selection, they will be assigned to another zone.

5. Applicants seeking to obtain a permit to participate in the Regulated Deer Hunting program must submit a completed application, the form of which is attached hereto, together with information regarding the applicant's archery experience, game law compliance record, and criminal record. Applicants shall also submit an executed copy of the Participant Acknowledgment Form.
6. Applicants who are chosen by the Township to become participants in the Regulated Deer Hunting Program shall complete and execute the Indemnification Agreement attached hereto. The failure of an applicant to submit an executed Indemnification Agreement shall disqualify the applicant from obtaining a permit.
7. Applicants who are chosen by the Township for a permit must demonstrate proficiency with the archery tackle to be used (while hunting) in order to qualify for a New Hanover Township property archery hunting permit.

9. Only those individuals selected to receive a permit may participate in the proficiency process. Each individual must pass the proficiency testing to participate in the Township property archery program. Pass or fail, there is a \$10 cash donation to Frontier Archers Association.
10. The proficiency test shall require individuals using compound, recurve, or longbow to place three (3) of four (4) arrows in an area of a target at twenty (20) yards equivalent in size to the vital area of medium-size whitetail deer. Individuals using crossbows shall be required to place three (3) of four (4) bolts in an area of a target at 30 yards equivalent in size to the vital area of medium size whitetail deer. The bow and arrows to be used for hunting shall be used for the proficiency testing, with the exception that arrows shall be equipped with field points during the proficiency testing. This same rule applies to crossbows and crossbow bolts.
11. All participants are **required** to attend the annual Pre-Hunt Safety Deer Management Meeting in September to receive their permits. This meeting is scheduled on 9/9/2025 at the New Hanover Township Municipal Building at 6:30 PM.

II. RULES AND REGULATIONS FOR HUNTING

1. Archery hunting will be allowed by permit only.
2. This program will utilize the Pennsylvania Game Commission Deer Management Assistance Program (DMAP).
3. Hunting on New Hanover Township owned property is restricted to archery only. Longbow, recurve bow, compound bow, and crossbow hunting are permitted. Archery tackle must conform to that which is specified by the Pennsylvania Game Commission for use during the season.
4. The use of any type of firearm is strictly prohibited.

5. Participants must carry their Township Archery Hunting permit any time they are hunting.
6. BAG LIMITS - Only antlerless deer may be harvested. Harvesting a buck is prohibited. Only DMAP tags may be used. Bag limits on antlerless deer are in accordance with PA Game Laws.
7. BAITING - It is the policy of New Hanover Township that baiting shall not be permitted on New Hanover Township's property.
8. Pennsylvania Game Commission Deer Management Assistance Program (DMAP) will be utilized. Only DMAP **tags** can be used. Selected participants will receive a DMAP **coupon** at the Pre-hunt Safety meeting which they can use to obtain a DMAP **tag** from either an authorized issuing agent or online at huntfish.pa.gov. Participants must possess a valid DMAP **tag**. If the participant harvests a deer, they will be issued another DMAP **coupon** which they can use to purchase another DMAP **tag**. These DMAP **coupons** and **tags** are valid only for hunting on designated New Hanover Township owned properties.
9. GENERAL PROCEDURES - Participants must fill out the Hunting Log Sheet each time they hunt. At the end of that day's hunt, the participant will take a picture of the log and email it to DMC@newhaover-pa.org. Within one week of the end of their designated hunting season, participants must either mail their log or drop it off at the New Hanover Township Municipal Building 2943 North Charlotte St. Gilbertsville, PA 19525. Hunting zones have been established for the whitetail deer management program for each Township site. The archery hunting zones are identified on the respective Deer Management Program Maps, which are forwarded to all participants with their hunting permits and DMAP coupons. Additionally, the Township will post outwardly facing signs to inform residents: that a particular area is part of the White Tail Deer Archery Hunting Program and that residents should wear brightly colored clothing to ensure visibility. If a Participant observes that his/her designated archery hunting zone is not so posted, the Participant shall immediately notify the Township and shall not hunt in the said area unless and until such signs are erected.
10. PARKING - Participants must park their vehicles in the area designated for the assigned hunting area and must display a Township parking permit.
11. Participants must wear a blaze orange hat and vest/coat that meet the minimum square inch requirements specified by the PA Game Commission during the overlapping muzzleloader/shotgun seasons.
12. Participants must hunt a minimum of 15 hours during the 2025 season from September 20, 2025 to January 24, 2026 to be considered for future archery programs as they may occur. *Failure to do so may result in revocation of hunting privileges at the discretion of the Township.*
13. HUNTING ZONES - Archery-only hunting on specific New Hanover Township owned properties is restricted to archery only. Longbow, recurve bow, compound bow, and crossbow hunting are permitted. Archery tackle must conform to that which is specified by the Pennsylvania Game Commission for use during the season. DMAP tags only.
14. Participants may hunt in their assigned zone only and possess a valid DMAP tag. Safety zone boundaries may exceed the 50-yard minimum, as is established statewide by the PA Game Commission for a variety of reasons including safety and respect for adjacent landowners. It is imperative that all hunters adhere to their area boundaries and safety zones accordingly. Deer Management Program Maps illustrating all archery hunting areas will be issued to participants.
15. TREE STANDS - Participants may use blinds and/or tree stands. Portable tree stands; the self-climbing type of tree stand is allowed. Fixed-position stands will be considered, but the type of stand and the proposed location(s) of stands must be approved by the Township. Steps or other devices that pierce the outer and inner bark of trees are not permitted. Participants must supply their own tree stands and must remove the tree stands at the expiration of their hunting permit or the end of the hunting season established by the Township Board of Supervisors, whichever is earlier. Tree stands may be left in place during the season only at the participant's risk. Blinds and tree stands must be removed within 1 week of the close of the

participants assigned hunting season. **Participants must label blinds and tree stands with their permit number so that it may be seen from ground level.**

16. The Pennsylvania Game Law and the New Hanover Township Ordinances and Regulations shall apply. Hunters shall abide by all of the Pennsylvania Game Laws. **The Township DOES NOT allow hunting on Sundays.**
17. The Township reserves the right to discontinue the program at any time.
18. Permits are not transferable.
19. The Township reserves the right to revoke a permit holder's permit at any time.
20. Permit holders who cannot participate in the management program are asked to call the Township to allow staff to make timely adjustments.
21. Participants are permitted to field dress a harvested deer on the Township's property provided that such is generally out of sight of residents. Remains may be left behind but must be placed away from likely human access.
22. Participants shall not make any attempt to harvest a deer while any non-archer is within sixty (60) yards of the targeted deer.
23. Participants shall not make any attempt to harvest a deer within fifty (50) yards of a residence or right of way for access to a residence.
24. Hunting will be for antlerless whitetail deer only. Trapping and/or hunting of furbearers or any other mammal or bird is strictly prohibited.
25. Participants may be checked by law enforcement officers from the Pennsylvania Game Commission, Pennsylvania Fish and Boat Commission, and New Hanover Township Police Department. Each participant must carry and if requested, provide photo identification, hunting licenses, and Township permits.
26. Participants who observe individuals hunting on Township property without a Township-issued permit displayed are requested to notify the New Hanover Township Police Department.
27. All participants are **required** to attend the annual Pre-Hunt Safety Deer Management Meeting in September to receive their permits. This meeting is scheduled on 9/9/2025 at the New Hanover Township Municipal Building at 6:30 PM.
28. Participants shall not be permitted to bring onto the premises, possess or consume any alcoholic beverage or illegal drugs of any kind; no participant shall enter the Township Property for the purpose of hunting in an intoxicated state or otherwise be under the influence of alcohol or controlled substances.
29. Participants must remove all material brought into the hunting area, with the exception of blinds and tree stands as provided in item 11 above.
30. Hunting is only permitted as published by the Pennsylvania Game Commission, Monday through Saturday.
31. Participants who wish to donate their harvest to a charitable organization such as Hunters Feeding the Hungry are encouraged to do so. Additional information can be provided.

III. VIOLATIONS

1. PARTICIPANT VIOLATION OF OR DEVIATION FROM THE NEW HANOVER TOWNSHIP ARCHERY HUNTING PROGRAM RULES AND REGULATIONS SET FORTH IN THIS BOOKLET, AND/OR THE PENNSYLVANIA GAME LAW AND THE U.S. FISH AND WILDLIFE SERVICE REGULATIONS SHALL NOT BE TOLERATED. SUCH CONDUCT, WHETHER WITNESSED BY OR REPORTED TO THE TOWNSHIP STAFF, MAY BE CONSIDERED GROUNDS FOR PERMANENT EXPULSION FROM PARTICIPATION IN THE NEW HANOVER TOWNSHIP HUNTING PROGRAM.
2. The New Hanover Township Police Department *is* authorized to enforce the Rules and Regulations set forth herein.
3. The Pennsylvania Game Commission is authorized to enforce all Pennsylvania game laws and regulations.
4. **The Township may revoke or suspend a Participant's permit for any violation of the Rules and Regulations.**

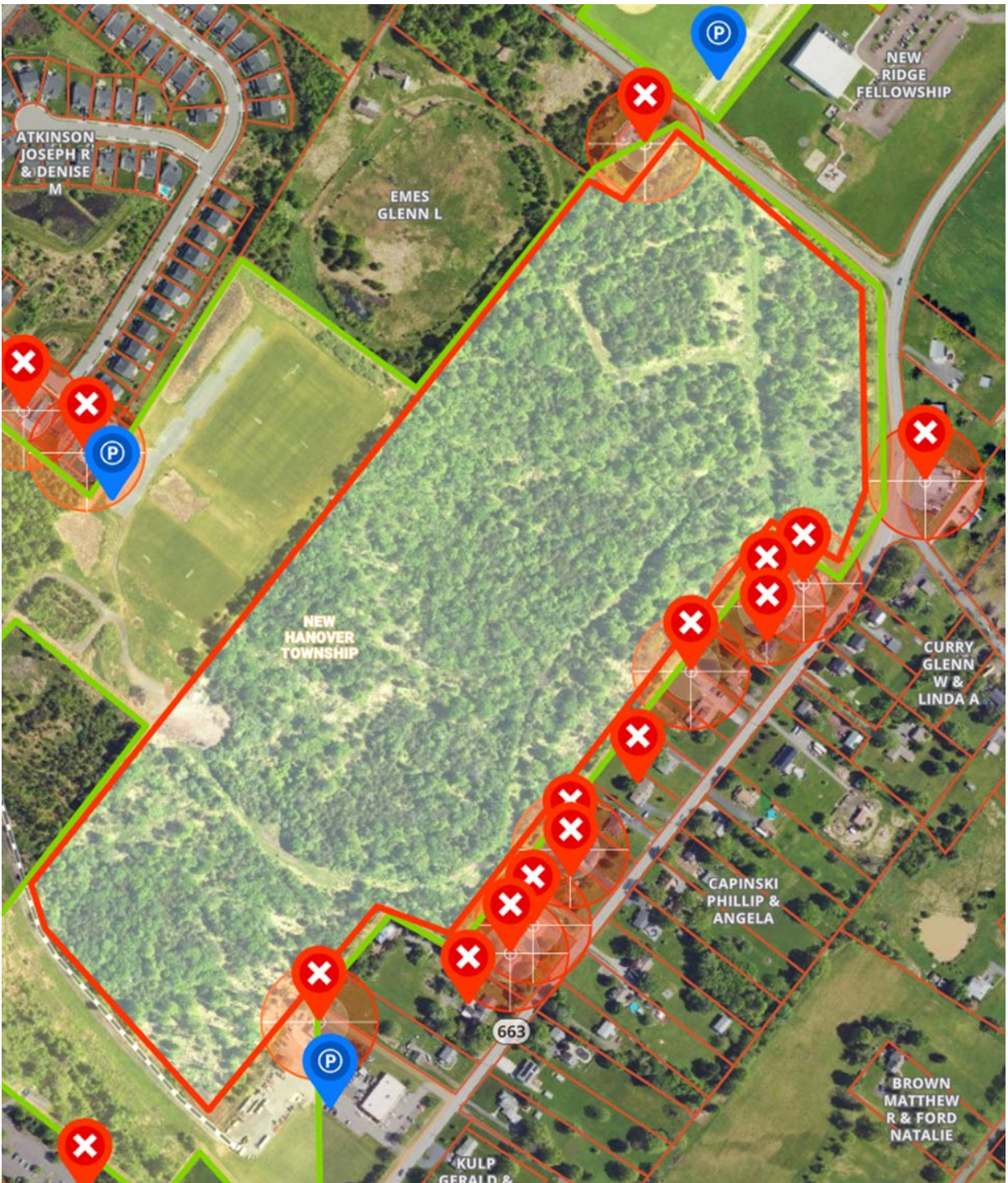

Zone 1 - Wassmer Tract: Center point GPS coordinates 40.305.09 – 75.58309

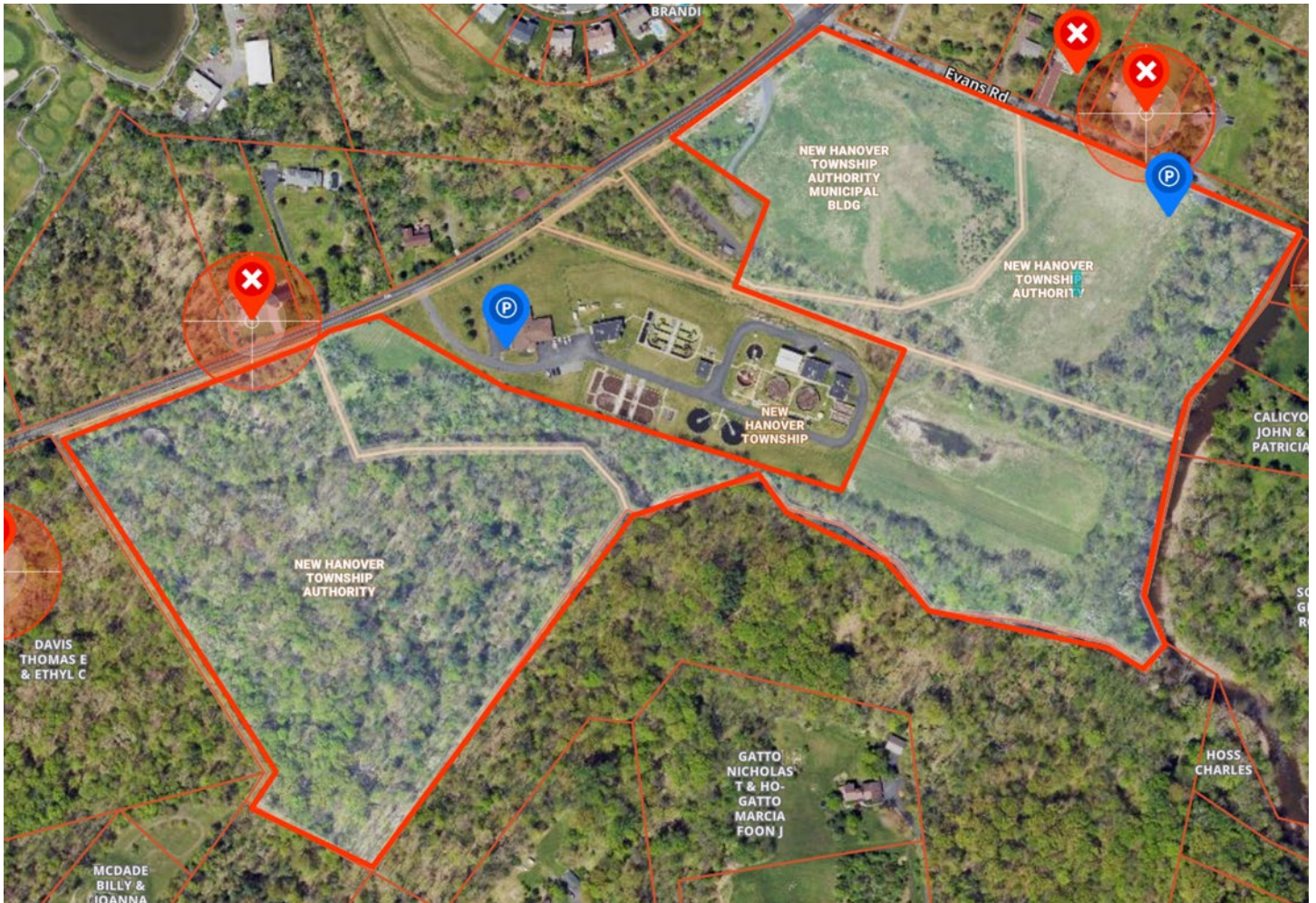
Located behind the New Hanover Township Building 2943 N. Charlotte St. Gilbertsville

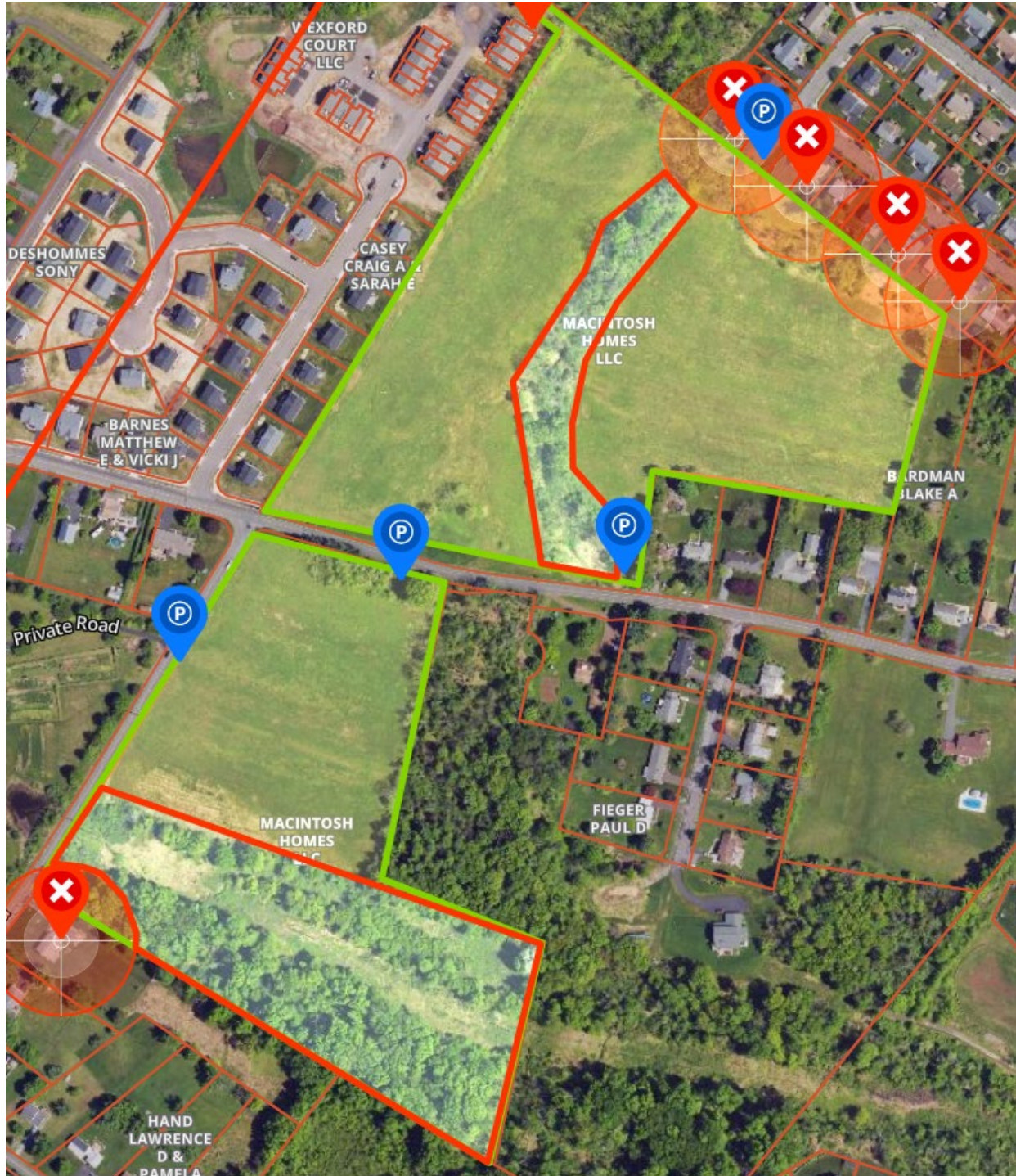


Zone 2 - New Hanover Township Authority: Center point GPS coordinates 40.29057 – 75.60842. 2990 Fagleysville Rd. Gilbertsville – 46 acres. Approximately 8 ½ acres through the center of the property is not included in the program. About 36 acres are included in the program. There is a small section of Safety Zone along Evans Rd. Two branches of Swamp Creek and Evans Rd provide natural line markers for much of the property. **4 hunters.**



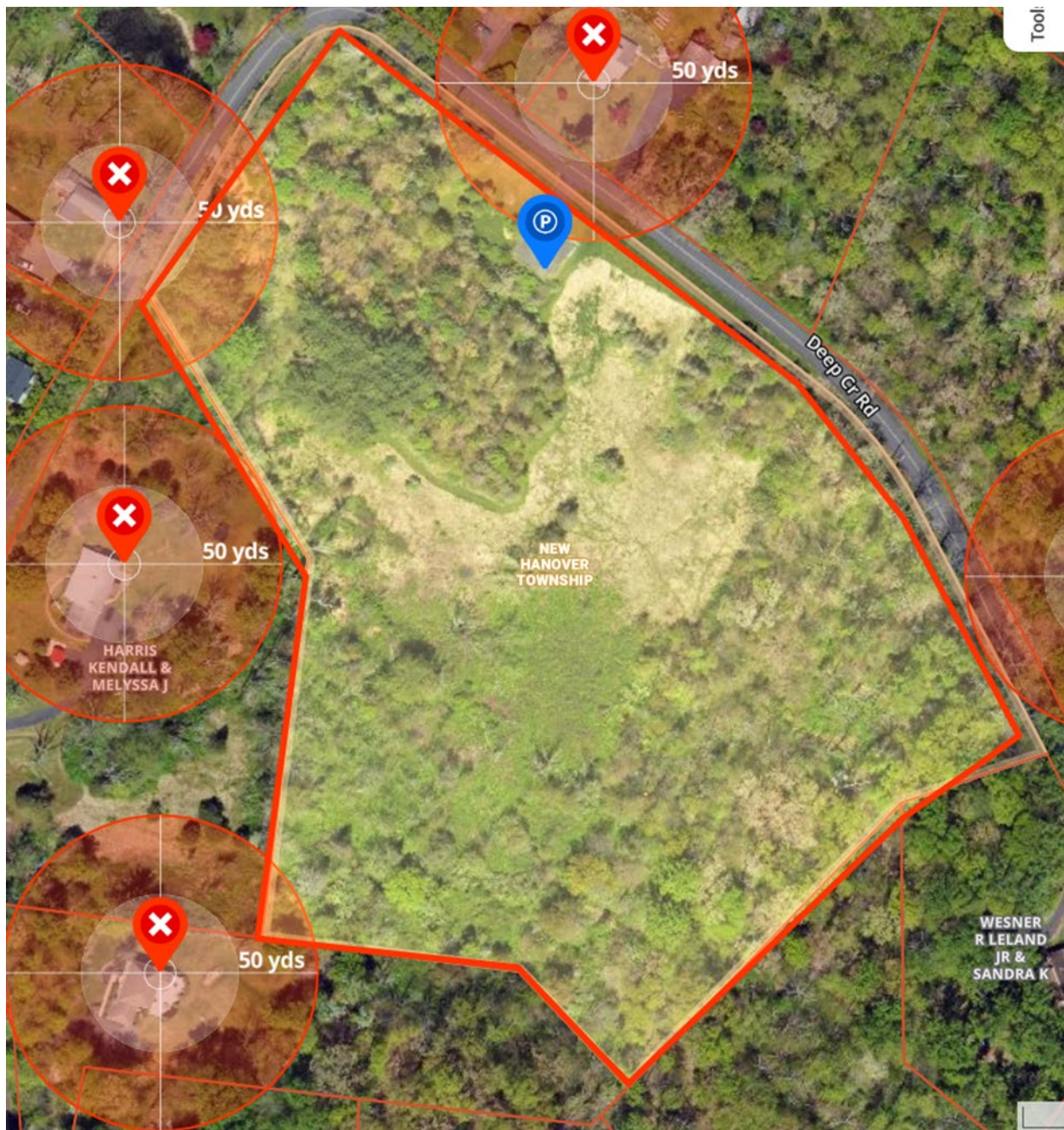
Zone 3 - Moyer Tract North: 35 Acres. Center point GPS coordinates, 40.29057 - 75.60842.
A riparian area of about 2 acres is included. **1 hunter.**

Zone 4 - Moyer Tract South: Center point GPS coordinates 40.28734 - 75.61031
Contains about 7 ½ acres that are included. **2 hunters.**



Zone 5 - Deep Creek Park: Center point GPS Coordinates 40.34794 - 75.53863.

Deep Creek Road (North of Pleasant Run Park), Perkiomenville. Three Safety Zones affect this area. 10.83 acres.
2 hunters.



Zone 6 - Parestis Open Space: Center point GPS Coordinates 40.3421 - 75.554861

Rte. 663 & Little Rd – 19 Acres. No hunting in the open field. 7 ½ wooded acres included in the program.

Zone 7 - Hickory Park: Center point GPS Coordinates 40.31542 - 75.56691.

2140 Big Road. 20 acres. The 4 $\frac{3}{4}$ acres section on the south side of the park near the Public Work's brush pile is included in the program. The area is bounded by the brush pile on the north, Liberty Development Corp on the east, and Swamp Creek on the south and west. **1 hunter.**
