**PROPOSALS FOR THE FIREMAN’S YOUTH PARK (FYP) PICKLE BALL COURTS BY GROUPS**

Niles Charter Township shall be guided by the policies considering proposals for the use of FYP Pickle Ball courts.

- A. Niles Charter Township shall have absolute authority and control over courts.
- B. All requests are to be posted with the time and date received at the township general offices.
- C. Niles Charter Township shall grant a group exclusive use of FYP Pickle Ball courts for the purpose of regularly scheduled tournaments in an organized league.
- D. Use of FYP Pickle Ball courts by a group or individuals will be scheduled on a first come first serve basis, no more than 2 (two) days per team per week. All permits will be limited to a 3 (three) hour maximum time limit.
  - 1. Requests for regularly scheduled tournaments in an organized team from Niles Charter Township shall have first priority.
- E. All permits for tournaments shall be supplied through the Niles Charter Township general offices providing the date(s) and time(s) do not conflict with any previously approved request(s). In which case, the request must be made to the contact person holding the permit.
- F. The agreement for use of the FYP Pickle Ball courts shall be signed by a person 18 years of age or older and said signer shall be responsible for: seeing that the terms of the agreement are observed and complied with: for any damage done to the courts, equipment and grounds or injury to any person thereon caused by any person or animal associated with the agreement signatory during the period of use stated, and the signatory shall reimburse, indemnify, and save Niles Charter Township fully harmless therefrom; in keeping the Pickle Ball courts and surrounding grounds in neat and orderly condition, free from rubbish and debris accumulated by the signatory.
- G. Intoxicating beverages and illegal drugs are PROHIBITED within the courts and surrounding park.
- H. Reservations will only be valid between April 1<sup>st</sup> and November 1<sup>st</sup> in the calendar year the permit is granted.

Agreements for weekly and or monthly repeated use require Township Board approval and must be submitted at least 30 days prior.
