AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PLEASANTON, TEXAS, ORDERING A SPECIAL ELECTION TO BE HELD ON MAY 7, 2022 FOR THE CONSIDERATION OF THE AMENDMENTS TO THE HOME RULE CHARTER OF THE CITY OF PLEASANTON; ESTABLISHING THE TIME AND PLACE FOR EARLY VOTING; AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLEASANTON, TEXAS;

Section 1. That there will be a Special City Election on May 7, 2022 for the consideration of the amendments to the Home Rule Charter of the City of Pleasanton as outlined in “Exhibit A”. The polls will be open from 7:00 a.m. to 7:00 p.m. on Election Day.

“EXHIBIT A”

Section 1. Regular Meetings and General Powers

The City Council shall conduct regular meetings on the ~~first and third Thursdays~~ _____ of each month. Special meetings may be called by the Mayor or at the request of three Councilmembers. At any meeting of the Council, a future meeting may be canceled by a majority vote of all members of the Council present. Notice of such cancellation shall be posted in accordance with applicable laws. The City Council shall see that all ordinances necessary and proper for carrying out the powers and duties prescribed in this Charter are passed and enforced. The City Council shall promote, in any way it sees fit, subject only to limitations imposed by the Constitution and laws of this State or by the provisions of this Charter, the welfare of the City and its inhabitants.
