Meeting called to order 4:03 p.m.

A. Roll Call

- a. Mr. Frontera, Mr. Hogan, Mr. Merucci and Mr. Switalski are present. Mr. Adkins arrived at 4:15 p.m.

B. Approval of Minutes for meeting on July 10, 2019

- a. Motion to approve the July meeting minutes was made by Mr. Switalski and supported by Mr. Merucci. All approved, none opposed. Motion passed.

C. Approval of Disbursements and Budget Report

a. Disbursement #1

- i. Motion to approve disbursement #1 was made by Mr. Switalski, supported by Mr. Merucci. Mr. Merucci requested that the font gets enlarged for easier reading. All approved, none opposed. Motion passed.

b. Disbursement #2

- i. Motion to approve disbursement #2 was made by Mr. Switalski, supported by Mr. Merucci. All approved, none opposed. Motion passed.

c. Revenue/Expense Report

- i. Motion to approve the revenue/expense report was made by Mr. Switalski, supported by Mr. Merucci. All approved, none opposed. Motion passed.

D. Hearing of the Public – agenda items only

- a. Mr. Lipinski shared that the newsletter did get mailed out late this year. There were a few delays with Litho Printing and the newsletter. There was also an issue with the bulk mail service at the Post Office.

G. New Business

a. Update from Chris Nordstrom, Carlisle-Wortman, on Recreation Master Plan.

- i. Mr. Lipinski received an email with all the up to date summary on the Master Plan. Mr. Nordstrom will be attending the Resource Fair on Friday, September 20th instead of the meeting tonight. The summary goes into detail of the responses received from June 6 through September 9, 2019.

b. Request approval to provide bonus to Amanda Hughes and Adam Just for added responsibilities during transition between Assistant Directors.

- i. Mr. Lipinski stated that during the transition they did have added responsibilities and really stepped up to help out; as well as when Sara started. Motion to approve the bonus was made by Mr. Merucci, supported by Mr. Frontera. All approved, none opposed. Motion passed.

c. Request to set a date for meeting for a Goal-setting session.

- i. Mr. Merucci believes this is something we should undertake and have all staff attend including Chris Nordstrom. Mr. Lipinski agrees and comments that this should be something incorporated in the Master Plan. It was agreed upon to tentatively have a meeting on October 3rd 10:00 a.m. – 2:00 p.m.

d. Update on status of Recreation Center Building.

- i. Mr. Lipinski stated that most of the issues have been resolved. Mr. Adkins suggested sending a correspondence stating that we would like the project closed out by November 1st and a full final report on November 13th. Motion to approve sending a correspondence in regards to the Recreation Authority Center projects was made by Mr. Merucci, supported by Mr. Hogan. All approved, none opposed. Motion passed.

H. Hearing of the Public

- a. Mr. Gary Sasek, Eastpointe Parks Commission, questioned when (as part of the Master Plan Steering Committee) another meeting would be. Mr. Lipinski responded that he does not have a date right now but will be checking with Mr. Nordstrom on a date.
- b. Mr. Harvey Creech, Eastpointe Resident, commented/questioned on the City Parks and whom responsibilities fall under.

I. Discussion by Director

- a. Mr. Lipinski stated that the newsletter did go out, we are getting a lot of registrations and the cover of the newsletter highlights the Resource Fair. The Resource Fair is on September 20th, Senior programs from 10:00 a.m. – 2:00 p.m. and all programs from 4:00 p.m. – 7:00 p.m. Motor City Bears is currently using one of the parks for their practices and was asked to not come back for the next season. Bargain Hunters had the most vendors we have ever had. Football season began, Eastpointe Community Schools, Tiger Cats and Roseville Junior sports are using the field for this season. The field is much improved from last season due to the maintenance on it. Complimented the City of Eastpointe on the new playground equipment at Roxana Park. The Fitness Court at Huron Park is scheduled for installation this coming weekend.

J. Discussion by Board Members

- a. **Mr. Switalski** – Nothing at this time.
- b. **Mr. Hogan** – Questioned if there was any progress with Huron Park Fields (Diamond 1).
- c. **Mr. Frontera** – Nothing at this time.
- d. **Mr. Merucci** – Commented that he was in favor of the Roseville football team using the Eastpointe Memorial Football Field. With respect to the concession stand, we (City of Eastpointe) are planning on renovating the building starting in January.
- e. **Mr. Adkins** – Would still like to get the Park boards together, probably closer to January, for a meeting.

RE: Recreation Plan Survey Analysis

The following is a summary of the results of the RARE/Easpointe/Roseville Recreation Plan survey which was available online from June 6, 2019 through September 9. The survey was advertised on the RARE, Eastpointe, and Roseville websites, on social media, and at stands at Rosefest and Sizzlin' Summer Nights. 270 responses were received during that time; 167 responses (61%) came from Eastpointe residents, 94 (35%) from Roseville residents, and 4% from other communities (Clinton and Harrison Townships, Fraser, and St. Clair Shores).

The results of this survey will be combined with other comments received by the three agencies and at an upcoming meeting on September 20 to finalize recommendations for the park systems. For purposes of brevity, where responses are broken out by city in the analysis below, Overall will be abbreviated to OV, Eastpointe to EP, and Roseville to RV.

RESPONDENT BACKGROUND

The vast majority of respondents (94%) resided in single-family homes (98% EP, 90% RV). 27.6% of households had children under 18 (EP 22%, RV 34%). The largest age group (29% OV) was between 35 and 44 years old, while the second largest (28% OV) was between 55 and 64 years old. Roseville's senior population (ages 65 and older) was more active in the survey than Eastpointe's (22% for RV to 13% for EP), and the percentages of seniors reporting in the survey was higher than the general population for each city (22%/13% for RV, and 13%/11% for EP). This latter statistic could suggest a slight bias towards senior activities and facilities in the overall survey results.

GENERAL COMMENTS

The top priority for residents was maintaining existing city parks. 98% (98% EP, 97% RV) considered maintenance "Important" or "Very Important". Maintaining existing programming (OV 91%, EP 93%, RV 88%) and developing new programming (OV 88%, EP 91%, RV 84%) were also very popular.

The open ended comments at the end of the survey mentioned a need for better communications. One participant noted, "I stumbled upon this survey. I was not made aware of it." When asked about other park systems they visited, participants frequently mentioned rest rooms, splash pads, updated park equipment, and "safe and clean" sites. Lack of access to natural areas was suggested by some of the participants throughout the survey.

PARKS

Satisfaction rates for the region's parks were mixed. Excluding the "Don't know / Haven't visited" category resulted in the following positive satisfaction rates (i.e. very satisfied or satisfied) for each park:

Five parks in Eastpointe and three in Roseville had less than a 50% satisfaction rating. Participants seemed much more forgiving of a park's shortcomings if the park was in the "other community". In the open comment section at the end of the survey, several participants mentioned amenities that had been removed and not replaced (Kennedy Pool in Eastpointe, basketball courts, and some playground equipment), flooding at Rotary and other parks, and general maintenance complaints. Most participants thought Eastpointe (OV 68%, EP 70%, RV 63%) and Roseville (OV 68%, EP 80%, RV 52%) had the right number of parks. Roseville participant's relatively close rating on the latter point suggests that the addition of a park may be attractive. It should also be noted that the survey took place before the addition of the new play structures at Roxana Park; we do not know the last time a respondent visited the park, and it is likely the score would have been higher post-installation.

Frequent activities for survey participants include walking and trail activities (73% for both communities), outdoor park activities such as using playgrounds (67% RV, 58% EP), picnicking (62% EP, 43% RV), and nature activities (62% RV, 43% EP). Specific amenities requested include multi-use trails (67% EP, 65% RV), splash pad (59% EP & RV), outdoor swimming pool (58% EP & RV), and picnic areas (55% EP, 54% RV). Access to pools was the most frequently mentioned open-ended comment.

Participants were generally supportive of a separate dedicated millage for park maintenance and improvements.

TRAILS

Trail development was not enthusiastically received. Comparatively few felt that trail development was important (OV 68%, EP 70%, RV 63%), which was consistent with a later question asking if they would like to see a trail network developed in the area (OV 63%, EP 64%, RV 63%). Most residents walked at least twice weekly for recreation (OV 68%, EP 67%, RV 70%), but relatively few (OV 13%) ran and only 30% bicycled. which could be due to the existing sidewalk network. The percentages of those who walked, ran, or cycled to run errands was even lower, with 19% saying they walked, 5% saying they ran, and 10% saying they cycled. Only 8% indicated they were aware of the Iron Belle Trail network, which suggests a lack of knowledge about regional non-motorized transportation.

Around thirty five participants provided suggestions for trail routes. Many were very general in nature (e.g. “Any”), but a few suggested developing routes to connecting the regions parks or going to nearby MetroParks, the Iron Belle Trail, or adjacent cities. One specifically suggested adding bike lanes with connections to area restaurants and attractions. Another mentioned developing the “old gravel yard”, stating “figure a way to use that big old hole of water and land”.

The general feeling is that residents are interested in a trail network in the cities, but are unsure of what that might look like or where it would run. While this topic will be discussed in the plan, it will likely not be of prime importance compared to other requirements.

PROGRAMMING

Relatively few respondents took advantage of RARE programming (OV 32%, EP 24%, RV 46%). Adult programs (OV 43%, EP 44%, RV 46%), exercise & fitness (OV 42%, EP 42%, RV 43%), and swimming (OV 40%, EP 38%, RV 44%) were among the most popular programs. Roseville residents also liked family programs (46%), while Eastpointe residents mentioned concerts & shows (42%).

Program pricing did not seem to be a problem, with the majority saying prices were “about right” (OV 75%, EP 74%, RV 77%). Location may be an issue, however. One respondent stated “Eastpointe needs its own Recreational facility” while another suggested buying the old Deerfield Elementary building for use as a recreation center. RE: Summary of Comments from Senior & Recreation Fair

A booth was set up at the Senior Resources Fair and Recreation Fair held at the Recreation Center on September 20, 2019. Approximately 30 interviews stopped by the booth and agreed to give input on the state of recreation opportunities in Roseville and Eastpointe. The vast majority of the visits took place in the morning (Senior Fair) session.

GENERAL DESCRIPTION

The typical participant was older (60s and up) and female, and had lived in the area for the majority of their lives. Only about 17% of participants came from Eastpointe, and 7% from other communities. They did not visit parks very frequently either due to physical limitations or because they did not know the parks existed. Those who knew about the parks stopped going after their children/grandchildren outgrew the parks. Almost all used the Senior Center on a regular basis; while a good number came for physical fitness, the social aspect of the Center was viewed as equally as important. Almost every participant was very satisfied with the Senior Center. Fees were viewed as reasonable or even “cheap”, and there were very few suggestions for improvements. The one item that came up frequently was the lack of a pool. Five different individuals suggested building a pool at the Recreation Center; all were willing to pay for a millage to fund construction and operation of the pool.

SPECIFIC ISSUES

Safety was mentioned by several participants. Part of the appeal of the Recreation Center was the ability to be active in a “controlled environment”. One participant was concerned about the lack of a receptionist or guard at the Senior Center entrance, noting that on some weekends she was the only one in the building and “Anyone could have come in”. Lack of visibility discouraged some of the interviewees from exercising in the parks.

A lack of knowledge of the park system was common. Almost every participant said, “I had no idea we had so many parks” when they approached the booth. Two separate participants stated that they visited neighboring community parks because they knew that those parks had trails; in one instance, the participant lived within walking distance of Dooley Park but had never visited because she didn’t know it was there. This general lack of knowledge is not limited to the parks. Three different participants described how they had just “discovered” the Senior Center. Two of those three were informed of the Center by their children who had received the Recreation periodical. These comments suggest that improved communications with residents is needed.

Access for non-residents came up on two occasions. These individuals felt that the current policy and fee setup was unreasonable and that staff made outside visitors feel unwelcome. One of the visitors stated that all of her friends lived in the area and that she would be willing to pay extra to use the center, but not the current “five or six times the amount that residents pay”. Another suggested that in an adjacent community, non-residents were able to visit and pay “50-cents extra per visit”. We have not been able to verify the amounts as described, but it may be worthwhile for Senior Center staff to evaluate fees charged by surrounding communities for comparison purposes.

Arts and Crafts was the only program mentioned as lacking. Overall, participants were very happy with the program selection, and with Mary’s leadership.

INDIVIDUAL COMMENTS – MORNING SESSION

- Warren resident – comes to the center to play cards and visit with friends
- Eastpointe – Misses the pool at Kennedy Park. Likes the new playscape at Roxana Park. Calls the Senior Center (SC) “perfect” and visits daily for recreation and to visit with friends. Considers the fees reasonable. Stated that “Mary cannot retire”.
- Roseville – Area needs water features such as a splash pad or open swim for seniors at the high school. Currently has to go to Warren. Considers the fees to be “cheap”. Currently walks on the sidewalks for exercise.
- Eastpointe – Would like to see concerts held at Spindler Park.
- Roseville – Has been a member of the SC for 17 years, and visits almost daily. Loves it.
- Roseville – Likes Dooley Park especially for walking.
- Roseville – Member of the SC for 2 years. Loves it, and does yoga 6-7 days/week. Found out about the Center by a mail flyer. Would like to see a meditation class added. Thinks Mary is doing a great job. Appreciated that the SC was used as a cooling center in the summer. Thought Spindler Park was the best park in the area. Mentioned a need to improve security by the SC door.
- Warren – Likes the SC and Mary.
- Roseville – Lives by Dooley Park but walks at the SC because it is a more controlled environment.
- Roseville – Would like to see more crafts. Is concerned about SC fees because she is on a fixed income. Does not go to the parks because there are not enough bathrooms.
- Roseville – Would like a pool at the Recreation Center (RC). Likes what is currently offered and is OK with the current fees. Would like to see more painting and crafts.
- Roseville – Just discovered the SC via word of mouth. She said she “Needs this to get out of the house!”
- Eastpointe – Doesn’t understand why Fairlane is a park, as nobody knows about it and nobody uses it. She would need a reason to visit the parks, such as concerts or other events. Goes to the SC for exercise, and feels that fees are reasonable. Would like to see more trips that are *not* casino related, such as the Whitney, Purple Rose Theater, or Meadowbrook.
- Roseville – Lives by Rotary Park and says it is never used, but has no ideas for improvements to the park. States that the programs are getting better, but that it is difficult for non-residents to join. Mentions that non-St. Clair Shores residents can use their center by paying \$0.50/visit.
- Clinton Township – Works and has friends in the area and would like to join, but can’t afford \$100 fee. Thinks the area parks are clean and well maintained.

- Roseville – Walks dogs at Veterans Park. Her kids used to play at Rotary Park. She did not know about the remaining parks at all. She just joined the SC for fitness, goes to Warren for their pool and sauna.
- Roseville – Felt that Kiwanis Park was not “family friendly”. Would like to see neighbors involved in running the parks. Feels like the park needs more amenities for little kids, but claims that teens always ruin it.
- Roseville – Loves the SC, and considers it a “life saver” for retirees.
- Roseville – Says Mary is “great”, and would like to see arts and crafts programs. Considers the fees to be low. She does not visit the parks because, “I am just not an outdoor person.”
- Roseville – Frequently visits Red Oak Park and Hanover Grove with her daughter because there are woods and good smooth asphalt. There are no parks by them (northeast side of city) so they use the school properties. Visits the SC two times per week to “sit and be fit”. Mentioned that good visibility at the parks is an important consideration.
- Roseville – Likes Dooley because it has good, clean trails.
- Roseville – Would like to see a group walk or group bike program. Would never consider biking on Gratiot, even if a protected bike lane were installed, but would take the “Mile Roads” (9 Mile or 12 Mile).
- Eastpointe – Misses the pool at Kennedy and would support a millage for pool construction. Would like to see pickleball courts at Huron Park and the skate park expanded. Would like to see bike paths (multi-use paths) but would not use bike lanes. Suggested creating a circular running and biking path at one of the larger park. Would like to see bocce ball, shuffleboard, and racquetball, similar to what they have in St. Clair Shores.
- Roseville – Uses the SC regularly for dinners and trips. Feels like she “needs this for the community it provides”. Wants sledding at Huron Park and more skating options.
- Eastpointe – Needs to see improved and timely maintenance, states that it takes too long for projects to be completed especially at Memorial Park. More picnic tables and benches at the smaller parks would be helpful. Feels like Eastpointe does not benefit from the Recreation Center in the same way Roseville does.

INDIVIDUAL COMMENTS – EVENING SESSION

- Roseville – restroom at Veterans Park should be expanded as the current facilities only allow one person in at a time. Feels the computer room needs a door to block out noise.
- Roseville – Loves the variety in the parks and appreciates that Alcoholics Anonymous can use Spindler Park for meetings. Notes that Memorial Park in Eastpointe has improved and is more “fleshed out”. Feels that RC fees could be lower. Was upset about a trip that had been canceled and fees not refunded. Problems parking at the RC due to lack of spaces and potholes. Liked the Garage Sale, and suggests holding it indoors at the RC next time. Would support a millage for a pool or splash pad at the RC.
- Roseville – Likes Spindler Park. Uses the RC frequently and would like to see more crafts. Would like to see horseshoes for rent at area parks.
- Roseville – Would like more bathrooms at Huron Park down by the skate park.
- Roseville – Would like drinking fountains at the parks and more picnic shelters. Would like more “flexibility in the types of teachers” and suggests different types of martial arts, especially deep breathing exercises. Would like more variety in the sports offered, and suggests biking and walking clubs.
