- i. Motion to approve the September Regular Meeting minutes was made by Mr. Switalski, supported by Mr. Klinefelt. All approved, none opposed. Motion passed.

C. Approval of Disbursements and Budget Report

a. Request from Dave Bommarito, Roseville Historical & Genealogical Society, to hold monthly meetings at Recreation Authority Center for several months, with a waiver of fees, until their meeting location is available.

- i. A motion to approve the request to host the Historical & Genealogical Society monthly meetings and programming for 6 months, with a waiver of fees was made by Mr. Switalski, supported by Mr. Klinefelt. All approved, none opposed. Motion passed.

b. Update on status of Park Development Spark Grant Project

- i. Soil borings testing is scheduled for Friday, October 18. Bid packet was approved and advertised on Wednesday, October 16. Bid opening will be November 13, 2024 at 2:00pm.

c. Review of Goals, Action Plans, Inventory & Timeline for Joint Parks & Recreation Master Plan.

- i. Goals, action plans and inventory were sent for board review for comments or corrections. A full draft should be received by October 21st. To be on the agenda for distribution at the November meeting, following a public hearing will be scheduled. Mr. Switalski was surprised by the numbers for accessibility at parks, the availability of parks for residents in northeast Roseville, and to change the action plan to identify and acquire land for park development from medium to high to a high priority.

d. Request approval to move the Recreation Authority millage collection from a winter tax collection to a summer tax collection beginning July 1, 2025 to comply with state statute.

My staff has seen the breaker box open multiple times with the breaker being turned off for the heater of the pool. They have not touched it, but just let me know about it. Last night my one lifeguard took the temperature of the pool and it was at 67.1.

I am not sure what can be done, but we have been losing participants of the open swim program and have been giving money back because the temperature of the pool. We are working on getting the swim lessons up and running for the

spring as well, and I do not want this to be a continued problem as this temperature is not at an appropriate level for swimming.

My colleague who has worked in aquatics for over 20 years sent me this guideline from the American Red Cross:

'He touched a lot of lives'

ROSEVILLE — The memory of Connor McMahon will live on each time someone enters the Recreation Authority of Roseville and Eastpointe building located at 18185 Sycamore St.

On the late afternoon of Nov. 7 at RARE — where McMahon worked for several years — staff unveiled on the lobby wall in large letters a quote he often said, “Be greater and make a difference.” A brief ceremony was held during the unveiling, which many people attended, including city officials; RARE employees; McMahon's parents, Kathleen and Corey McMahon; and his brother, Carter. Kathleen and Corey McMahon teared up when RARE Director Tony Lipinski presented the family with a quilt that was made from their son's summer camp T-shirts that he wore over the years. The quilt also had squares that depicted his alma mater — the University of Michigan — Spider-Man and Marvel Comics.

“This has been a long time coming to get this to Kathleen, Corey and Carter,” Lipinski said. “Connor was taken from us too soon. There's not a day that we at the rec authority don't think about him. He touched a lot of lives and made a positive impact on the world. We want to keep Connor's memory alive. We feel anybody that visits the rec authority center should experience Connor and his positivity and his message to the world.”

McMahon was a scorekeeper, summer day camp instructor, building supervisor and park attendant at RARE. The 23-year-old Fraser High School teacher was killed in a hit-and-run car crash June 13, 2023, while changing a tire on the shoulder of Interstate

94 in Harper Woods.

McMahon certainly influenced the camp counselors he worked alongside. Stephanie Berlin, 28, affectionately described him as “corny” because as McKenna Ciner, 27, said, “He loved a good dad joke.”

Ciner remembered that McMahon “would do anything for the kids.” Berlin also said that she often went to McMahon when she needed help with technical equipment.

“He would figure things out somehow,” Berlin said. “He never lost his patience.”

McMahon also made movies each year of summer camp that everyone appreciated.

Brendan Shiemke shared a story about the time he and several kids in summer camp played a joke on McMahon when he was a building supervisor.

“He was in the building and one of the kids asked if we could prank call him,” Shiemke said. They didn’t get very far because “Connor figured it out right away. He thought it was hilarious.”

The wall quote would mean a lot to him.

“He would think this was the coolest thing ever,” Rachael Weldon, 26, said.

Even though the group saw each other at RARE during summer camp, they also hung out after work hours.

“We would hang out on the weekends and play board games,” Jacqui Feldman, 22, said. “He loved video games and once brought his whole video console to my house.”

Michael Lipinski, who is Tony Lipinski’s son, was roommates at U of M with McMahon for about 2 1/2 years.

“There were a lot of late-night 7-Eleven runs and we’d get Joe’s Pizza because he was a big Spider-Man fan,” Michael Lipinski said.

Pinball Pete’s was another regular hangout. According to Michael Lipinski, McMahon was a “huge sports fan,” so they spent many weekends attending U of M football games and tailgating with classmates.

In tribute to McMahon, the Connor McMahon Scholarship was established at RARE. The scholarship helps provide funding for the Summer Day Camp for families in need. This year, the fund helped seven students attend summer camp. Scholarship applications are available on the website at rare-mi.org or in person at the RARE building.

Roseville Big Bird Run - Story by Ron Marinucci

Roseville (11/10)—Early morning broke with ominous signs for the 46th annual Big Bird runs. A heavy rain was dowsing much of the Detroit area. Traffic reports on the radio indicated multiple accidents impeding travel on a major expressway leading to Roseville.

But the running gods took over, deciding to smile on Big Bird participants. Runners arriving from the south and west found the freeway had been cleared and it was smooth sailing. Although the skies remained cloudy, with a hint of mist, and the streets were wet (Runners were cautioned at the start, "Be careful at the finish. Don't just stop. The timing mats are wet and may be slippery."), there was no rain.

Race director Tony Lipinski smiled at the finish line. "I told you I'd stop the rain." His pipeline to the running gods worked again. Over the years, the Big Bird has faced its share of nasty weather, from snowstorms and heavy winds to torrential rain and bitter cold. But pretty good weather has graced runners for the last five or six or more years. (2020, the Big Bird went virtual.) This day, a couple of runners, males!, ran bare-chested.

The Big Bird includes three distances—a one mile, a 5K, and a 10K. Two years ago, the 5K replaced the long-standing 4K. All courses are flat, traversing residential streets of Roseville. They are safe and well-marshalled by law enforcement and many volunteers. The only "hills" are faced on the 10K, out-and-back across a pedestrian overpass that crosses I-696.

The Roseville High School Marching Band, relegated to the Recreation Authority gym due to the weather, was in top form, regaling runners and their families with popular tunes and the National Anthem.

A number of veteran Big Birders returned to run, some for the 20th and even 30th or more times: David Rau, Maggy Zidar, John Tarkowski, past winner Bonnie Moroni, and Joe Burns among them. (This was my 35th or 36th Big Bird.) Burns noted he was nursing a foot injury but was out here anyway. And he passed along news that the Detroit-area Medals for Mettle charity he directs now has collected more than 11,000 medals for the disabled.

But the youngsters were also running, having fun, and doing quite well.

The one mile attracted 56 runners and walkers. Nine-year old Ellie Ventimiglia was the 14-under winner among the girls. Her 8-year old brother, Leonardo, finished third among the boys. It was already his third time at the Big Bird. As usual, "I loved it," he said afterward. He's been training with his MACH team and really didn't need any help in answering, "Will you be back next year?" "I hope so!" he enthused.

Runner-up among the 14-under girls was Tessa Gadiola, followed by Rosie Swoszowski in her first race. Her mother noted Rosie has come with her in previous years, but this time announced, "I'll do it, too." She didn't train specifically for the Big Bird, but her many other activities—dance, volleyball, basketball, and soccer—kept her in shape.

Rosie was joined by her "cousins" ("Close enough," said her mother.) at the Big Bird. Among the 15-over one milers, Angela Swoszowski was runner-up, just like 2023. Madeline Ross was the female champion of the 5K. She's 11-years old! Her 21:34 placed her eighth overall. "I just signed up yesterday," she admitted with enthusiasm, walking off proudly with the turkey ("Big Bird") and handsome cooler she won. The middle school cross country runner noted with a big smile, "I enjoyed it, until the end." Ashley Olive also runs middle school cross country, at Troy's Larson MS. "I signed up yesterday, too." In her first Big Bird 5K, she won her 12-under age-group. Like her "cousins," she found the race "fun. It was good." and promised, "I'll be back."

In 2023 Jake Felarco topped the 14-under milers and returned this year to repeat. It was a family affair as both mom, Kathleen, and dad, Frank, notched third places in their age-groups, although finishing behind Jake (3rd overall).

Tyler Brege notched a three-peat, winning the mile (5:48) for the third consecutive year.

In the 5K, Dan Garza topped at all runners (115) in 16:06. Last year, Garza was the 10K winner. Second overall was masters runner Ron Boudia. Leah Williams was the first masters woman.

10K runners (69) were paced by Nathan Schilling (39:58), with masters Jeff Roggenbeck just fifteen seconds back. Among the women, Sarah Jelinek was good for the win (and 7th overall) while 62-year old Donna Haist was the first masters.

Earlier in the week, Lipinski thought "registration is up a little bit." Although the foreboding weather likely kept numbers down somewhat,

he was pretty much right on for the final totals.

He also provided a nice surprise. Along with the always quality awards and raffled turkeys, runners' long-sleeved tee shirts were in Detroit Lions' colors! Thinking of how to show support for the so-far magical football season, he said, "We tossed around the idea" of Honolulu blue and silver "and finally said, 'Why not?'" (I think Karen has found a new shirt to wear!)

With its 46th running, the Big Bird continued to demonstrate it's a wonderful community and family event. Runners would do well to mark it on their 2025 race calendars.
