Eastpointe celebrates First Amendment

Event was mandated by lawsuit settlement



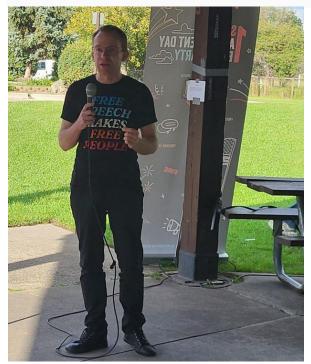

A celebration of the First Amendment at Eastpointe's Spindler Park Sept. 6 was a first for the city, but is set to be a mainstay going forward.

The event was hosted by the Foundation for Individual Rights and Expression (FIRE), whose attorneys represented four Eastpointe citizens in a federal lawsuit against the city and former mayor Monique Owens alleging their First Amendment rights were violated when she stopped them from speaking during a council meeting.

As part of the settlement reached earlier this year, Sept. 6 was designated as an annual First Amendment Day in Eastpointe as that was the date Owens shouted down Cindy Federle, Mary Hall-Rayford, Karen Beltz and Karen Mouradjian when they tried to criticize her during the public comment portion of the City Council meeting.

"It takes a lot of guts to sign yourself up for a federal lawsuit, much less a federal lawsuit that is going to be in the news constantly," said FIRE attorney Conor Fitzpatrick. "These four women were not only brave enough to stand up at a city council meeting to speak their mind, but stand up for their and all of our Constitutional rights to free speech."

Federle said she learned a tremendous amount about public meetings and a citizen's right to speak, even if they are criticizing elected officials. She hopes a day recognizing the First Amendment will be an opportunity for others to learn and that more people will come and express their views during public meetings.

"I didn't know that when Mayor Owens stopped me from saying what I wanted

to say that it was a violation of the First Amendment," said Federle. "In the agenda, it states we were not allowed to address one person on the City Council so I had no idea that was a violation until I got involved in this lawsuit."

Federle said she is disappointed the city was not more involved in the planning of the first-ever First Amendment Day.

"I think the city needs to step up and recognize our First Amendment rights and support that," Federle said. "I think our city attorney and council persons who go to classes about this should have known better and should have done something about it immediately and not said this was not a real case when we filed it.

"They did take that sentence out of the agenda but they never stepped up and said they were wrong."

Hall-Rayford said it is important that people know they can go to a public meeting and criticize public officials.

"People need to know they have a right to attend a public meeting with public officials and during the public hearing, they can say what they need to say,"

said Hall-Rayford. "If you enter into the political field, you put yourself in a position to be criticized."

Hall-Rayford went on to say that she personally does not believe profanity or name calling is in order when criticizing and urged people to disagree agreeably.

For Mouradjian it is about being heard and respected.

"You just do not intrude on anyone's first amendment right, especially not in a public comment section," said Mouradjian. "We have the right to address the government about our grievances without fear of retaliation.".

Fitzpatrick urged attendees at Friday's event to treasure their First Amendment rights and recognize that freedom of speech is not something afforded to people around the globe.

"Freedom of speech is what we at FIRE eat, live and breathe every day, but even in our jobs it is easy to take freedom of speech for granted," Fitzpatrick said. "If there is one message I would like to leave with all of you it is how good we have it in the United States and how fortunate we are to have freedom of speech."
