Dog Park Rule Sheet

- No pets other than dogs are permitted in the park.
- Dogs must be leashed when entering and exiting the park and you must have the leash on you at all times. SPIKED COLLARS ARE NOT PERMITTED WHILE IN THE DOG PARK.
- Do not let people or dogs in by holding the gate open, each member must use their own key FOB for entering and exiting the park. This protects all members and the park.
- Do not allow unregistered participants in to the dog park.
- No children under 5 are permitted in the dog park. Children ages 5 to 17 must be accompanied by an adult. Strollers, bikes, skates, skateboards, scooters, running, shouting or chasing dogs is not permitted.
- Only pet another dog with the owner's permission to do so.
- No food (including dog treats), alcoholic beverage, glass bottles or smoking of any kind is allowed in the dog park.
- Participants must immediately clean up after their dog(s) and properly dispose of waste.
- No more than 2 dogs per person is permitted within the dog park during a visit.
- Dogs under 5 months of age are prohibited.
- Dogs must be free of any diseases and parasites such as fleas and ticks. Sick dogs and dogs in heat are not allowed.
- Dogs must be in view of and within voice control of their owner/handler at all times.
- Excessive barking is prohibited. Dogs barking excessively must be removed.
- No aggressive dogs or people are allowed. Dogs with a known history of, or who exhibit aggressive or dangerous behavior, are prohibited. Immediately leash your dog and leave the park if aggressive behavior is observed.
- Off-leash dog parks are generally self-supervised. Members of the park are required to follow the rules and encourage others to do the same. If there is a problem beyond the capacities of the members to manage the Eastpointe Police should be called at (586) 445-5100. For emergencies, call 911. An incident report should also be filed with the Recreation Authority Center located at 18185 Sycamore, Roseville, MI 48066.
- You are entering this area at your own risk. The Recreation Authority and the City of Eastpointe is not responsible or liable for injuries to dogs, their handlers or others who enter the park. Owners/handlers are responsible and liable for the actions of their dog(s) at all times.
