Motion by Councilmember Workman, seconded by Councilmember Norton, that the **Cooperative Bid** Award Purchase for one (1) **Replacement Backhoe**, Caterpillar 2022 Model 420XE Backhoe Loader for the **Sourcewell** Contract Price of **\$132,409.97**; and Authorization to Accept the Trade-in cost of a Used Backhoe in the amount of **\$22,000.00** for a total net purchase price of **\$110,409.97**, be Approved. Carried unanimously.

Motion by Councilmember Workman, seconded by Councilmember Gunaga, that an **Extension** of the **2021 Street Sectioning Program Contract Agreement** with **Dominic Gaglio Construction, Inc.**, for the 2022 Street Sectioning Program in the amount of \$200,000.00, plus 10% contingency in the amount of \$20,000.00 for a total of **\$220,000.00**; and further, Authorization of Engineering Fees for **Charles E. Raines** Company to Perform Field Evaluation, Marking, Contract Administration, Inspection, Testing and As-Builts in an Amount Not to Exceed **\$30,000.00**. Carried unanimously.

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF RIVERVIEW TO AMEND SECTION 66-3 “TRAFFIC CONTROL ORDERS” TO RATIFY AND APPROVE TRAFFIC CONTROL ORDER NUMBER 424; AND TO ADD SECTION 66-36 “APPLICATION TO RIVERVIEW LAND PRESERVE” TO ARTICLE II “ENFORCEMENT OF TRAFFIC ORDINANCES ON PRIVATE PROPERTY” OF CHAPTER 66 “TRAFFIC AND VEHICLES.”
