RESOLUTION NO. 20-10
RESOLUTION APPROVING THE WATER/SEWER
UTILITY BILL PENALTIES AND INTEREST

WHEREAS, due to a combination of factors relating to the current COVID-19 virus pandemic including, but not limited to, some individuals having job uncertainty, some individuals needing extra time to pay their water/sewer utility bill either due to prioritizing of bills or general uncertainty, and the City administration having to adapt to requirements for remote/reduced staffing and limitations of in-person contact, City Council is exploring ways to assist its residents;

WHEREAS, while the timely payment of utility bills is very important to the City's utility fund cashflow, City Council has listened to concerns raised by residents regarding the current struggle to meet the payment deadline and has decided to provide residents with some relief regarding the timing of utility bill payment as set forth in this Resolution.

NOW, THEREFORE, BE IT RESOLVED that in response to the concerns raised regarding the timely payment of recent water/sewer bills, and the additional burden that interest and penalties would cause during this time, City Council hereby takes the following actions for residential customers:

1. For water/sewer bills that will be due April 6, 2020, City Administration shall not assess penalties and interest if said bills are paid in full by April 30, 2020.
2. For any bills that are not paid by the new date in paragraph 1, then City Administration will assess normal penalties and interest, but using the new dates as the due date for interest and penalty purposes.
3. With the exception of bills referenced in paragraphs 1, all future bills must be paid in a timely fashion to avoid penalties and interest.
4. The temporary waiver of penalties and interest does not apply to any utility bill that was already past due with penalties and interest currently accruing.
5. The transfer to taxes of all outstanding utility balances scheduled for April 15, 2020, shall be delayed until May 15, 2020.
