9. CONSENT AGENDA.**9.1 AWARD COOPERATIVE BID PURCHASE FOR ONE (1) 2023 FORD ESCAPE FROM GORNO FORD FOR A TOTAL COST OF \$33,100.00 — POLICE.**

COMMUNITY IMPACT/BACKGROUND: The City of Riverview Purchasing Manual, Section 10.2 A, authorizes the City's participation in cooperative purchases to take advantage of volume buying. The State of Michigan through its MiDeal program, formerly known as Extended Purchasing, has awarded a contract for police vehicles to Gorno Ford of Woodhaven, Michigan. The Vehicle and Equipment Officer is requesting the purchase of one (1) 2023 Ford AWD ESCAPE, for a total price of \$33,100.00.

The Riverview Police Department has adopted a personalized platform for vehicle retirement/replacement that is managed by an active City Lieutenant, since there were no predetermined national or state criteria regarding this due to differences amongst departments and too many influences and variables to be considered. This platform allows for current police vehicles to be evaluated and rated as to when future replacement will be required, thus allowing for the ability to "spread out" vehicle acquisitions to approximately one or two per year.

The vehicle recommended to be replaced is #14-0, a 2015 Ford Escape with approximately 94,000 miles which is not yet recommended for decommissioning, but to be utilized on a limited basis for officers when commuting to schools/training. The replacement of the patrol car is consistent with the City's fleet rotation and replacement schedule.

ACTION REQUESTED: The City Council is requested to consider the cooperative bid award for one (1) 2023 Ford Escape from Gorno Ford, for a total cost of \$33,100.00.
