Many projects were completed under their terms, impactful decisions to help lower unemployment, and numerous other acts of service. Thank you, Commissioner Lovelace and Commissioner Hunt. Your expertise and contributions have made Rutherford County the thriving community it is today.



Commissioners/Appointments

- **Certificate of Achievement in Financial Reporting** - Chairman King recognized Finance Director Paula Roach and Finance staff (pictured below). The County received notification that the County's CAFR (Comprehensive Annual Financial Report) for the fiscal year ending June 30, 2023 qualified for the Certificate of Achievement for Excellence in Financial Reporting from the Government Finance Officers Association. This is the County's thirty-fifth consecutive year to achieve this award.



- **Appointment to Isothermal Community College Board of Trustees** - Commissioner Michael Benfield was appointed to replace Ms. Amanda Shevette who has resigned.
- **Appointment to Juvenile Crime Prevention Council** - Appointed Mr. Eric Holland.

Forest City, NC - Earlier today, Governor Roy Cooper and North Carolina Commerce Secretary Machelle Baker Sanders announced the successful recruitment of Abstract Ice, a specialty craft ice manufacturer, which will locate its newest facility in Rutherford County at 212 NuWay Packing Rd, Forest City, NC. Company plans include the creation of 26 new fulltime jobs and an investment of approximately \$12,500,000 within the first three years.

"The Town of Forest City and the Board of Commissioners are thrilled to have Abstract Ice coming to our town" said Forest City Mayor, Steve Holland. "We look forward to working with them on this project. Abstract Ice will be a great addition to our county" he added.

Rutherford County has been awarded a \$75,000 grant from the One North Carolina Fund for this project. The grant is contingent upon proof of job creation and receipt of a local funding match. Rutherford County will partner with the Town of Forest City to provide the required local match for the One North Carolina Fund grant in support of this project.

"Your investment not only brings valuable job opportunities for our citizens but also strengthens our local economy, our community, and our future. GRANT AWARD FROM GATEWAY WELLNESS FOUNDATION

We have been awarded a \$20,000 grant from the Gateway Wellness Foundation to support our Home Delivered Meals Program. This funding will provide crucial assistance in continuing our efforts to serve nutritious meals to seniors in need.

TAR HEEL LEGISLATOR, CLARK POOLE

North Carolina legislators recently heard key concerns from the Senior Tar Heel Legislature, including home-safety and ensuring seniors can remain in their homes. Local representative, Clark Poole, (pictured right) addressed these issues at the Rutherford County Senior Center, emphasizing the need for increased funding to support in-home care, assisted living, and CNA positions.

Poole highlighted the importance of seniors advocating for their needs, especially considering challenges like choosing between food and medicine or dealing with the aftermath of hurricanes. He praised seniors' resilience, noting their leadership in disaster response, such as organizing community aid within days of recent storms.



MEDICARE OPEN ENROLLMENT

Medicare's annual Open Enrollment period, which began on October 15, is set to conclude on December 7. As of today, November 25, there are only seven business days remaining to review and adjust your Medicare coverage for the upcoming year.

While the state has extended the enrollment deadline for beneficiaries affected by Hurricane Helene, this Special Enrollment Period (SEP) applies specifically to residents in the 25 North Carolina counties declared disaster areas, including Rutherford County.

However, it's important to note that our local counselors have prior commitments beyond December 7. If you delay your enrollment changes until after this date, you will need to seek assistance from representatives in Raleigh.

To ensure you receive personalized guidance and avoid potential delays, we strongly encourage you to contact our local counselors before December 7. They can help you navigate your options and make informed decisions about your Medicare coverage for 2025.

ACTIVE PARTICIPANTS


We had a total of 683 active participants during the month of October.

Rutherford County Transit: Evacuating Over 100 Residents During Hurricane Helene

During Hurricane Helene, Rutherford County Transit played a critical role in protecting residents as catastrophic flooding and power outages devastated the community. On September 27, with power and cell service down, Emergency Management Director Frankie Hamrick called on Transit for immediate assistance. Unable to contact her drivers due to power outages, Transit Director Kerry Giles authorized Emergency Management to directly access Transit vehicles to evacuate residents from high-risk areas. EMS retrieved three vehicles, which were crucial in the initial evacuation of Chimney Rock Village as warnings of an imminent Lake Lure Dam failure escalated the need for action.

Later that morning, Giles was called to the Emergency Operations Center (EOC) to serve as Public Information Officer (PIO). While media inquiries and reports of missing persons poured in, Giles managed public communications, ensuring accurate, timely updates and providing reassurance to families searching for loved ones.

As conditions began to stabilize on September 28, Kerry Giles, her husband Bill Giles, Transit Operations Manager Jeff Hill, and County Commissioner Michael Benfield joined the evacuation efforts. Using Transit vehicles, they navigated dangerous and partially cleared roads into Lake Lure, working alongside NC DOT crews and emergency personnel to safely evacuate over 100 residents from Chimney Rock Village and the Lake Lure area.

That evening, Operations Manager Jeff Hill took on a critical solo mission in Chimney Rock Village. Despite power outages and challenging terrain, Hill crossed a still-intact bridge into the darkened village after evacuees were not at the designated meeting point. Deep in the village, Hill located four adults, six dogs, three newborn puppies, and two cats stranded without transportation after losing their car keys and leashes to floodwaters. Acting quickly, Hill loaded the group into a Transit vehicle and in complete darkness, navigated curvy, debris-filled roads, washed-out sections, and downed power lines to bring them to safety at an emergency shelter.

In the days that followed, as cell service was partially restored, numerous Transit drivers returned to duty. Many left behind their own damaged homes or worked without power to join the ongoing evacuation efforts. They transported additional evacuees, navigated treacherous roads, and provided an essential lifeline to residents with no other means of escape.

Rutherford County Transit's actions during Hurricane Helene showcased the extraordinary dedication and resilience of its staff. From rescuing stranded residents and their pets to ensuring vital communications and safe evacuations, Transit personnel prioritized the community's needs above their own challenges. Their adaptability and determination underline the indispensable role public transportation plays in disaster response, saving lives and building resilience when it matters most.

Staff Updates

As Transit resumed normal operations following Hurricane Helene, Transit Director Kerry Giles took the timely opportunity to travel to Washington, D.C., with the NCPTA Legislative Delegation. While there, she advocated for increased funding for rural public transportation and sought Hurricane Helene relief funds to support ongoing recovery efforts (pictured right and following page).





Transit also welcomed three new part-time drivers to the team: Jeannette Meyers, Rhonda Rhyne, and Terry Lindsay, who are now completing orientation and preparing to contribute to our mission. At this quarter's Transit Advisory Board meeting, members reviewed Transit's disaster response to Hurricane Helene and discussed the continued advocacy for rural transportation funding at both state and federal levels. The discussion emphasized the vital role transit agencies play in emergencies and disasters, highlighting the importance of investment in public transportation.

Finally, we are deeply grateful for our dedicated staff, whose hard work and commitment shine both in daily operations and during crises. On Friday, November 22, Transit held its annual Thanksgiving lunch, providing an opportunity to celebrate the team's efforts and express gratitude for their unwavering dedication to serving the community.



"Rural transportation serves as a lifeline for communities, especially during crises, as demonstrated by Hurricane Helene. On the morning of the storm, Rutherford County Transit was deployed to assist in evacuation efforts, transporting individuals airlifted from the mountain to safety. Throughout the entire response and recovery period, we continued to provide essential support by evacuating residents, transporting them to food and supply sites, ensuring shelter access, supplying vehicles for National Guard operations, and delivering meals to seniors.

North Carolina's rural transit systems are deeply integrated into local emergency operations plans, ready to respond swiftly when disaster strikes. However, maintaining these critical services comes at a substantial cost. Federal operating funds, such as those from the CARES Act, would be invaluable in offsetting recent expenses and revenue losses, helping to ensure Western North Carolina remains prepared for future emergencies."

ROC partnered up with [Broad Riverkeeper](#) to take multiple rounds of Broad River water samples in the aftermath of Helene, and there is encouraging news on the road to recovery. Results at all sites show bacteria levels have returned to safe conditions. This is huge progress after bacteria levels spiked following the failure of the Lake Lure sewage plant during the floods. The water's height has begun to drop as well, another positive sign of recovery for our river.

While this is all encouraging news, **please continue to use caution and stay out of the river until further notice.** The water remains turbid and there are likely many debris and hazards that are yet to be seen. Check out the full panel of results on the right, with many thanks to Broad Riverkeeper for the data. Stay safe and stay tuned for updates on the river's recovery!
