PRESENT:

Members: Chair Carl McGookey, Judy Corso, Mark Harrington, Joe Hayberger, Bill Semans, David Miller, Mike Zuilhof and Secretary Kevin Zeiher were present.

Also present were Steve Poggiali, Tim Schwanger and Angie Byington, Director of Neighborhood Development and Planning and City Engineer Aaron Klein.

The meeting was called to order at 7:32 A.M. by Chair Carl McGookey.

**MINUTES OF THE
PREVIOUS MEETING:**

Upon Motion by Mark Harrington, seconded by David Miller the minutes for the meeting of May 2, 2019 were approved as submitted.

STAFF UPDATE:

Mr. Klein reported that the west end of Shoreline Drive was under construction and on schedule. The Permit to Install will be issued by EPA to permit the installation of the sewer. The final version of the underground utilities for Jackson Street Pier should be available next week. David Miller inquired about the limited parking and if

there had been any complaints and Angela Byington had not received any, due to the effort to make people aware of the work to be done. Mr. Kline reported that the City was still reviewing plans from Customs and Border Patrol for the structures to be built on Jackson Street pier. Ms. Byington reported that the consultant would be holding a meeting at the new City Building on June 26, at 4:30 PM.

In spite of the paving work being done adjacent to the Chesapeake, the residents are happy. Plans for the Sandusky Bay Pathway will be presented to the City Commission in July outlining the scope of work.

Mr. Klein also reported that the new court building at the old American Crayon building will not be completed for 3-4 years. Ms. Byington stated that the only department to remain in the existing City Building will be Recreation. Invitations to the Open House for the new City Building were sent on June 5.

OLD BUSINESS:

Mr. Miller thanked the City for its assistance and the provision of wood chips during the Great Lakes Cleanup program at the canoe and kayak site at Kiwanis Park. Mr. Harrington inquired about any progress at the Keller Building and there was nothing new, according to Ms. Byington. The fence had been removed and the green spaced improved

NEW BUSINESS:

Mr. Zuilhof inquired if the Committee would be interested in promoting historic US Routes, namely, Route 6 and Route 250. The members were interested and Secretary Zeiher offered to send a letter of inquiry to Erie County, and Lake Erie Shores and Islands.

COMMUNITY INPUT:

Mr. Schwanger inquired about the contract that the City was promoting with the Canadian Ferry company, hoping it was for more than one year. Ms. Byington reported that Matt Lasko was negotiating the terms of the contract with his Canadian counterparts, including the investment in new structures.

ADJOURNMENT:

There being no further business to come before the Bayfront Corridor Committee, the meeting was adjourned at 7:59 AM upon motion by Mr. Harrington, joined by Mr. Miller.

The next meeting of the Bayfront Corridor Committee is scheduled for **JULY 4, 2019 at 7:30 AM** in the City Commission Chambers. Due to the holiday it will be rescheduled.
