That the Bayfront Corridor Committee shall consist of the City Manager or designee, an employee of the Department of Community Development appointed by the City Manager, and fifteen (15) additional members of the community nominated by the City Manager and appointed by and serve at the pleasure of the City Commission. For the years, 2017, 2018, and 2019 there shall be no more than fifteen (15) members of the community. The terms for the community members shall be of such a length and so arranged that the initial terms of five (5) members will expire on December 31, 2017, the initial terms of five (5) members will expire on December 31, 2018, and the initial terms of five (5) members will expire on December 31, 2019. Starting in January 2020 there shall be no more than ten (10) community members of the Bayfront Corridor Committee who shall be nominated by the City Manager and appointed by and serve at the pleasure of the City Commission for a term of three (3) years. This reduction will be accomplished by reappointment or appointment of only three (3) community members after the expiration of the initial terms expiring on December 31, 2017, reappointment or appointment of only three (3) community members after the expiration of the initial terms expiring on December 31, 2018, and reappointment or appointment of only four (4) community members after the expiration of the initial terms expiring on December 31, 2019.
