Chief Jared Oliver mentioned, the candidate is not in the top ten currently, but he is someone we could put through the academy training.

They have hired two local candidates that were sworn in at the commission meeting Monday, both from Perkins Township. "It is very exciting that we can that we have some hires locally", says Chief Orzech.


Mr. May asked about how their promotion was going and Chief John Orzech stated, "it's in the process of it's been posted and they will have that process done probably around May."
