Exterior Surface Maintenance 1341.13(a)(4) All exterior surfaces of buildings on a premises shall be clean and maintained in good repair so as to provide sufficient covering and protection of the structural surface underneath against deterioration, with paint, stucco, aluminum, vinyl siding or

other approved exterior grade waterproofing materials, applied in a an approved manner, and of a uniform color and appearance to match or complement the other structural surfaces on the premises.

Without limiting the generality of this section, an exterior surface of a building shall be deemed to be out of repair if the surface is blistered, cracked, flaked, scaled or chalked away, or is loose or has fallen.






