<u>Item for Consideration:</u> Application to rezone several parcels fronting Rockwell Street, Hayes Avenue, and Pierce Street owned by Firelands Regional Medical Center from both "R1-40" Single Family Residential to "RRB"/ Residential Business District to "PF" Public Facility.

<u>Purpose:</u> The Bicentennial Vison/ Comprehensive Plan outlines the city- wide development for the next ten years. In general, zoning amendments should align with the proposed land uses stated in a Comprehensive Plan. Therefore, the Comprehensive Plan is utilized by staff as one factor when evaluating proposed amendments.

**Background Information:** John Hancock, on behalf of Firelands Hospital, is requesting a zoning amendment for the above referenced parcels. The parcels are currently zoned "R1-40" Single Family Residential and "RRB" Residential Business, the applicant is proposing to rezone the property to "PF" Public Facility. The parcels are adjacent to the south campus facility. The VA facility is proposed to locate within the south campus facility within the near future. This use will occupy more than 12,000 square feet. The application is proposing to rezone the property for the purpose of additional parking for the facility. At the October 25<sup>th</sup> Planning Commission meeting, the Commission made a favorable recommendation for the rezoning of the above referenced parcels and approved a site plan that proposes an additional 147 parking spaces within the project area. Firelands Regional Medical Center has continued to place a great deal of effort into making Hayes Avenue a health corridor for the city by continuing to purchase property for development and invest in their existing facilities.

The applicant did work with planning staff to make some alterations to the initial site plan, these changes produced additional landscaping and fencing for the last remaining residential structure within the area. The applicant did indicate that the property owner was aware of the proposed parking plan, in addition the adjacent property owner also received notice of the public hearing at both Planning Commission and City Commission.

The Bicentennial Vision and Comprehensive plan calls for the expansion of "Eds and Meds" uses along the Hayes Avenue corridor, staff believes that the rezoning will assist the property owner in expanding their uses. Planning staff recognizes that there are surrounding parking facilities along south campus, however the VA is requesting additional parking that will service their uses as well as other uses within south campus.

### **Correlation to the Comprehensive Plan:**

As stated, the current City Comprehensive Plan references developing the Hayes Avenue area as the Med-Tech/Education district. The Bicentennial Vision plan also speaks to reclaiming and repurposing blighted sites for industrial or commercial redevelopment. The plan encourages building on our regional assets, the applicant has expanded uses within their existing site to include the veteran's facility and this proposed parking area will service this use.

### **Budgetary Impact:**

There is no impact to the general fund.

<u>Action Requested:</u> It is requested that City Commission approve the proposed amendments to the zoning map for the following parcels: 57-05208.000, 57-02426.000, 57-62129.000. 57-01072.000, 57-63087.000, 57-03452.000, 57-03923.000, 57-61532.000. # City of Sandusky, Ohio Planning Commission Report

### BACKGROUND INFORMATION

Firelands Regional Medical Center, has submitted an application for an amendment to the zoning map. The applicant has requested to rezone the parcels from both "R1-40" Single Family Residential and "RRB" Residential Business to "PF" Public Facility. The parcels are fronting Rockwell Street, Hayes Avenue, and Pierce Street. The following information is relevant to this application:

Applicant: Firelands Regional Medical Center

1111 Hayes Avenue Sandusky, Ohio 44870

Site Location: Rockwell Street, Hayes Avenue, Pierce Street

Zoning: "R1-40"/ Single Family Residential and "RRB" Residential Business

Existing Uses: Vacant Land

Proposed Zoning: "PF" Public Facility/ Parking for Veterans Facility

Applicable Plans & Regulations: City of Sandusky Comprehensive Plan



### SITE DESCRIPTION

The subject properties are located along Rockwell Street, Hayes Avenue, and Pierce Street. The surrounding zoning districts include RRB (Residential Business), and R1- 40 (Residential Single Family).

Zone Map - Parcels outlined in red







#### DIVISION OF PLANNING COMMENTS

Firelands Regional Medical Center has applied for a zoning map amendment for several parcels adjacent to the south campus facility. The VA facility is proposed to locate within the south campus facility in the near future. This use will occupy approximately 12,000 square feet. The applicant is proposing to rezone the property for the purpose of additional parking for the facility. The proposed site plan proposes 147 parking spaces, Section 1149.05 requires one space for every 200 square feet, which would require 60 spaces. Firelands Regional Medical Center has continued to place a great deal of effort into making Hayes Avenue a health corridor for the city by continuing to purchase property for development and invest in their existing facilities.

The Bicentennial Vision/ Comprehensive Plan outlines a city-wide development plan for the next ten years. Following the approval of this plan, it is the responsibility of Planning Staff to review the areas of the city that will need to be rezoned to carry out the vision of this plan. The plan references institutional expansion within this area.

Staff has expressed to the applicant some concern regarding the remaining residential structure within the area, the property owner has indicated that the property owner is aware of the current parking plan and they would be willing to create some sort of scheme for buffering with either landscaping for fencing for this property and the other surrounding properties adjacent to the proposed parking area.

The proposed zoning amendment does address a few priorities in the Bicentennial Vision as well. **Vibrant City:** 

- Reclaim and repurpose blighted land/sites for industrial redevelopment/commercial redevelopment. The applicant has over time purchased these properties and demolished the structures on these parcels to repurpose for redevelopment.
- Identify and build on regional assets. The comprehensive plan specifically discusses creating an "Ed and Meds Corridor by building on the presence of Firelands Regional Medicals center. The applicant has expanded the uses located within their facilities by including the veteran's facility and this parking within the adjacent area.

Chapter 1113 Amendments, of the Zoning Code, states that the Zoning Map may be amended periodically in order to keep it abreast of new zoning techniques, as well as when the following general conditions arise:

- (1) Whenever a general hardship prevails throughout a given district;
- (2) Whenever a change occurs in land use, transportation, or other sociological trends, either within or surrounding the community; and
- (3) Whenever extensive developments are proposed that do not comply but would be in the public interest.

Understanding the trends within this area are both medical and educational uses along the Hayes Avenue corridor, staff believes that rezoning these parcels to support these uses would be helpful. Planning staff also believes it will be in the public's interest to utilize this area to service an established institution within the community.

The applicant is aware that site plan approval will be required for the proposed parking within the area.

### **ENGINEERING STAFF COMMENTS**

The City Engineer has reviewed the proposed zoning amendment and has provided the following comments, please note that these are more specific to the site plan.

- Is there a curb ramp on the south side of Pierce Street?
- What will be in the west and north green space?
- Where will the storm water volume storage be and where will it discharge?
- Where will the lighting be?
- The spaces should be closest to the crossing, can these be moved?
- Spaces do not work on the SW corner?
- Will need a final SWPP
- Need a final sewer/ utility plan prior to approval

### **BUILDING STAFF COMMENTS**

The City Building Official has reviewed the proposed zone map amendment and has indicated that the applicant would need electric permits for any proposed lighting.

### POLICE DEPARTMENT COMMENTS

The City Police Chief has reviewed the proposed zone map amendment and has no objections.

### FIRE DEPARTMENT COMMENTS

The City Fire Chief has not provided comments on the application.

### CONCLUSION/RECOMMENDATION

In conclusion, the Bicentennial Vision and Comprehensive Plan calls for the expansion of the "Eds & Meds" uses along the Hayes Avenue corridor, staff believes that this rezoning will assist the property owner in expanding these uses. Planning Staff recognizes that the existing south campus has a number of surrounding parking facilities, however the VA facility is requesting additional parking that will service their use as well as other uses within south campus. Staff recommends approval of the rezoning with the condition that the property owner must seek site plan approval for the proposed parking area.

AN ORDINANCE AMENDING THE OFFICIAL ZONE MAP OF THE CITY OF SANDUSKY TO REZONE SEVEN (7) PARCELS FROM "R1-40" (SINGLE-FAMILY RESIDENTIAL DISTRICT) AND ONE (1) PARCEL FROM "RRB" (RESIDENTIAL BUSINESS DISTRICT) TO "PF" (PUBLIC FACILITY DISTRICT); AND DECLARING THAT THIS ORDINANCE SHALL TAKE EFFECT UNDER SUSPENSION OF THE RULES AS CONTAINED IN AND IN ACCORDANCE WITH SECTION 13 OF THE CITY CHARTER.

WHEREAS, a request is being made on behalf of Firelands Regional Medical Center for an amendment to the Zone Map No. 96-01 as codified in Section 1121.03 of the Codified Ordinances of the City for seven (7) parcels fronting Rockwell Street, Hayes Avenue, and Pierce Street (Parcel Nos. 57-05208.000, 57-02426.000, 57-01072.000, 57-63087.000, 57-03452.000, 57-03923.000, and 57-61532.000) from "R140" (Single-Family Residential District) and one (1) parcel located at the corner of Hayes Avenue and Rockwell Street (Parcel No. 57-62129.000) from "RRB" (Residential Business District) to "PF" (Public Facility District) and as more fully described herein and in Exhibit "A" which is attached to this Ordinance and specifically incorporated as if fully rewritten herein; and

**WHEREAS**, the change in zoning being requested for the eight (8) parcels is for the purpose of additional parking for the Veterans Affairs facility which is proposed to locate to the south campus of Firelands Regional Medical Center within the near future; and

**WHEREAS**, this request was heard by the Planning Commission at their October 25, 2017, meeting resulting in the Planning Commission's recommendation to **approve** the requested Zone Map Amendment; and

**WHEREAS**, a public hearing on the applicant's request was held by this City Commission at their December 22, 2017, regularly scheduled meeting; and

WHEREAS, this Ordinance should be passed under suspension of the rules in accordance with Section 13 of the City Charter approving the Amendment to the Zone Map 96-01 as Codified in Section 1121.03 of the Codified Ordinances for seven (7) parcels fronting Rockwell Street, Hayes Avenue, and Pierce Street (Parcel Nos. 57-05208.000, 57-02426.000, 57-01072.000, 57-63087.000, 57-03452.000, 57-03923.000, and 57-61532.000) from "R140" (Single-Family Residential District) and one (1) parcel located at the corner of Hayes Avenue and Rockwell Street (Parcel No. 57-62129.000) from "RRB" (Residential Business District) to "PF" (Public Facility District); and

**WHEREAS**, in that it is deemed necessary in order to provide for the immediate preservation of the public peace, property, health, and safety of the City of Sandusky, Ohio, and its citizens, and to provide for the efficient daily operation of Municipal Departments of the City of Sandusky, Ohio and, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SANDUSKY, OHIO, THAT:

Section 1. This City Commission approves the requested rezoning and the Zone Map 96-01, as codified in Section 1121.03 of the Codified Ordinances of the City is hereby amended to effect the rezoning of seven (7) parcels fronting Rockwell Street, Hayes Avenue, and Pierce Street (Parcel Nos. 57-05208.000, 57-02426.000, 57-01072.000, 57-63087.000, 57-03452.000, 57-03923.000, and 57-61532.000) from "R140" (Single-Family Residential District) and one (1) parcel located at the corner of Hayes Avenue and Rockwell Street (Parcel No. 57-62129.000) from "RRB" (Residential Business District) to "PF" (Public Facility District), as more fully described as follows:

Situated in the State of Ohio, County of Erie, City of Sandusky, Ward 2, and part of Rockwell, Curtis and Whitworth Subdivision, Plat Volume 51, Page 32, and being all of Lots 57, 59, 61, 63, 65, 67, 69, 71, 2, 4, 6, 106, 108, and part of Lots 110 and 112, last described in RN#200221674, RN#200907312, RN#201306955 and RN#201402283, and being more particularly described as follows:

Commencing, for reference, at an 1" iron pin found in a monument box at the intersection of Hayes Avenue (66' in width) and Pierce Street (66' in width); Thence along the centerline of Hayes Avenue, N 19°43'19" E, 34.72 feet to a point; thence leaving said centerline of Hayes Avenue S 88°22'04" E, 34.72 feet to a 5/8" iron rod set at the southwest corner of Lot 112, Rockwell, Curtis and Whitworth Subdivision, the same being on the north right of way line of Pierce Street and the east right of way line of Hayes Avenue, and the TRUE POINT OF BEGINNING for this description;

Thence, with the easterly right of way line of Hayes Avenue, N 19°43′19″ E, 213.03 feet to a 5/8″ iron rod set in the south right of way line of Rockwell Street and the northwest corner of Lot 106;

Thence, with the south right of way line of said Rockwell Street, S 88°18′12″ E, 224.72 feet to a 1″ iron pipe found on the northeast corner of Lot 6;

Thence, with the west line of Lot 8, S 2°11′38″ E, 98.72 feet to a 5/8″ iron rod set on the southeast corner of Lot 6;

Thence with the south line of Lots 8, 10, 12, 14 and 16, S 88°18′58" E, 199.87 feet to a 5/8" iron rod set on the southeast corner of Lot 16;

Thence with the west line of Lot 55, S 2°11′38″ E, 103.74 feet to a 1″ iron pipe found on the north right of way line of Pierce Street, the same being the southeast corner of Lot 57.

Thence along the north line of said Pierce Street, N 88°22′28″ W, 359.47 feet to a 5/8″ iron rod set on the southeast corner of a parcel of Eugene H. Fox, RN#200611222;

Thence with the east line of said parcel, N 2°11'38" W, 81.12 feet to a 5/8" iron rod set;

Thence along the north line of said parcel N 88°22′28″ W, 40.02 feet, to a 5/8″ iron rod set;

Thence along the west line of said parcel S 2°11'38" E, 81.12 feet to a 1" iron pipe found in the north right of way line of Pierce Street.

Thence along the north right of way line of Pierce Street N 88°22′28″ W, 104.76 feet to the place of beginning, containing 1.6310 acres of land, more or less, subject to legal highways and easements of record.

This description was prepared by Steven B. Walton, P.S., Ohio R.L.S. 7675 from an actual field survey of the premises conducted in August of 2017. Bearings hereon are based on the Ohio State Plane Coordinate System NAD 83 (2011)

and in Exhibit "A" which is attached to this Ordinance and specifically incorporated herein, from "R140" (Single-Family Residential District) and "RRB" (Residential Business District) to "PF" (Public Facility District).

Section 2. The City's Chief Planner is directed to make the change on the original Zoning Map on file in the Office of Planning and Zoning.

Section 3. If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 4. This City Commission finds and determines that all formal actions of this City Commission concerning and relating to the passage of this Ordinance were taken in an open meeting of this City Commission and that all deliberations of this City Commission and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 5. That for the reasons set forth in the preamble hereto, this Ordinance shall take effect under suspension of the rules as provided in Section 13

of the City Charter after its adoption and	due authentication	by the President and

# Survey for Firelands Regional Medical Center 1.6310 acres.



Planning Commission October 25, 2017 Minutes "Draft"

The Chairman called the meeting to order at 4:30PM. The following members were present: Mr. David Miller, Mr. Jim Jackson, Chairman Michael Zuilhof, Mr. Conor Whelan, Mr. Joe Galea and Mr. Wes Poole. Ms. Casey Sparks Planning Department; Mr. Trevor Hayberger represented the Law Department and Debi Eversole, Clerk from the Community Development Department. Mr. McGory arrived late.

Mr. Galea stated prior to the Public Hearing that he will recuse himself from items #1 and #2 (Firelands Regional Medical Center) due to pending litigation with Firelands Regional Medical Center.

Ms. Sparks presented that **Firelands Hospital** had submitted an application to rezone several parcels along Hayes Avenue, Pierce Street and Rockwell Street. The parcels are proposed to be zoned from R1-40/Single Family Residential and RRB/Residential Business to PF/Public Facility for the purpose of parking. The applicant also applied for site plan approval for the parking area.

The bicentennial vision plan specifically discusses creating an "Eds and Meds" corridor by building on the presence of Firelands Regional Medical Center as well as reclaiming and repurposing blighted land for commercial development.

The applicant has over time purchased properties within the area for redevelopment and has actively expanded the uses within both the north and south campus area as well as expanding the Hayes Avenue corridor.

Staff has concern regarding the adjacent remaining residential structure and has proposed additional landscaping and buffering as a part of the site plan approval. This structure is currently zoned PF/Public Facility.

Staff is recommending approval with the condition that the applicant seek site plan approval.

Mr. McGory moved to suspend this discussion until the site plan approval is heard. Mr. Miller seconded the motion. Mr. Poole suggested that the meeting resume in the order of the agenda. Chairman Zuilhof stated that there are specific engineering concerns with the Ontario and Hancock School applications. The Civil Engineer stated that he would only be available until 5:30PM.

Robert Moore, 3610 Fox Rd, applicant for Firelands Regional Center stated that approximately one year ago, there was a notice that he VA was looking to relocate their outpatient clinic at the Ohio Veteran's Home into another location in Sandusky. Firelands put together a proposal where one of the requirements was to have 99 dedicated parking spaces; this will include a staff of 28 clinicians and 50 – 70 patients per day plus visitors. Firelands had acquired several properties on Pierce and Rockwell Streets. They reached out to the last residential property owner Mr. Fox. He was offered a purchase price for the home or a like kind exchange. Mr. Fox was not interested in moving and he stated that he fully understands what will be build around him.

Mr. Poole asked why the far west side of the property would not be suitable for this project. Mr. Moore stated that there are several limitations for the patients of the VA and although the patients may not be handicapped, it would be suitable for them to be able to park close to an entrance. The far west parking lot is overflow for behavioral health and dialysis patients and visitors.

Mr. Miller wondered if Mr. Fox is amenable to the conditions around him. Mr. Moore stated that when he spoke with Mr. Fox, he stated that eventually the hospital would get the property anyway. Mr. Moore stated that he was unclear what Mr. Fox meant by that statement.

Tim Stookey, 1307 Fifth Street stated that he was at the VA today and they have close parking for handicapped individuals. He suggested that the parking where the emergency room used to be at Providence Hospital should be designated for handicap parking only. Mr. Moore stated that the plan proposed to more than double the number of handicap parking spots than what is currently there.

Mr. Poole moved to approve the application to rezone the parcels listed on the application. Mr. Miller seconded the motion. Mr. Poole stated that the paperwork seemed to be in order. There had been a parking lot on the east side of Mr. Fox's property all along so there should be no reason not to approve the application. The motion passed with a 6/0 vote, Mr. Galea abstained.

The site plan application for **924 Ontario Street** (Ontario School) was tabled due to engineering concerns. It is anticipated that the application will be heard in the November or December Planning Commission meeting.

The site plan application for **2314 Hancock Street** (Hancock School) was tabled due to engineering concerns. It is anticipated that the application will be heard in the November or December Planning Commission meeting.

Ms. Sparks presented that Firelands Hospital had submitted for site plan approval for a parking area to service south campus and the proposed VA facility that will occupy 12,000 square feet with south campus in the near future. The applicant had proposed 147 parking spaces. The applicant would be required 60 spaces in order to make up for the parking that was lost at the old memorial site. The lease agreement with the VA stated that the applicant would provide 100 parking spaces in addition to 12 handicap van accessible spaces. The parking spaces are proposed to be 9'x19' angled at 60 degrees. The proposed aisle widths are to be 17.26' and 19.58'. The applicant had proposed 4 handicap spaces per requirements, one additional van accessible space needs to be provided, and however, there will be 12 van accessible spaces within the adjacent parking area.

The applicant had proposed several landscaping islands amongst the site, however due to the remaining dwelling staff had recommended additional landscaping along the southwestern corner of Hayes Avenue as well as additional landscaping adjacent to the residence.

Staff recommended approval of the site plan for the proposed 147 parking spaces with the area fronting Pierce Street, Rockwell Street and Hayes Avenue with the following conditions:

- 1. Removal of several parking spaces along the southwest corner of Hayes and Pierce Street for the purpose of additional landscaping to the site.
- 2. Relocation of the proposed handicap parking spaces to the west of the single family dwelling and additional landscaping within this location.
- 3. The applicant provides a lighting/photometric plan for the proposed site.
- 4. Approval of the site plan is contingent on the approval of the zoning map amendment.

Mr. Poole asked the applicant if there were any problems accommodating Staff's conditions. John Hancock stated that there is no problem with any of the conditions in which staff proposed.

Mr. McGory asked if there was any feedback from any of the other surrounding neighbors. Ms. Sparks stated that to date, there had been no feedback from any surrounding neighbors. There is a 6' privacy fence proposed. Mr. Hancock stated that the rears of those properties are currently fenced off from the parking lot right now.

Mr. McGory moved to approve the application subject to staff recommendations. Mr. Miller seconded the motion. The motion carried with a 6/0 vote. Mr. Galea abstained.

Mr. Galea moved to adjourn the meeting. Mr. McGory seconded the motion. The meeting was adjourned at 6:00PM.

<u>Item for Consideration:</u> Approval of the creation of Codified Ordinance Chapter 187, Public Arts and Culture Commission.

<u>Purpose:</u> To establish Chapter 187 Public Arts and Culture Commission, which creates policies, procedures and duties for the commission, as well as creation of the Public and Cultural Art and Acquisition Fund ("PCAAF").

The Public Arts and Culture Commission, shall be tasked with the preparation, maintenance and updating of the Public Art Master Plan. They shall also act as an advisory body, to the city, in reviewing and recommending for acceptance or rejection, public art projects. The Chair and City Manager, shall authorize expenditures from the Public and Cultural Art and Acquisition Fund, and provide recommendation for expenditure in full accordance with the City Charter. The "PCAAF" shall be funded on an annual basis with the use of general funds in an amount equal to one percent (1%) of the total admissions tax received from the previous year.

<u>Background Information</u>: During the planning process for the Sandusky 2018 Strategic Plan there was a call to increase Sandusky's status as a Destination City. The presence and investment of millions of visitors in Sandusky annually provides us with resources to offer amenities that would typically be unavailable to cities of similar size. These amenities will benefit the quality of life for local residents in addition to attracting visitors.

Arts and Culture is a classic example of a quality of life issue that also drives a destination economy. Children, residents, and future residents value strong cultural assets like the State Theater, Maritime Museum, Merry-Go-Round Museum, Sandusky Cultural Center, and more. In addition to these cultural institutions however, the city is in an excellent opportunity to stimulate residents and visitors further by enhancing and dedicating resources to public art. Further investments in public art have been demonstrated to increase private investment and raise property values according to *Urban Land*, a publication of the Urban Land Institute in 2012.

**Budgetary Impact:** There is no direct budgetary impact related to the creation of the Public Arts and Culture Commission. The Public and Cultural Art and Acquisition Fund ("PCAAF") referenced in the proposed Chapter 187, shall be funded on an annual basis with the use of general funds, not admission tax dollars. One percent (1%) of the total admissions tax received from the previous year will be used to calculate the budget for the PCAAF.

<u>Action Requested:</u> It is requested that legislation be passed under Section 13 of the City Charter to create Chapter 187, Public Arts & Culture Commission.

# Sandusky Percent for Art Program

Throughout the Bicentennial Plan visioning process a need for increased focus on public art was mentioned numerous times. The City of Sandusky could accomplish this by creating a Percent for Public Art Program that would have a purpose of:

### 1. The creation of a Sandusky Public Arts and Culture Commission

- a. Nurture a vibrant cultural and artistic community in Sandusky, as well as to oversee and administer a public art program that will ensure the inclusion of artwork throughout the city to enhance the artistic and cultural development of the city.
- b. This commission will have members with a broad set of backgrounds in the fine arts, architecture, business, landscape architecture, marketing, communications, graphic design, programming and others. Must have a youth liaison and a city commission's liaison.

### 2. Creating an ordinance that forms an annual fund dedicated to public art

- a. The Public and Cultural Art and Acquisition Fund ("PCAAF") shall be funded on an annual basis with the use of general funds, not admission tax dollars. However, one percent (1%) of the total admissions tax received from the previous year will be used to calculate the budget for the PCAAF.
  - i. For example, in year 2016 the city received \$4.3 million in admissions tax revenue, which would create a line item budget for public art under the general fund in the amount of \$43,000.
- b. Funds may be pooled and aggregated over a few years if projects costs deem it necessary.
- c. Funds can be used for maintenance and curation.

### 3. Create a public art plan

- a. Create a framework for implementing public art in a strategic way that aligns with the Bicentennial Vision Comprehensive Plan.
- b. The plan is to be created every 10 years with annual updates.
- c. The Sandusky Arts and Culture Commission and the Public Art plan will create guidelines for artwork visible from public property.

The Sandusky Public Arts and Culture Commission and Percent for Art Program are vital as public art is accessible to everyone. It offers a social escape in an urban setting and also helps drive local economies. Creating a city with a multitude of unique events and pieces of art means more revenue for local business and it makes our community more attractive to young, talented professionals, as well as enhancing the city for current residents and small businesses. A strong public art program will be important as a person's choice on where to live is increasingly being driven by quality of life and the availability of cultural amenities.

This program will help leverage our funds with our own resources by integrating public art projects into infrastructure or development projects as well as combining this program with resources from sponsors, developers, foundations etc....

AN ORDINANCE AMENDING PART ONE (ADMINISTRATIVE CODE), TITLE SEVEN (BOARDS AND COMMISSIONS), BY THE ADDITION OF CHAPTER 187 (PUBLIC ARTS AND CULTURE COMMISSION) OF THE CODIFIED ORDINANCES, IN THE MANNER AND WAY SPECIFICALLY SET FORTH HEREINBELOW; AND DECLARING THAT THIS ORDINANCE SHALL TAKE EFFECT UNDER SUSPENSION OF THE RULES AS CONTAINED IN AND IN ACCORDANCE WITH SECTION 13 OF THE CITY CHARTER.

WHEREAS, the proposed Public Arts and Culture Commission is established to administer, promote, facilitate, and oversee the creation of public art projects that will promote the cultural heritage and artistic development of the City, enhance the City's character and identity, contribute to economic development and tourism, add warmth, dignity, beauty and accessibility to public spaces, and expand the experience and participation of citizens with visual arts; and

**WHEREAS**, the proposed Public Arts and Cultural Commission will prepare, maintain, and update a Public Art Master Plan which identifies locations for public art in the City and identifies specific performing arts venues or locations for development; and

**WHEREAS**, in addition, a Public and Cultural Art and Acquisition Fund (PCAAF) will be created for authorized expenditures and will be funded on an annual basis with general funds based on a formula for establishing the budget of the PCAAF; and

WHEREAS, in that it is deemed necessary in order to provide for the immediate preservation of the public peace, property, health, and safety of the City of Sandusky, Ohio, and its citizens, and to provide for the efficient daily operation of Municipal Departments of the City of Sandusky, Ohio and, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SANDUSKY, OHIO, THAT:

Section 1. Part One (Administrative Code), Title Seven (Boards and Commissions), of the Codified Ordinances of the City be amended by the addition of new Chapter 187 (Public Arts and Culture Commission) as follows:

# NEW CHAPTER 187 PUBLIC ARTS AND CULTURE COMMISSION

187.01	CREATED, MEMBERSHIP COMPENSATION AND TERM OF MEMBERS, MEETINGS.
187.02	DUTIES.
187.03	PUBLIC AND PERFORMING ART AND ACQUISITION FUND
187.04	LIMITATION OF POWER.

187.01 CREATED, MEMBERSHIP COMPENSATION AND TERM OF MEMBERS, MEETINGS.

- (a) Members. There is hereby created and established a commission to be known as the Public Arts and Culture Commission, consisting of nine (9) members. Five (5) members shall be appointed by the City Commission and four (4) members shall be appointed by the City Manager. Preference to appointment to the Commission shall be given to City residence, although residency is not required. Members shall have experience and/or an interest in the placement, creation, or designation of public art.
- (b) <u>Ex-Officio Members</u>. The City Manager shall designate a City employee to serve as the staff liaison, one City Commissioner, and one representative of a high school and/or college art program (who may reside outside of the City of Sandusky) shall all serve as ex-officio members.
- (c) <u>Officers</u>. There shall be a Chair and Vice-Chair of the Public Arts and Culture Commission. The Public Arts and Culture Commission shall elect officers from its membership for a term of one (1) year and shall determine responsibilities of officers.
- (d) <u>Terms</u>. Public Arts and Culture Commission members shall serve three year terms and the membership shall be staggered. To achieve staggered appointments, the initial appointments to the Public Arts and Culture Commission shall have three (3) members appointed to three (3) year terms, three (3) members appointed to two (2) year terms and three (3) members appointed to one (1) year terms.
- (e) <u>Removal</u>. Members of the Public Arts and Culture Commission shall serve at the pleasure of the City Manager and City Commission and may be removed and replaced with or without cause at any time.
- (f) <u>Volunteers</u>. Public Arts and Culture Commission members are volunteers and shall serve without compensation or reimbursement for personal expenses.
- (g) <u>Meetings</u>. The Public Arts and Culture Commission shall hold regularly scheduled meetings. The frequency, time and location of meetings shall be established by the staff liaison. The staff liaison shall provide notice of all meetings to the City Commission Clerk a minimum of forty-eight (48) hours prior to the meeting to ensure public notice requirements are met. All meetings shall be conducted in accordance with the Open Meetings laws. All meeting and records of the Public Arts and Culture Commission shall be public records and kept in the custody of the City Commission Clerk.

### **187.02 DUTIES.**

(a) <u>Purpose</u>. The Public Arts and Culture Commission is created and established to administer, promote, facilitate, and oversee the creation of public art projects that will promote the cultural heritage and artistic development of the City, enhance the City's character and identity, contribute to economic development and tourism, add warmth, dignity, beauty and accessibility to public spaces, and expand the experience and participation of citizens with visual arts.

- (b) <u>Master Plan</u>. The Public Arts and Culture Commission shall prepare, maintain, and update a Public Art Master Plan which identifies locations for public art in the City of Sandusky and identifies specific performing arts venues or locations for development therefor.
- (c) <u>Responsibilities</u>. The Public Arts and Culture Commission, as an advisory body to the City Manager, shall assist in reviewing and recommending for acceptance or rejection, according to criteria described in the Public Art Master Plan, proposed public art projects.
- (d) <u>Authorization of Expenditures</u>. The Chair of the Public Arts and Culture Commission and the City Manager shall be required to authorize expenditures of the Public and Cultural Art and Acquisition Fund ("PCAAF") pursuant to the decisions of the Public Arts and Culture Commission, and in full accordance with the City Charter and any requirements thereunder for City Commission final approval.

## 187.03 PUBLIC AND CULTURAL ART AND ACQUISITION FUND

- (a) Accounting. The Public and Cultural Art and Acquisition Fund ("PCAAF") shall be funded on an annual basis with the use of general funds. One percent (1%) of the total admissions tax received from the previous year shall be used as the formula for establishing the budget for the PCAAF. The PCAAF is a separate, special fund as part of the City's overall finances into which public art donations and funding are deposited, transferred and used for acquisition, commissioning, performance, exhibition and conservation of public art as recommended by the Public Arts and Culture Commission and approved by the City Manager.
- (b) <u>Developer Contributions</u>. The Chief Development Officer shall develop and institute a process whereby developers of new City or non-City initiated, construction or redevelopment projects are educated about the City's Public Arts and Culture Commission, as well as the value of public art to the City of Sandusky.
- (c) Use of PCAAF. PCAAF funds may be authorized for the following purposes:
  - 1. Artist fees and artist travel related to the training, education and performance of art open to the general public;
  - 2. Artists fees and artist travel and expenses that are related to the City's commission or purchase of public art;
  - 3. Purchase of equipment to be used in performing arts;
  - 4. Leasing of equipment and space for education, practice and performance;
  - 5. Studies and planning documents to further the arts;
  - 6. Promotion and marketing of activities associated with educational activities and performances;
  - 7. Fabrication, storage, and installation of a commissioned work of art:
  - 8. Acquisition of existing work of art;

- 9. Fees associated with the lease of works of art for temporary display;
- 10. Required permits and insurance during the fabrication and installation of the public art per contract;
- 11. Project consultants and contracted services;
- 12. Curatorial services;
- 13. Public art planning services;
- 14. Documentation and interpretive plaques;
- 15. Publicity for public art projects;
- 16. Education and outreach, including symposia and special events;
- 17. Conservation and non-routine maintenance of works in the City of Sandusky Public Art Collection; and
- 18. Any other expense the City Manager approves in writing.
- (d) Non-use of PCAAF. PCAAF funds may not be used for:
- 1. Mass produced work, with the exception of limited edition controlled by the artist;
- 2. Professional graphics;
- 3. Routine maintenance; and
- 4. City of Sandusky staff costs.
- (e) <u>PCAAF Annual Report</u>. Each year the City Manager or designee shall assist the Public Arts and Culture Commission in preparing an annual report to be presented to the City Commission which provides for a detailed accounting of all PCAAF monies raised and all monies spent and/or earmarked for future expenditures.

### 187.04 LIMITATION OF POWER.

The Public Arts and Culture Commission shall have no police powers, disciplinary powers, or lawmaking powers.

Section 2. If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 3. This City Commission finds and determines that all formal actions of this City Commission concerning and relating to the passage of this Ordinance were taken in an open meeting of this City Commission and that all deliberations of this City Commission and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. That for the reasons set forth in the preamble hereto, this Ordinance shall take effect under suspension of the rules as contained in and in accordance with Section 13 of the City Charter after its adoption and due

<u>ITEM FOR CONSIDERATION:</u> Agreement for Professional Services with Environmental Design Group (EDG) to do site plans for and renderings of select initial Sandusky Neighborhood Initiative - Implementation Projects.

**BACKGROUND INFORMATION:** The City of Sandusky adopted the Bicentennial Vision in February of 2016. As part of the Bicentennial Vision, recommendations were made for investments into the neighborhoods to make them more vibrant, livable, and connected. As such, the City hired the Cleveland Urban Design Collaborative to create the Sandusky Neighborhood Initiative. The initiative, aimed at improving residential neighborhoods within the City, began with the selection of six (6) neighborhoods based on demographics, housing types, and geographic diversity to together serve as a representation of the city as a whole. The selected neighborhoods for the initiative are: The Cove, 1<sup>st</sup>-5<sup>th</sup> Street Neighborhood, South of Kilbourne Neighborhood, Garden District, The South Side and the West End. Each neighborhood underwent a planning process specific to their neighborhood including public involvement. Within each neighborhood, the plan calls for an existing or proposed anchor project, model block program, neighborhood identity and beautification projects and the facilitation of community programming to be accomplished over the five (5) year timeframe.

Implementation of the Sandusky Neighborhood Initiative projects has begun but several projects will require site planning including but not limited to: selection of appropriate plants for landscape, feasible amenity options, layout of landscape and amenities, and site renderings. Initial projects needing one or more of these services include: Public access waterfront improvements at the end of Curran & Lockwood Streets, a neighborhood park at 1321 Cleveland Road, the Venice Connector Curve improvements, and Huron Park improvements. A request for qualifications from registered Landscape Architects was issued and in which eight (8) submittals were received, evaluated and ranked by a selection committee. Based upon the firm's experience and professional expertise,, EDG was selected as the most qualified to perform the tasks necessary for the initial round of neighborhood projects.

AN ORDINANCE AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR PROFESSIONAL SERVICES WITH ENVIRONMENTAL DESIGN GROUP, LLC, OF CLEVELAND, OHIO, FOR THE SANDUSKY NEIGHBORHOOD INITIATIVE - IMPLEMENTATION PROJECTS; AND DECLARING THAT THIS ORDINANCE SHALL TAKE IMMEDIATE EFFECT IN ACCORDANCE WITH SECTION 14 OF THE CITY CHARTER.

WHEREAS, in 2016 the City's Bicentennial Vision / Comprehensive Plan and Strategic Plans were adopted in which recommendations were made for investments into the neighborhoods to make them more vibrant, livable, and connected and inspired the creation of the Sandusky Neighborhood Initiative; and

WHEREAS, this City Commission authorized the execution of an agreement with Kent State University Cleveland Urban Design Collaborative (CUDC), of Cleveland, Ohio, for Professional Services for the implementation of the Sandusky Neighborhood Initiative - Neighborhood Planning Project by Ordinance No. 16-097, passed on June 27, 2016; and

**WHEREAS**, this City Commission approved and adopted the Sandusky Neighborhood Initiative Plan by Ordinance No. 17-135, passed on July 10, 2017; and

WHEREAS, the Sandusky Neighborhood Initiative, aimed at improving residential neighborhoods within the City, focuses on six (6) neighborhoods (The Cove, 1<sup>st</sup>-5<sup>th</sup> Street Neighborhood, South of Kilbourne Neighborhood, Garden District, The South Side and the West End) where each neighborhood underwent a planning process specific to their neighborhood including public involvement and within each neighborhood, the plan calls for an existing or proposed anchor project, model block program, neighborhood identity and beautification projects and the facilitation of community programming to be accomplished over a five (5) year period; and

WHEREAS, a Request for Qualifications (RFQ) was issued for the Sandusky Neighborhood Initiative - Implementation Projects in which eight (8) submittals were received, evaluated and ranked by a selection committee and based on the firm's experience and professional expertise necessary to complete the required tasks, it was determined Environmental Design Group was the most qualified; and

WHEREAS, Environmental Design Group, LLC, will be providing professional services, including landscape architecture, planning, design, graphics, and engineering for the Sandusky Neighborhood Initiative - Implementation Projects on a task order basis and the services and associated fee will be described in and agreed to in writing on a project by project basis in Task Order format; and

**WHEREAS**, funds for the Sandusky Neighborhood Initiative have been allocated in the Neighborhood Initiative Fund and includes funds donated from the Randolph J. & Estelle M. Dorn Foundation; and

**WHEREAS**, the cost of the professional services is not to exceed \$30,000.00 and will be paid with Neighborhood Initiative Funds; and

WHEREAS, this Ordinance should be passed as an emergency measure under

suspension of the rules in accordance with Section 14 of the City Charter in order to proceed with implementation of the projects and allow timely expenditure of the Neighborhood Initiative Funds; and

WHEREAS, in that it is deemed necessary in order to provide for the immediate preservation of the public peace, property, health, and safety of the City of Sandusky, Ohio, and its citizens, and to provide for the efficient daily operation of the Municipal Departments, including the Department of Community Development, of the City of Sandusky, Ohio, the City Commission of the City of Sandusky, Ohio finds that an emergency exists regarding the aforesaid, and that it is advisable that this **Ordinance** be declared an emergency measure which will take immediate effect in accordance with Section 14 of the City Charter upon its adoption; and NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SANDUSKY, OHIO, THAT:

Section 1. The City Manager is authorized and directed to enter into an agreement with Environmental Design Group, LLC, of Cleveland, Ohio, for Professional Services for the Sandusky Neighborhood Initiative - Implementation Projects substantially in the same form as attached to this Ordinance, marked Exhibit "1", and specifically incorporated as if fully rewritten herein, together with any revisions or additions as are approved by the Law Director as not being substantially adverse to the City and consistent with carrying out the terms of this Ordinance, at an amount **not to exceed** Thirty Thousand and 00/100 Dollars (\$30,000.00).

Section 2. If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 3. This City Commission finds and determines that all formal actions of this City Commission concerning and relating to the passage of this Ordinance were taken in an open meeting of this City Commission and that all deliberations of this City Commission and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. That for the reasons set forth in the preamble hereto, this Ordinance is hereby declared to be an emergency measure which shall take immediate effect in accordance with Section 14 of the City Charter after its adoption and due authentication by the President and the Clerk of the City

Background Information: The properties listed above received loans through the City of Sandusky between the years 1989 and 2009. The loans were dispersed through multiple programs through the Community Housing Impact and Preservation Program as well as the Community Development Block Grant Program. All properties went through the foreclosure process, were sold at sheriff sale and are now owned by new owners – eliminating the City's source of collateral and therefor collectability of the loan balances. At sheriff sales, the properties were not sold for enough money for the City to receive all or even a portion of the outstanding balance. Since each property has transferred title the City is no longer able to collect any portion of the loan balance and is requesting the uncollectible debt be written off from an accounting perspective.

**Budgetary Information:** There is no impact on the City's General Fund.







Section 2. The Finance Director is authorized to draw warrants upon the

City treasury for funds appropriated in this Ordinance upon presentation of

properly approved vouchers and when in conformity with the Charter and general

laws of the State of Ohio. In addition, the Finance Director is authorized to make

transfers between funds, to cover deficiencies in City funds provided said

transfers are included in the general appropriations.

Section 3. If any section, phrase, sentence, or portion of this Ordinance is

for any reason held invalid or unconstitutional by any Court of competent

jurisdiction, such portion shall be deemed a separate, distinct, and independent

provision, and such holding shall not affect the validity of the remaining portions

thereof.

Section 4. This City Commission finds and determines that all formal

actions of this City Commission concerning and relating to the passage of this

Ordinance were taken in an open meeting of this City Commission and that all

deliberations of this City Commission and of any of its committees that resulted in

those formal actions were in meetings open to the public in compliance with the

law.

Section 5. That for the reasons set forth in the preamble hereto, this

Ordinance is hereby declared to be an emergency measure which shall take

immediate effect in accordance with Section 14 of the City Charter after its adoption

and due authentication by the President and the Clerk of the City Commission of the

City of Sandusky, Ohio.
