Recycling Program Notification

Once each year, each commercial hauler engaged in the collection and removal of garbage, refuse and/or recyclables shall provide to each of his or her customers during the months of March, April, or May, written notice of the availability and cost of recycling services. As part of the licensing process, commercial haulers shall provide to the City, adequate and appropriate demonstration of his or her compliance for the prior year with the written notice requirements of Section 955.11 of the Codified Ordinances of the City of Sandusky. Failure of any commercial hauler to comply fully with the notice requirements, or to afford the City demonstration of the same shall be and constitute grounds for the refusal of the issuance of a license.
