CONTRACT PERIOD & CONTRACTOR

Contract Period: April 1, 2026 through December 31, 2026 (a total of 9 months)
Contractor: Heitsche TLD of Norwalk, Ohio

PICK-UP SCHEDULE

Yard waste will be picked up weekly, each Friday.

Yard waste must be placed at the curb in front of the residence that has been authorized for yard waste collection and disposal services no later than 6:00 am on the scheduled day of collection. Holidays may affect the weekly pick-up.

CONTAINERS

20-35 gallon biodegradable waste bags and/or 20-35 gallon containers (garbage cans) clearly marked "yard waste." Purchase of bags or containers is the responsibility of the participant. Containers shall be constructed of plastic, metal, or fiberglass and shall have handles of adequate strength for lifting.

QUANTITIES

There is NO limit to the amount of yard waste collected weekly from a residence. Yard waste includes grass clippings, leaves, weeds, shrubs, brush, and tree trimmings. Containers must have handles of adequate strength for lifting. Shrubs, brush, and tree trimmings must be tied together with twine or string AND may not exceed 4 feet in length, 4 inches in diameter, or 60 pounds in weight.

PARTICIPATION

Residents within the corporate limits of the City of Sandusky may elect to "opt in" to this program. Participation enrollment or discontinuation will be offered in January of each year for the next contract period.

PROGRAM COST

The cost of the service is \$16.50 per month for the contract period (\$148.50 total). The charges for the program will be shown as a separate line item on the participant's water/sewer bill. Participant has the option to pay \$16.50 monthly or the \$148.50 as an annual (one time) charge for the contract period.
