#### **RECOMMENDED ACTION(S):**

It is recommended that the City Council adopt the attached Resolution authorizing the City Manager to execute an amended Memorandum of Understanding ("MOU") to continue its partnership with the City of Hollister and San Benito County by changing the use of its \$231,284 CDBG-CV2 and CV3 allocation, from homeless public outreach and services, to renovate the public facility used as a homeless shelter for the whole County for a total County project of \$1,150,872.

#### **BACKGROUND INFORMATION:**

At its regular meeting October 19, 2021, the City Council received a report that updated them on the Memorandum of Understanding ("MOU") approved by Resolution 2021-16 on April 13, 2021. At that time the City agreed to contribute its allocation of \$231,284 for homeless services and to help repair the homeless shelter. The collaboration between Hollister, the County and the City amounted to \$1,110,872; \$300,000 for the shelter repairs and \$850,872 for public services and outreach. Before the May 7, 2021 deadline, the County as lead agency, submitted two CDBG applications to the State Department of Housing and Community Development, ("HCD"); one for facility rehabilitation, and one for public services. The City's allocation was to support the public services.

On October 1, 2021, the City learned that the County has to re-program the use of public funds to facility rehabilitation. A large portion of the funds were to support a new managed homeless camp,

and they lost control of the property intended for this project. The City brought a memorandum to the City Council from its grant writer after they had spoken to the State HCD. That memorandum states that the HCD will allow the City to submit a new allocation, if it was not interested in its CDBG funds being used for facility rehabilitation. It first recommended that the City talk directly to HCD to confirm the details. The City held a public discussion on the 19<sup>th</sup>, and postponed taking action until staff could verify the details. It considered every kind of use possible for CDBG in hopes of submitting its own new application. This was the preferred choice.

If the City decides to continue its collaboration with Hollister and the County, the HCD deadline to re-submit a new revised application is October 31. A special meeting would have to be scheduled Tuesday the 26<sup>th</sup> so the City's action can occur before the deadline (if applicable).

#### **DISCUSSION:**

On the morning of the 20<sup>th</sup>, the County informed the City that its information was incorrect and that HCD would not receive any new applications after May 7<sup>th</sup>. That morning at 11:15, the City Manager and three staff members from HCD held a conference call. It included the HCD staff member identified in the grant writer's memorandum.

HCD stated that the City was limited to just two choices: it can assume the responsibility for the existing public service application that County was ready to abandon, or it could choose to support facility renovations. The City does not have the capacity to develop its own homeless public service program, which is why it decided to work in collaboration with Hollister and the County. It does not employ case workers, or specialists in homeless services, or have the overhead to support it. That leaves the City with only one choice; support the rehabilitation/renovation of the homeless shelter that serves the whole County. If the City does not agree to continue its collaboration, and terminates its MOU with the Hollister and the County, the \$231,850 will be returned to the CDBG program at HCD for another jurisdiction to use. Attached is the conversation with HCD from October 20, 2021.

In summary, in April, the City agreed to support the CDBG collaboration in part because these funds are complicated to use, and the alternative seemed like it met a true need for San Juan Bautista and the region. If homeless services are needed in the City, the City will use the "211" call-in for County Health and Human Services to request assistance. Since April, the City has retained the services of a grant writer that will help administer these complicated federal grant programs. In the future, City will be capable of assessing the use of these grant funds locally, if it chooses.

#### **FISCAL IMPACT:**

By agreeing to collaborate with Hollister and the County, the City's CDBG allocation of \$231,284 will be used in the County to help the homeless population. If it decides not to collaborate and make this change from public services to facility rehabilitation, its CDBG allocation will be returned to the State HCD for use by a different local government.

#### **RESOLUTION 2021-XX**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN JUAN BAUTISTA AUTHORIZING AN AMENDED MEMORANDUM OF UNDERSTANDING WITH THE CITY OF HOLLISTER AND SAN BENITO COUNTY TO USE \$231,284 OF COMMUNITY DEVELOPMENT BLOCK GRANT CARES ACT CV2 AND CV3 FUNDS THAT CHANGES THE USE OF FUNDS FROM HOMELESS PUBLIC SERVICES, TO REHABILITATE A FACILITY USED AS THE COUNTY'S HOMELESS SHELTER

WHEREAS, the federal government delegated a portion of its CARES Act relief funds to its various departments, and the Department of Housing and Urban Development ("HUD") received a generous allocation as part of its Community Development Block Grant ("CDBG") program in three intervals referred to as "CDBG-CV1, CV2, AND CV3"; and

**WHEREAS**, in smaller jurisdiction, HUD delegates the authority to manage these funds to the State, and in California, this is the Department of Community Development ("HCD"); and

WHEREAS, on April 13, 2021, the City Council executed a resolution and appropriated \$63,558 from CDBG CARES ACT V1 authorizing the execution of a regional Memorandum of Understanding ("MOU") between the City of Hollister, San Benito County and San Juan Bautista that will provide subsistence payments to City and County residents that have suffered a loss of income due to the pandemic to them help pay for utility expenses; and

WHEREAS, also on April 13, 2021, the City Council directed staff to bring forward a second Resolution and MOU for the CDBG CARES Act V2 and V3 in the amount of \$231,284 in partnership with the City of Hollister and San Benito County for a total budget of \$1,150,872, to fund various regional homeless services programs as descried in the attached MOU; and

WHEREAS, the County submitted two applications to HCD, one for \$300,000 to rehabilitate the Homeless Shelter, and a second for \$850,852 that includes the City's allocation of \$231,284 for homeless public services for a total of \$1,150,872; and

WHEREAS, HCD's deadline to submit these two applications for CDBG CARES Act V2 and V3 funds was May 7, 2021; and

WHEREAS, on October 1, 2021, the City learned that the County had to modify its May 7, 2021 applications to HCD, moving the public service funds to facility renovation, because the services they planned to implement were no longer possible due to the loss of site control where these services would be provided; and

WHEREAS, changing the County's CDBG application has to be done by HCD's deadline of October 31, 2021; and

WHEREAS, at the City Council's regular meeting held on October 19, 2021, it considered a consultant's report stating that HCD, in an informal discussion, agreed that the City could find a new use of for its funds, and also received feedback from the County concerning its needs and the proposed change of use of funds; and

WHEREAS, as described in Staff's October 19, 2021 report, to City Manager spoke with HCD staff October 20, 2021, to verify HCD's position in this matter, and learned that the City could not initiate a new application as the May 7 deadline had passed, but it could assume responsibility for the soon to be abandoned County homeless public services application, or agree to the proposed change of use for the funds moving 100% of the funds to facility renovation; and

WHEREAS, the City does not have the capacity to build a homeless public outreach or service program, and is unable to fulfill the expectations described by the County in their application to HCD for public service funds; and

WHEREAS, at its special meeting held October 26, 2021, the City Council agreed to continue to work with the County and have its portion of \$231,284 used for facility renovation and repair the roof of the homeless shelter that serves the whole County.

# NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE SAN JUAN BAUTISTA CITY COUNCIL AS FOLLOWS:

**SECTION 1.** That the recitals in this Resolution and accompanying staff report are true and correct and are hereby made a part of this Resolution.

**SECTION 2.** The City Council of the City of San Juan Bautista, hereby agrees with the terms and conditions set forth in the Amended MOU attached hereto by reference, agrees to continue its partnership with the City of Hollister and San Benito County by changing the use of its \$231,284 CDBG-CV2 and CV3 allocation, from homeless public outreach and services, to renovate the public facility used as a homeless shelter for the whole County for a total County project of \$1,150,872.

**SECTION 3.** The City Council directs and authorizes the City Manager to prepare and execute the Revised MOU in time for the October 31, 2021 deadline.

# Attachment AMENDED MEMORANDUM OF UNDERSTANDING FOR CARES ACT V 2 AND V3

# MEMORANDUM OF UNDERSTANDING BETWEEN THE COUNTY OF SAN BENITO AND CITY OF HOLLISTER AND CITY OF SAN JUAN BAUTISTA, FOR THE PREPARATION AND SUBMITTAL OF AN APPLICATION FOR THE OPERATION OF A PUBLIC FACILITIES IMPROVEMENT PROGRAM TO BE FUNDED BY CDBG-CV2/3 GRANT FUNDS

- 1. Parties: This Memorandum of Understanding (hereinafter referred to as ("MOU') is made and entered into by and between the County of San Benito (hereinafter referred to as ("Agency 1"), the City of Hollister, (hereinafter referred to as "Agency 2") and the City of San Juan Bautista (hereinafter referred to as "Agency 3". The address of the lead Agency 1 is 1161 San Felipe Road, Suite Bldg. B, Hollister, CA 95023.
- 2. Purpose: The purpose of this MOU is to establish the terms and conditions under which the Parties will operate a public facility improvement program to serve the homeless and lower income persons and households. This program seeks funding the aggregate amount of \$1,1,50,872 which is derived from jurisdictional allocations of \$369,468 to the County of San Benito, \$550,120 to the City of Hollister and \$231,284 to the City of San Juan Bautista. The shared program activity will consist of conducting public outreach on the proposed CDBG-CV2/3 program to the homeless and lower income individuals and households residing in each of the three jurisdictions who have been impacted by the COVID-19 pandemic.
- 3. Term of MOU: This MOU is effective upon the day and date last signed and executed by the duly authorized representatives of the Parties to this MOU and the governing bodies of the Parties' respective jurisdictions and shall remain in fully force and effect for not longer than 18 months from the date a standard agreement is executed. This MOU may be terminated, without cause, by either Party upon thirty (30) days written notice, which notice shall be delivered by electronic mail, hand or by certified mail to the address listed above.
- 4. Responsibilities of Agency 1: Agency 1 shall be the lead applicant and shall be responsible for coordinating all necessary pre-application activity, application submittal, conditions of the standard agreement and post award activity. In addition, Agency 1 as the lead agency, shall be responsible for the overall operation of the proposed program in order to secure compliance with the State CDBG-CV rules and regulations. Agency 1 shall be responsible for activity implementation, financial reporting, submitting funds requests and related administrative duties.

- 5. Responsibilities of Agency 2: The primary responsibility of Agency 2 shall be to cooperate in the preparation of the CDBG-CV2/3 application and meeting all responsibilities required of the jurisdiction for participation in a joint CDBG activity. Following an award of the funds, Agency 2 shall further cooperate by promoting the shelter and making referrals of homeless individuals in need of emergency shelter.to Agency 1. Agency 2 shall also participate in program meetings to provide feedback on the implementation of the proposed activities.
- 6. Responsibilities of Agency 3: The primary responsibility of Agency 3 shall be to cooperate in the preparation of the CDBG-CV2/3 grant application. This shall include meeting all responsibilities required of jurisdictions for participation in a joint CDBG activity. Following an award of funds, Agency 3 shall further cooperate by promoting the shelter and making referrals of homeless individuals in need of emergency shelter to Agency 1. Agency 3 shall also participate in program meetings to provide feedback on the implementation of the proposed activities.
- 7. Administrative costs allowed by CDBG-CV2/3 Grant: The State CDBG-CV grant program allows for a percentage of the total grant to be used to cover administrative costs in the operation of the proposed program. Agency 1 shall be entitled to all of the administrative funds allowed by the State HCD/CDBG due to its role and responsibilities as the lead agency.

#### 8. General Provisions:

- A. **Amendments**: Either Party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the Parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all Parties to this MOU.
- B. **Applicable Law**: The construction, interpretation and enforcement of this MOU shall be governed by the laws of the State of California. The courts of the State of California shall have jurisdiction over any action arising out of this MOU and over the Parties and the venue shall be the County of San Benito Judicial District, California.
- C. **Entirety of Agreement**: This MOU, consisting of four (4) pages, represents the entire and integrated agreement between the Parties and supersedes all prior negotiations, representations and agreements, whether oral or written.
- D. Severability: Should any portion of this MOU be judicially determined to be illegal or unenforceable, the remainder of the MOU shall continue in full force and effect, and either Party may renegotiate the terms affected by the severance.
- E. **Sovereign Immunity**: Agency 1, Agency 2 and Agency 3 and their respective governing bodies do not waive their sovereign immunity by entering into this MOU,

- and each fully retains all immunities and defenses provided by law with respect to any action based on or occurring as a result of this MOU.
- F. Third Party Beneficiary Rights: The Parties do not intend to create in any other individual or entity the status of a third-party beneficiary, and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained this MOU shall operate only between the Parties to this MOU and shall inure solely to the benefit of the Parties to this MOU. The provisions of this MOU are intended only to assist the Parties in determining and performing their obligations under this MOU. The Parties to this MOU intend and expressly agree that only Parties signatory to this MOU shall have any legal or equitable right to seek to enforce this MOU, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this MOU, or to bring any action for breach of this MOU.
- G. CDBG Program Terms and Conditions: The Parties agree to administer all funding and activities identified in this MOU in compliance with the State Agreement executed with the State for said activities and funding. The Parties agree that the County of San Benito, as the lead agency, shall be the executor of the Department's Standard Agreement, and that primary communication regarding the activities shall be the responsibility of San Benito County. It is the responsibility of the Parties to this MOU to communicate and transfer performance and regulatory compliance to applicable Parties, including contractors and subrecipients. Failure to administer funds and/or activities in accordance with HUD regulations, and the terms and conditions identified in the standard agreement will result in performance penalties toward all Parties to this MOU, and may result in repayment of expended CDBG funds in the event that the costs were determined to be ineligible, or that the funds failed to meet a National Objective, as identified in title 42 of the United States Code, Section 5301 and title 24 of the Code of Federal regulations Section 570.483.
