The majority of activities during the month of December was dedicated to parking enforcement. During the Christmas and New Year's holiday period December 16-30. Kysmet Security provided 22 hour/day coverage. This modified schedule was to deter porch pirates and other possible thefts during the holiday season.

Kysmet Officers issued 12 green tags and 22 parking citations. I issued no green tags, 4 parking citations and 7 Administrative Citations (All to the same violator). Kysmet continues to perform foot patrols during which time they discovered two unlocked doors. Due to the fact that the Officer activated the alarm when the door was checked both businesses were secured without the assistance of the Sheriff's Office.

The trapper continues to remove the feral chickens and roosters.

Focus for the month of January will continue to be parking enforcement, including sidewalk and driveway violations. A public education campaign will be started regarding the licensing of dogs and property maintenance. A short informational letter will be drafted and included with the February water bill requesting citizens to register their dogs and information will be provided on the City web site. Letters will be sent to all businesses informing them that in accordance with Municipal Code Section 5-8-170, all refuse or trash must be placed so as not to be visible from neighboring properties or streets. Several dumpsters currently are not in compliance. Continue issuance of Administrative Citations.
