APRIL 2023 ACTIVITY LOG

- 04/02/2023 Patrolled all side streets from 1930HRS arrived on third street at 1945HRS seen one girl that looked like she had too much to drink. I walked up with Parga to make contact to see if she need any medical assistance she looked very out of it she was with her husband and he carried her to the car of her mother's car. And they explained she had to much to drink and she was fine but it did not look like that. So I Have the license plate on my body cam and read it out loud in case we need license plate for the future. Finished at 2000HRS. From then it was all clear no issues to report.
- 04/02/2023 Arrived at 3rd street at 2035HRS at Donner Ester there was people claiming to be working on the roof of the building . I made contact with one of the employees to see what was going on, he told me that they were working on the roof. I asked him what they were working on and he said cleaning the air vents. Same with the other worker there.
- 04/02/2023 Arrived at third st at 2245HRS all clear no issues to report. Notice light was on in the museum looked around and found nothing or any person near so all clear no issues to report.
- 04/02/2023 1640HRS I was driving down second st when i notice a vehicle parked in a cross walk i gave this vehicle a parking ticket for city code violation 7-4-100 stopping in specified places no other issues to report. I left second ST black 1700HRS
- 04/02/2023 1717HRS I was driving down Church Street when I notice a vehicle that appear to be getting gas siphoned out of it. When i approached the vehicle. A man was standing next to the vehicle i recognized the man, an interaction that I had a few weeks ago. He explained that he had accidentally put gas in his diesel truck. Body cam was turned on. No other issues to report. I left Church Street at 1730HRS
- 04/02/2023 1945HRS I was driving down third ST I notice a lady sitting on a bench who appeared extremely intoxicated. As we approached the man who is standing next to her trying to pick her up and put her a car that had just pulled over. Body cam was turned on. While talking with the man and the lady that was driving the vehicle I came to the conclusion that the driver was her mother and the man was her husband. For lady who was a on the bench, she was unable to walk/hold her self up. They did not want EMS. No other issues to report. I left third ST at 2009HRS
- 04/02/2023 2149HRS I was driving down lang CT when I notice a vehicle parked the wrong direction I gave this vehicle a parking warning. No other issues to report i left lang CT at 2203HRS
- 04/03/2023 0437HRS conducted a patrol of the San Juan Bautista water tower the gate was locked. The water pipe outside the gate was releasing water. Contacted the San Juan Bautista public works.

- 04/05/2023 Paroled all aide streets from 2120HRS to 2210HRS.Made contact with 5 girls at San Jose st and second st park. I was letting them know that the curfew was at 2200HRS. Check all 3 bathroom spots in the city they are all safe and secure.
- 04/08/2023 1712HRS witnessed semi on Franklin st/ and third st. When we came to area found that the semi had left area and the stop sign on Franklin knocked over managed to locate semi and managed to get plates and photos before he left town. Notified Rich brown and canvased area for witnesses, were able to locate multiple witnesses and they provided us with photos and statements on the happenings. Rich brown arrived took photos and all info was given to him. Helped straighten sign as it had been completely flattened. Nothing further to report.
- 04/10/2023 0005HRS conducted patrol at the veterans hall. Gates are locked. A person needed assistance he asked for a phone he can use to call for a ride because he was stranded. The person he called said he is going to pick him up. Nothing further
- 04/10/2023 0006HRS conducted patrol at the Valero gas station. There was a white F-1 ford truck in pump number 7 that would not start the owner left a note. Contacted Rich brown regarding he said it will be up to the gas station what to do in the morning regarding the truck. No issues to report
- 04/10/2023 1633: checked on Valero gas station. Noticed the Library traffic sign was knocked over. Notified code enforcement. Nothing further to report.
- 04/11/2023 2347HRS conducted patrol at the veterans hall. One gate was unlocked we secured it. We also called rich and he told us just to lock it back up. Nothing further
- 04/12/2023 2326: jj's burgers was unlocked. Code enforcement and owner were notified.
- 04/12/2023 2312HRS Conducted a foot patrol of Third Street. All businesses were closed with the exception of Daisy'. We checked all businesses doors to verified all doors were locked and secured. JJ'S Burger was left unlocked. We contacted code enforcement and notified him. No issues or suspicious activity to report.
- 04/15/2023 2308HRS we noticed a red Camaro parked in a handicap parking on 3rd St and Mariposa St, was unable to give citation because the driver left as I took pictures of the vehicle 2326HRS an alarm was going off at Ms. B's, we were told by Rich to notify sheriffs dispatch, no other issues to report
- 04/16/2023 2330HRS conducted foot patrol at the baseball restrooms and on the men's restroom there is graffiti on the walls. The soccer field restrooms in the men's and women's restroom there is graffiti as well. I took pictures and sent them to Rich. And the verutti park restrooms you can barely see some graffiti on the wall. The Verutti park had a restroom locked. The windmill market restrooms are fine. Nothing further
- 04/17/2023 2311HRS conducted foot patrol at the windmill market restroom. No issues to report .Conducted foot patrol at the soccer field restrooms and there is still graffiti and food on the sinks. Conducted foot patrol at the baseball restrooms and the men's restroom is still has graffiti. Conducted foot patrol at the Verutti park restrooms. No issues to report.
- 04/18/2023 1827: received a phone call from dispatch about a resident who had called about a trailer parked over 72hrs. 72 hour noticed had already been issued. Caller was

then contacted by phone call and was explained to that the parking over 72hrs process had been started. Nothing further to report.

- 04/18/2023 2242HRS conducted foot patrol on 3rd street. All business doors were locked except for daisy's bar and JJ's burger. Josh told us to monitor their door until sheriffs shows up. 2311HRS sheriffs showed up to daisy bar. 2314HRS JJ's Burgers owner showed up. 2335HRS Daisys bar owner showed up and told us to not check her doors anymore. Nothing further
- 04/18/2023 2348HRS conducted foot patrol at the windmill market restroom. No issues to report. Conducted foot patrol at the soccer field and the woman's restroom still had graffiti. Conducted foot patrol at the San Verutti restrooms. No issues to report. Conducted foot patrol at the baseball field restrooms and there is still graffiti on the mirror. I sent a picture to rich. Nothing further.
- 04/19/2023 2340HRS conducted foot patrol at the soccer field restrooms and the female restroom door has graffiti and the men's restroom mirror has tag marks. The Windmill market restrooms are fine. The baseball restrooms men's has graffiti on a wall and on the mirrors. The Verutti park restrooms are fine. Nothing further
- 04/21/2023 0434HRS conducted patrol at the San Juan Bautista VFW hall the front gate is unsecured the lock is missing. The parking lot is empty. No issues to report
- 04/23/2023 2008HRS we noticed at semi parked in the windmill market parking lot, we gave the semi a ticket for city code violation 7-4-715 "parking of oversized vehicles", the ticket was left in the door handle
- 04/23/2023 2315HRS conducted foot patrol at the windmill market restroom. No issues to report. Patrolled the soccer field restrooms and the girls restroom door had graffiti. The boys restroom mirror has scratches. I sent pictures to Rich. Patrolled the verutti park restrooms. No issues to report. Patrolled the baseball field restrooms and the men's restroom has graffiti on the wall and the mirror. I took pictures and sent them to Rich.
- 04/24/2023 0237-0250HRS Checked the verutti park restrooms the woman's restroom had a knife on the sinks it was disposed in the trash. Patrolled the baseball field restrooms and the men's restroom had graffiti on the wall and the mirror. Patrolled the soccer field restrooms and the girls restroom door had graffiti. Patrolled the windmill market restrooms no issues to report.
- 04/28/2023 1849: During patrol of the downtown area of 3rd st. Officer valadez and I observed a vehicle that was parked in a handicapped parking zone without a handicapped placard. Vehicle was issued a citation.
- 04/29/2023 1816HRS got a call from Rich Brown of two vehicles he had spotted that needed citations. Went over to area (Second st, Polk st) and both vehicles were cited.
- 04/29/2023 1823 Heard Firework after finishing writing the citations Rich brown had told us about , proceeded to the direction of the sound to investigate the area(fifth st-Seventh st) and found no evidence of any fireworks. Decided to go sit on lausen Dr to get a better view , and at 1842HRS we witnessed a Male in a black t shirt, dark colored pants, wearing white shoe's setup and light an illegal Aerial Firework. We Proceeded to the address [57 Muckelemi st) and identified the male who had set the firework off. Notified Rich brown and were told to ask him to identify himself or sheriffs would be called out. We arrived to 57 muckelemi were the Person in question was located. On our approach

to talk with the man that parga and I witness setting on fireworks we noticed that the man along with two other males where drinking beer . Parga and I went up to the man and asked him about the fireworks. We Told him that we need his information because he will be getting a city administrative citation. At this time a second party later identified as [REDACTED] (Hispanic Male late 40s shaved head wearing a black shirt with a white long-sleeve under it , black pants and black and white shoes) began to berate us, say we had no proof and could not do anything. Parga and I let them know if they choice not to give us his information that we will be Contacting the sheriffs office, they told us to go head, contact the sheriff office and get off the property. Parga and I start to return to our patrol car when I notice a piece of the fireworks was on the ground about 100 feet away from where they set off the firework. After returning to our patrol car I call the sheriffs office and informed them of the situation and told them we would be parked at San Antonio st/ mukelemi st. After about 15 minutes of me and my partner being parked at San Antonio st/ mukelemi ST the individual later identified as [REDACTED] preceded to cross the street and make contact with us. Parga and I got out of our patrol car. [REDACTED] stated that parga and I were harassing him, Parga and I both explain to him that in fact we were not harassing him that we are waiting for the Sheriff's Department. After [REDACTED] lit a cigarette and explained once again that he felt like we were harassing him he crossed back over to other side of the street. After the two interactions we had with [REDACTED] it's was very apparent that [REDACTED] was under the influence of alcohol from which we saw him drinking during from our first interaction with him. After 24 minutes a white Toyota Tacoma turned on to San Antonio and pulled up next to us , a Hispanic male(grey shirt, Grey jeans full beard and with black hair. late 30s) got out of the vehicle and began to record and berate us on why we were harrasing the party we had contacted, a couple minutes after his arrival [REDACTED] also decided to come over and berate us after a couple moments and after threatening to [REDACTED] to make us move along I was finally able to deescalate the situation and explain what was going on and we came to the consensus of moving away from the area to calm the situation. I informed Rich brown of what was happening and he decided he would come down and render assistance with the situation after 20 minutes of us having left the area to a more secure location they decided to drive past us and yell explicit things out of there vehicle (black newer Chevy Tahoe) and drove off . Rich brown shortly arrived after they had passed we notified him and he decided to go and find where they went to which he was successful in finding them. we met with Rich Brown at city hall and provided him with the evidence we had found and a full recap of the events that transpired. Nothing further to report.

- 04/29/2023 2334HRS arrived at the windmill market, noticed one of the Pizza Factory doors looked like it was slightly kicked in but it was locked, there was a male standing in the parking when we were checking doors, Hispanic, was approximately 6 feet, wearing a cap, dark blue sweater, light colored jeans, white shoes, Rich was notified about the doors
- 04/30/2023 2119HRS made contact with a male in the parking lot across from the windmill market parking lot, he told us he was going to urinate next to the fence, Parga informed him the restroom was nearby.
