JULY 2023 ACTIVITY LOG

- 07/01/2023 Patrolling all side streets from 2330 till 0140HRS only issues we had was fireworks were being lit could not find the source of the issues walked all side streets all Clear no issues to report
- 07/01/2023 2346 Patrolled San Juan Mission and resident came up to me informing me that there was a mobile home whos been parked and doesn't have a permit to park there. Will talk to mobile home owner and let them know they need a permit to park or else they have to leave.
- 07/02/2023 0030 conducted foot patrol of baseball park where resident claims she seen 5 young men lighting fireworks and ran through the park. Carrillo and myself conducted foot patrol of city streets in the area of the park.
- 07/02/2023 0512 Patrolled san Juan elementary. Noticed the gate next to the basketball courts was opened. Made sure to secure. All clear.
- 07/02/2023 2030HRS we had a meeting with rich brown the code enforcer. He said if there is people popping illegal fireworks to call him as soon as possible so he can issue the citation.
- 07/02/2023 2141HRS we were searching for a small brown SUV 4runner with black tinted windows. They were driving around lighting up fireworks.
- 07/02/2023 Patrolling all side streets from 2200 till 0000HRS. Followed suspect of people using illegal fireworks 3 guys wearing all black.
- 07/03/2023 2026: met with code enforcement. Discussed preparations for the 4th of July.
- 07/03/2023 2100: patrolled through windmill parking lot. Customers are leaving store. Windmill market employees are closing. Pizza factory employees are closing. Stood by until employees locked and secured front doors. Conducted a foot patrol. Verified all business doors are locked. No activity or incidents to report. Area is clear and secure.
- 07/03/2023 2310: checked on abbe park. 1 male sitting at the bus stop(no busses running) stood by until male left the area at 2214hrs. Area is now clear and secure.
- 07/03/2023 2306HRS conducted foot patrol on 3rd street. The Santana gallery door was open. Code enforcement and store owners were notified. All other business doors were locked.
- 07/04/2023 1727: met with code enforcement at city hall. Discussed preparations for residents that set off illegal fireworks.
- 07/04/2023 2000: officer valadez informed me a resident had made contact with him and informed him that 2 bicycles were stolen from his residents on cedar. Resident gave a description of the bicycles and two male suspects(male in red hooded sweater, male in Grey hooded sweater). I then patrolled the area of mission Vineyard, mission farm campgrounds, and Copperleaf area but did not get visual of anyone matching the description of the suspects. Will continue to monitor.

- 07/04/2023 2100: resident informed me that people were setting off fireworks in the field behind the SJB mission. Notified code enforcement. Was not able to make contact.
- 07/04/2023 2234: conducted foot patrol around 5th, 6th, and 7th Streets and abbe park. Heavy illegal firework activity. Was not able to make contact due to multiple illegal fireworks going off.
- 07/04/2023 2215HRS began driving around letting people know that no fireworks were allowed anymore. Notified 5 residents throughout muckelemi ST. Nothing further to report.
- 07/04/2023 2209 By orders of code enforcement we were told to notify residents that they would like all firework activity to be stopped by 10pm. As we were walking towards residents who were still outside they started screaming at me, they said they didn't need us in the city and got too close to me. I called over the radio that I would like backup, my first language is spanish and I feel more comfortable speaking it over the radio. The man started screaming that "this is America and speak English". The man was too intoxicated. I did not want to make the situation worse. Rich and Cecenas showed up to back us up. Eventually they got calm and we left the area (Muckelemi)
- 07/04/2023 2215- responded to yells at Muckelemi where code enforcement confronted a intoxicated male resident about getting verbally aggressive towards on of the guards on site. After Rich from code enforcement made contact with individual, he started yelling. Body cam was turned on. Situation was deescalated. All clear.
- 07/04/2023 2236HRS conducted patrol at the copperleaf community. Used fireworks were left on the middle of the road. We had to turn one off because it was on fire.
- 07/07/2023 1919: patrolled through SJB mission. Visitors are still arriving. Heavy vehicle traffic. No suspicious activity or incidents to report at the moment. Will continue to monitor. Nothing further to report. Area is secure.
- 07/07/2023 1715 arrived at cemetery conducted patrol. A resident approached and spoke for a few minutes asked about times to visit, I let him know to abide by the signs posted. Nothing further to report.
- 07/07/2023 Arrived at third st at 2325HRS to do walk through all clear no issues to report. Had Santana gallery open at 2235HRS stood by waiting for owners to come and secured the door.
- 07/08/2023 Patrolled all side streets from 0430HRS till 0530HRS all clear no issues to report. Reported a vehicle for a Ford focus license plate number 6TXH231 it had its hazards lights on for about two hours decided to check on the people in side around 0435HRS when I saw no one in side decided to call it in and report it to dispatch. Met with deputy Matt he told me there's not much to do there for he decided to leave it alone.
- 07/08/2023 2102 arrived at windmill to standby for employees to come out. 2125 all employees are gone for the night. Site is clear.
- 07/09/2023 1934HRS conducted patrol on Lang Street and there was a refrigerator outside in the sidewalk. The owner said its going to get picked up. Nothing further
- 07/11/2023 2215: patrolled through mission garden apartments. Resident parked in #10 trunk was left wide open. Did not see owner in the area. I then left a note on the vehicle stating that I shut the trunk for the owner. No other activity or incidents to report. Area is secure.

- 07/14/2023 2234: patrolled through cemetery. 2 vehicles were parked towards the back of the property. Both vehicles left the property when I shined my spotlight towards them. No other activity or incidents to report. Area is clear and secure.
- 07/15/2023 Patrolled all side streets from 0100HRS till 0310HRS as I was patrolling fourth st when I was flagged down and I was approached by a woman name Sarra she told me she found a lost dog and and she ask if I could call dispatch for Sheriff's to get them to come take the dog to a shelter I stood by with her till Sheriff's arrived about half an hour later to the call for them. Over all they took the dog to the shelter.
- 07/15/2023 Arrived at the Alameda and freeway at 0400HRS found a ladies sitting on the corner she talked to me saying she was left there alone cuz her boyfriend left her there and she said He could not find a ride. Then about 30 minutes later she said she found a ride and said its OK to call the Sheriff's of that she does not need anymore assistance..
- 07/17/2023 2342HRS conducted foot patrol at the windmill market. Room B5 was open so I secured it. The restrooms are fine.
- 07/18/2023 2136: checked on abbe park. Baseball diamond lights were on. Employee from public works notified me that he was showing Warner Bro's associates the field. No other activity or incidents to report. Area is secure.
- 07/19/2023 1913: patrolled through Hacienda Hotel. Upon arrival a Goat and Dog were on the property. Hotel manager was contacted. Manager and I tried getting the goat off the property but were unsuccessful. I was then able to make contact with the owner of the goat and dog. With the help of the owner we were able to remove both animals from the property. No other activity or incidents to report. Area is secure.
- 07/20/2023 1824: windmill market employees contacted me over the phone to inform me they were dealing with a female who was possibly stealing. When they made contact with her she became hostile. When I had arrived to windmill market employees informed me female had left in a black Toyota Corolla. A picture of the vehicle, and license plate were provided by employees upon arrival. Code enforcement was notified.
- 07/20/2023 2151: patrolled through elementary school. A black Chevy Volt is parked in the parking lot. No visual occupants. Will continue to monitor. Verified all gates are locked. No suspicious activity or incidents to report. Area is secure.
- 07/25/2023 1934HRS Conducted a patrol of Monterey st. Was informed by J.Amaya to call dispatch and ask for a wellness check on a big rig as instructed by Rich brown. Nothing further to report.
- 07/26/2023 1750: patrolled through elementary school. Unlocked basketball and pickle Ball Court gates. Pickle Ball players had forced open one of the gates. I was able to secure the forced gate. Staff is still on campus. No other activity or incidents to report at the moment. Area is secure.
- 07/26/2023 2124: patrolled through elementary school. I observed a white van lic.58786X1 parked in the dirt area by the pickle Ball Courts. According to previous observations by other guards, vehicle has been there since Sunday July 23rd. Officer Carrillo informed me he observed the driver sitting outside the vehicle in a lawn chair looking through binoculars. Deputy was notified.

- 07/27/2023 2049: patrolled through elementary school. Locked and secured basketball courts and pickle Ball Courts gates. White van reported yesterday 7/26/23 is back on school grounds with driver inside. Will continue to monitor. No other activity or incidents to report.
- 07/27/2023 1716HRS while patrolling Monterey st noticed a black Hyundai Elantra parked the wrong way.Citation was issued.
- 07/27/2023 1727HRS while patrolling 2nd st was contacted by resident Bill Adam's who lives at 705 Second St. He asked if we could keep an eye out near his property as someone had pounded on his front door with unknown intent at 0500 HRS . He contacted the sheriffs office but no one responded. Nothing further to report .
- 07/27/2023 1915HRS was informed by Josh of suspicious van that had been parked at the school since Sunday. Notified a deputy that was in town and he said he would look into it. Nothing further to report.
- 07/27/2023 2128HRS Conducted a patrol of Monterey st and noticed that they were taken the Big Rig that had been parked for a few days ok Muckelemi st. Notified Rich Brown and contacted owner per Rich's request and notified the owner that he needs to get in contact with Code Enforcement. Semi Was Loaded and left area. Nothing further to report

- 07/29/2023 1324: checked on event to make sure there were no cars parked in the no parking zone . No suspicious activity everyone was enjoying the event and activities. Witnessed an impressive display of vintage cars lined up Attracting a large crowd.
- 07/29/2023 1716 spotted a vehicle parked in crosswalk ok 2nd st. Cited vehicle and took photos
- 07/30/2023 Patrolled all side streets 0110HRS till 0230HRS all clear no issues to report.
