JUNE 2023 ACTIVITY LOG

- 06/01/2023 2258HRS conducted foot patrol at the Verutti park restrooms and someone put a sticker on the window. I took a picture and sent it to Rich. Nothing further
- 06/02/2023 1718: met with code enforcement. Discussed city enforcements.
- 06/02/2023 1824: patrolled through elementary school. Staff is still on campus. Basketball courts are occupied. Pickle Ball Courts are occupied. No other activity or incidents to report at the moment. Area is secure.
- 06/03/2023 1956HRS San Juan Bautista Elementary school: Gray Nissan 240SX looked abandoned on the parking lot. Will let next officers know about the car. Will continue to monitor.
- 06/04/2023 2154: checked on veterans hall. Verified all gates are locked. White Toyota Tacoma is parked in parking lot. No visual occupants. Will continue to monitor. No activity or incidents to report. Area is clear and secure.
- 06/04/2023 2315: patrolled through elementary school. Locked and secured gates. No activity or incidents to report. Area is clear and secure.
- 06/04/2023 2343HRS conducted foot patrol at the baseball field restrooms and inside the female restroom a door is locked. I sent a picture to Rich. Nothing further
- 06/05/2023 2233: During patrol officer Rangel informed me that the bathroom at Abbe park had been tagged. Upon arrival I observed the tagging and realized that the paint was fresh. I then took photos of the tagging and informed code enforcement. Nothing further to report. Area is clear and secure.
- 06/05/2023 0249HRS conducted foot patrol at the baseball field restrooms and there is gang related graffiti outside the men's restroom. Josh took pictures and sent them to Rich. Rich said he's going to let sheriff know. Nothing further

I was contacted by the couple after they flagged me down 30-45 mins after the cite was given. They wanted to know why I had cited only them If The other vehicle was also in the red. Female became irritated and threatened to contact my boss. I politely said goodbye and no longer spoke to her. Full chain of command was notified.
- 06/06/2023 1828: officer Valadez informed me a big rig was parked at the veterans hall. I then attempted to contact with driver. Driver then drove away. Nothing further to report.
- 06/06/2023 2228: During patrol I observed a red Jetta parked in a crosswalk on Muckelemi/San Antonio St. I then wrote a citation for the vehicle. Noticed a citation had already been written by officer Valadez. Voided my citation and continued patrol.

- 06/08/2023 2032: patrolled through SJB mission. I was waved down by a male who was asking about AA meeting. Was able to get the information about meeting. Male then left property. Nothing further to report. Area is clear and secure.
- 06/09/2023 1645: met with code enforcement. Discussed citations written for the week. Discussed vehicles running stop signs and steps to take if so. Discussed incident with vehicle that has been intimidating officers. Discussed preparations for the 4th of July shifts.
- 06/09/2023 1732HRS was asked if we had a med kit as a younger girl had gotten her hand full of thorns. Let them know we did not but contacted Rich brown and he was able to bring one to provide first aid to the girl. Stood by incase he needed assistance. Nothing further to report
- 06/09/2023 1915HRS noticed a vehicle parked on the red zone between Franklin st and second st. cited vehicle and images sent to rich brown.
- 06/10/2023 2115hrs waited for windmill market to close. Approached by mayor and asked what I was doing I let her know I was over watching closure. She began to question me as to why I was doing it so I informed her Rich brown had asked us too and she asked about the second guard that's supposed to be on duty.
- 06/12/2023 1822: patrolled through SJB mission. Mission is open. Visitors on site . During patrol of the dirt parking lot I observed graffiti on the fence toward the back area. Officer Amaya Notified code enforcement. Nothing further issues to report
- 06/12/2023 1933: officer hermida arrived on site at abbe park and came across some graffiti on the dug out cabin.
- Officer Amaya reported to the code enforcement. Also spot with residents and claimed they did not notice it from before so It had to be fresh. Keeping an eye out at the park and doing extra patrol to maybe catch the perpetrator.
- 06/12/2023 2210: patrolled through streets one through seven and all cross streets . A resident stopped the vehicle and mentioned he was tired of the fire works be lit off at night . Saying his dogs bark to much when it's happening and he can't sleep . Told the gentleman we would notify the night crew and patrol that park of SJB a little more to show presence in that area . Site secure all clear .
- 06/12/2023 2352HRS a sprinkler on third st and lavagnino Dr was shooting up to the sky and spraying all over the street. I called public works and they said they will take care of it tomorrow. I took pictures and sent them to Rich Brown's email. Nothing further
- 06/13/2023 0045HRS a street light on first st and Ahwahnee st was off. I took a picture and sent it to Josh. He said he will send the picture to Rich Brown. Nothing further
- 06/13/2023 0454HRS there was a tagging saying KSD by the baseball field. I took a picture. Nothing further
- 06/13/2023 1948: patrolled through SJB mission. Upon arrival I observed a suspicious female coming from the dirt parking lot area. Once female had visual of my vehicle she then left parking lot. Upon further observation there was nothing further to report.

Discussed about recent gang vandalism that has been occurring and possible suspects. Discussed about a resident who parks his big rig inside city limits and further procedures. - 06/16/2023 1805HRS Spotted two vehicles parked on Red curb on Franklin st. Cited both vehicles and took photos of violation.
- 06/16/2023 1939HRS spotted a green pick up parked in two spaces and parked sideways. Cited vehicle per Rich Browns request, was approached by male approximately an hour later. He asked me about why the cite was given I then informed him of why the cite was given, He then proceeded to throw the citation at me and walk away while saying " I ain't gonna appeal Expletive" and proceeded to get in pick up and leave. Nothing further to report
- 06/16/2023 2055: patrolled through windmill. Upon arrival a suspicious black male about 5'10"-6' was punching the air walking up to business doors and looking inside. He the crossed the street and went to the elementary school. Officer valadez then patrolled through Elementary school. Male then came back to windmill parking lot and is walking around taking to himself. Will continue to monitor. Windmill market employees have locked and secured front door. Pizza factory employees are closing. Deputy showed up and made contact with male. Officer valadez stood by until Pizza factory employees locked and secured front door.
- 06/18/2023 Arrived at San Juan Bautista cemetery at 2110HRS found a white car and let them know they had to leave all clear and no other issues to report.

- 06/21/2023 1758: checked on Valero gas station. Upon arrival a big rig was parked on the side of the property. I then made contact with the driver inside the Valero. Informed him that he was not allowed to park inside city limits to which he complied and left city limits. Nothing further to report. Area is secure.
- 06/21/2023 2312HRS conducted foot patrol at the Verutti park restrooms. There's paper tissue stuck on one of the restroom floors and the water fountain doesn't work. I took pictures and sent it to Rich Brown's email. Nothing further.
- 06/22/2023 2243: while leaving Valero gas station. The officers and I heard a loud crash. Patrol guards Rangel located the vehicle and driver of the crash. I made contact with driver to make sure if medical was needed. The driver said he was fine and walked to the Valero from the shoulder of the freeway. Dispatch and CHP were notified. Guards Rangel and Hernandez stood by until CHP arrived.
- 06/23/2023 0120HRS conducted foot patrol on 3rd street. All business doors were locked except for the Santana gallery and the store next to the gardens de san Juan. We called Rich and he said to stand by for someone to come. The owner showed up and locked the doors. Nothing further.
- 06/25/2023 1757HRS conducted foot patrol at the baseball field restrooms. There is a lot of graffiti in the men's restroom. I called Rich Brown and he said to take pictures and send them to his email. Nothing further.
- 06/25/2023 2257HRS conducted foot patrol on 3rd street. All business doors were locked except for the Santana gallery. I called Rich Brown and he called someone to come lock it. It's secured. Nothing further.
- 06/26/2023 01:36 the Community of Rancho Vista was patrolled, we found a bull outside the ranch outside walking through the streets until 02:25 we put it where it came from, the sheriff's arrived and they put it into the ranch.
- 06/26/2023 1728: during patrol officer Hermida and I observed a big rig hauling two trailers turning onto 2nd street. Made contact with driver and informed him he was not allowed inside city limits. Driver complied to which he followed instructions and followed patrol vehicle outside of city limits. Suspecting driver would come back into city limits we then drove back to Monterey St entrance to which we observed the driver coming back into city limits. We then pointed him back towards freeway. No citation was issued due to driver not being able to read electric street sign. (Only spoke Spanish). Nothing further to report.
- 06/27/2023 2000: patrolled through cemetery. A red pick up truck with 1 occupant was using water hose to wash vehicle. Attempted to make contact to which he drove away. Nothing further to report. Area is clear and secure.
- 06/27/2023 2120: During patrol officer Valadez and I observed a firework go off in the air. Drove towards the area and seen another go off in the air. Residents stop us to inform us the person lighting the fireworks was in a Grey Hoodie by Abbe Park dugout. Upon further observation nobody was seen lighting fireworks. Will continue to monitor.
- 06/28/2023 Had to escort 2 semis out of town at 1645HRS till 1653HRS all clear no issues to report.

FOURTH OF JULY WEEKEND 2023 ACTIVITY LOG

- 06/30/2023 1837: patrolled through SJB mission. Upon arrival I observed a branch hanging from one of the trees in the parking lot. Was not able to make contact with anyone at the mission. Code enforcement was notified.
- 06/30/2023 2054: patrolled through windmill parking lot. Customers are leaving store. Windmill market employees are closing. While standing by I observed an illegal firework go off in the air. I then went to check on area. While patrolling the area another illegal firework was set off. While patrolling 5th street The Fire Marshall of San Benito County waved officer Pacheco and I down at 300 A 5th st. Fire Marshall witnessed a 16 year old male setting off illegal fireworks. Deputies arrived to assist but then continued on with patrol. Citation was issued to the father of 16 year old without incident.
- 07/01/2023 Patrolling all side streets from 2330 till 0140HRS only issues we had was fireworks were being lit could not find the source of the issues walked all side streets all Clear no issues to report
- 07/01/2023 2346 Patrolled San Juan Mission and resident came up to me informing me that there was a mobile home whos been parked and doesn't have a permit to park there. Will talk to mobile home owner and let them know they need a permit to park or else they have to leave.
- 07/02/2023 0030 conducted foot patrol of baseball park where resident claims she seen 5 young men lighting fireworks and ran through the park. Carrillo and myself conducted foot patrol of city streets in the area of the park.
- 07/02/2023 0512 Patrolled san Juan elementary. Noticed the gate next to the basketball courts was opened. Made sure to secure. All clear.
- 07/02/2023 2030HRS we had a meeting with rich brown the code enforcer. He said if there is people popping illegal fireworks to call him as soon as possible so he can issue the citation.
- 07/02/2023 2141HRS we were searching for a small brown SUV 4runner with black tinted windows. They were driving around lighting up fireworks.
- 07/02/2023 Patrolling all side streets from 2200 till 0000HRS. Followed suspect of people using illegal fireworks 3 guys wearing all black.
- 07/03/2023 2026: met with code enforcement. Discussed preparations for the 4th of July.
- 07/03/2023 2100: patrolled through windmill parking lot. Customers are leaving store. Windmill market employees are closing. Pizza factory employees are closing. Stood by until employees locked and secured front doors. Conducted a foot patrol. Verified all business doors are locked. No activity or incidents to report. Area is clear and secure.
- 07/03/2023 2310: checked on abbe park. 1 male sitting at the bus stop(no busses running) stood by until male left the area at 2214hrs. Area is now clear and secure.
- 07/03/2023 2306HRS conducted foot patrol on 3rd street. The Santana gallery door was open. Code enforcement and store owners were notified. All other business doors were locked.
- 07/04/2023 1727: met with code enforcement at city hall. Discussed preparations for residents that set off illegal fireworks.
- 07/04/2023 2000: officer valadez informed me a resident had made contact with him and informed him that 2 bicycles were stolen from his residents on cedar. Resident gave a

description of the bicycles and two male suspects(male in red hooded sweater, male in Grey hooded sweater). I then patrolled the area of mission Vineyard, mission farm campgrounds, and Copperleaf area but did not get visual of anyone matching the description of the suspects. Will continue to monitor.

- 07/04/2023 2100: resident informed me that people were setting off fireworks in the field behind the SJB mission. Notified code enforcement. Was not able to make contact.
- 07/04/2023 2234: conducted foot patrol around 5th, 6th, and 7th Streets and abbe park. Heavy illegal firework activity. Was not able to make contact due to multiple illegal fireworks going off.
- 07/04/2023 2215HRS began driving around letting people know that no fireworks were allowed anymore. Notified 5 residents throughout muckelemi ST. Nothing further to report.
- 07/04/2023 2209 By orders of code enforcement we were told to notify residents that they would like all firework activity to be stopped by 10pm. As we were walking towards residents who were still outside they started screaming at me, they said they didn't need us in the city and got too close to me. I called over the radio that I would like backup, my first language is spanish and I feel more comfortable speaking it over the radio. The man started screaming that "this is America and speak English". The man was too intoxicated. I did not want to make the situation worse. Rich and Cecenas showed up to back us up. Eventually they got calm and we left the area (Muckelemi)
- 07/04/2023 2215- responded to yells at Muckelemi where code enforcement confronted a intoxicated male resident about getting verbally aggressive towards on of the guards on site. After Rich from code enforcement made contact with individual, he started yelling. Body cam was turned on. Situation was deescalated. All clear.
- 07/04/2023 2236HRS conducted patrol at the copperleaf community. Used fireworks were left on the middle of the road. We had to turn one off because it was on fire.
