MARCH 2023 ACTIVITY LOG

- 03/03/2023 2145: During patrol officer Valadez and I came across a red Chevrolet sedan parked in a crosswalk. Vehicle was issued a citation. No incidents to report.
- 03/05/2023 1752HRS i was driving down Monterey Street when i notice a vehicle parked in a red zone i gave this vehicle a parking ticket for city code violation 7-4-100 stopping in specified places no other issues to report. I left Monterey Street at 1811HRS
- 03/05/2023 1914HRS I was driving down THE ALAMEDA when I noticed a vehicle that had been parked longer than 72-hours, I gave this vehicle a parking warning. No other issues to report. I left THE ALAMEDA at 1931HRS
- 2024HRS I was driving down Third st when I noticed a vehicle parked in a Red zone, I gave this vehicle a parking ticket for city code violation 7-4-100 stopping in specified places. No other issues to report. I left third ST at 2042HRS
- 03/11/2023 2253HRS arrived at the school, we spotted a black Chevy pick up parked at the school. The vehicle was empty upon inspection. We searched the tennis courts, basketball court, and the playground but were unable to locate anyone.
- 3/12/2023 1716HRS arrived at Mayor Jim West Memorial Park where I gave a Black Ford C - Max a parking warning for being parked the wrong way. Left at 1726HRS
- 3/12/2023 1823HRS We noticed a Honda wrecked on The Alameda and pulled over to check on the passengers of the vehicle. Made contact with the driver " body cam was turned on". The driver stated his wife had neck and back pain. Officer Parga stayed with the wife and made sure the wife stayed in an upright in line neutral position while I went to check on the other vehicle which ended up in a ditch next to the windmill market. Fire and AMR were already on scene helping the driver of the other vehicle out of the ditch and onto a stretcher. After talking to some of the witnesses I found out that the vehicle that ended up in the ditch which was a white Ford pick up had run a red light going west down 156 when he struck the Honda. I walked back towards the other vehicle and Parga gave me the statement he had gotten from a nurse that happened to be driving by. She stated that there she was 4th in line at the stoplight and the Honda was 3rd in line, the Honda was half way through the intersection when they were hit by the Ford. The Honda ended up spinning a few times before rolling to a stop and Ford lost control and flipped a total of 5 times before landing in the ditch upside down. Fire and AMR showed up to assist with the Honda. I started doing traffic control while Parga went to take pictures of the vehicle and debris on the road, he then came to help me direct traffic. We assisted the owner of the vehicle and sheriffs pushed the Honda into San Juan Elementary. Fire and AMR had cleared the scene and we began to clear the debris as best we could. After cleaning we waited until the tow truck showed up. The tow truck arrived and sheriffs cleared the scene, we replaced them on the side of the road and turned on the lights on the patrol vehicle. We proceeded to help the tow truck driver remove the Ford

from the ditch. The vehicle wasn't able to be towed normally so the tow truck driver had to use special tools to get the Ford up. The tools ended up breaking so an extra 15 to 20 mins for a second tow truck to show up. The second truck arrived and was able to get the Ford hooked and loaded. We cleared the scene at 2120HRS. We were able to clear most of the debris on the road, get the Ford out of the ditch and the Honda was left at the elementary school waiting to be towed. 2 out of the 3 people involved in the accident were transported to the hospital.

- 03/13/2023 1707: patrolled through elementary school. Upon arrival a RV was parked at the end of the parking lot. School employee informed me that the RV belongs to a staff member and had permission to park on campus due to flood issues. Other staff members are still on campus. No other activity or incidents to report. Area is secure.
- 03/14/2023 0018-0021HRS contacted poc Richard code enforcement for a female transient sleeping outside of the Bears Hideaway. She was asked to move as asked by Richard. She left on her own with no further issues.
- 03/16/2023 1839: During patrol officer Valadez and I came across a tan Chevy S10 parked in a red zone. Vehicle was issued a citation. No incidents to report.
- 03/17/2023 0001HRS conducted foot patrol on 3rd street. daisys bar door was unlocked i contacted rich and he asked if I can secure the door. And we were able too. All other businesses are locked. Nothing further
- 03/17/2023 1926: During patrol officer valadez and I came across a grey Toyota Tacoma parked in a red curb zone. While writing the citation, the owner of the vehicle drove away. No other incidents to report.
- 03/18/2023 0130HRS we noticed a male and female arguing, Carrillo stopped to talk to the female and drove down first towards the windmill market because the Male ran down that way. We drove around trying to locate him but we were unable to. The female stopped us at the elementary school and told us that the man had an argument with a mutual friend and that she was going back to take her friend home just in case the male returned
- 03/18/2023 Started walk through at 2035HRS all clear no issues to report. Had a door open across from Dona Esther restaurant was able to secure the door. Finished walk through 2057HRS all clear.
- 03/18/2023 Arrived at first and San Jose st for San Juan Bautista community center. We got called out there for a loud noise complaint. I arrived there at 2325HRS. There were issues trying to get them to turn off the music. They were not complying with 5 guards and they said they would have it off in 20 minutes but SOS showed up and then they turned off the music so we went back inside. Left the call around 2350HRS.
- 03/18/2023 2330HRS Salinas Dispatched contacted me to help with shutting off the music at the San Juan Bautista Hall #10 where there was a party occurring. The point of contact was asked 3-4 times to turn off the music before the sheriffs would be called. An unknown person contacted the sheriffs regarding the noise complaint. Richard was contacted regarding the music not being shut off. I stood by with the guards on shift until the end of their shift due to the issues.

- 03/19/2023 0157HRS conducted a patrol of the Valero gas station there is a white Acura four door license plate #8FJW488 parked on the side of the gas station. No issues to report.
- 03/24/2023 0030HRS conducted foot patrol on 3rd street. All business doors were locked except for Daisy's bar. The door was open so I locked it and the alarm went off. I notified Rich and he told me to call dispatch. Dispatch said they will send someone.
- 03/24/2023 0201HRS officer Miller said everything was fine and the alarm will eventually shut off. Nothing further
- 03/24/2023 2017: dispatch contacted valadez and I about a resident making a noise complaint about a neighbor. Drove to the residents address and contacted them through phone call. Neighbor had stopped the noise at the moment. Will continue to monitor. Nothing further to report.
- 03/25/2023 2034HRS saw the fireplace for 53 Mukelemi st going off. Looked around the property for signs of a fire but none were found and shortly after the alarm silenced. San Benito Dispatch and Rich Brown were notified and the fire department were informed of the happenings. Nothing further to report
- 03/25/2023 2334HRS arrived on 3rd St to do the walk through, had to call dispatch so a possible domestic, separate report was made for the incident. We called Rich because we noticed a level one guard driving down Third St. He let us know that the guard wasn't allowed to be doing that. We stopped the guard to let him know he wasn't allowed to be driving down Third Street in his vehicle.
- 03/25/2023 2358HRS We heard a loud bang on 3rd St and Washington St. We went to investigate and found the source of the noise. There was yelling from a male and female as well as objects being thrown. Carrillo called Rich while I called dispatch. I notified dispatch at 0005HRS that the yelling was coming from an apartment above the plaza market. I called again at 0021HRS because we heard the yelling increase in volume and heard the female yell out. 2 sheriffs arrived about 5 minutes later and made contact with the residents of the apartment. The male allowed one of them to go in and look around while the other stayed outside to talk with him. They were up there for about 5 minutes before the sheriffs came back and told us they didn't see anything out of the ordinary. After they left we called Rich again to let him know we were code 4.
- 03/26/2023 0955HRS i was driving down Washington St when i notice to vehicles that were parked in a red zone i gave both vehicles a ticket for city code violation 7-4-100 stopping in specified places. No other issues to report i left Washington ST 1014HRS
- 03/26/2023 1017HRS I was driving down Washington when I notice a vehicle parked in a red zone on seventh ST I gave this vehicle a parking ticket for city code violation 7-4-100 stopping in specified places. I left seventh ST at 1028HRS
