- 09/01/2023 2250 Third street was patrolled, doors were locked, only issue to report is a check of GG's Cafe check was found and picked up. Took to the patrol office.
- 09/02/2023 Arrived at Rancho Vista Community at 1950HRS there was kids lighting fire crackers some where in the hills out side of Rancho Vista Community beside that all clear no issues to report.
- 09/02/2023 2240 the doors on third street were patrolled and checked 2257 a passenger bus arrived and parked in the middle of the street, I let the driver know he could not park there. Most of the passengers got off to go to the bar. I kept on signaling he had to move. Eventually they left.
