CALL TO ORDER

The San Miguel County Board of Commissioners held its regular monthly meeting on Tuesday December 12, 2017, beginning at 2:00 p.m. The meeting convened at the San Miguel Administration Complex located at 500 West National Avenue, Suite 200, New Mexico 87701.

Commissioners, staff and citizens in attendance joined in the pledge and salute.

APPROVAL OF AGENDA

Motion made by Vice-Chairman Arthur Padilla to move Item #4 to Item #1. Second by Commissioner Chris Najar. Motion carried.

APPROVAL OF MINUTES

Motion made by Commissioner Chris Najar to approve the minutes of the June 13, 2017 Regular meeting as a result of an error on the date. Second by Commissioner Maria Martinez. Motion carried.

PUBLIC INPUT FORUM

Manuel Garcia- Voiced concerns on County Road issues that yet need addressing.

Salvador Higgins-Voiced issues and concerns in regards to Fracking and discussed religious issues.

John Olivas- Voiced the updated issues in regards to the Sabinoso Wilderness.

NEW BUSINESS

PRESENTATION: INDUSTRIAL HEMP VENTURES
Presenter: Mikki Anaya

Mikki Anaya Industrial Hemp Volunteer informed the Commission that Industrial Hemp is not marijuana. On July 28, 2017 Industrial Hemp Farming Act of 2017 was introduced. Hemp is defined as having less than 0.3 percent Psychoactive THC from the controlled substance Act and now recognizes Industrial Hemp as an agricultural commodity not a drug.

REGULAR ORDER

1. 2018 FAIR MARKET RENTS (FARMER'S) AND UTILITY ALLOWANCES FOR SAN MIGUEL COUNTY

San Miguel County Acting Housing Authority Betty Valdez informed the Commission they are working with the 2018 Fair Market Rents and Utility Allowances for San Miguel County Section 8 program participants. Ms. Valdez informed the Commission when a revision of utility allowance schedules is updated, SMCHA board of County Commission approve the changes. Ms. Valdez requested the Commission approve the 2018 Fair Market Rents and Utility allowances for San Miguel County.

2. YEAROUT ENERGY SERVICE

YearOut Energy Services Senior Sales Executive Scott Griffith informed the Commission they are a company that works under the State Efficiency the Water Conservation Act. Mr. Griffith stated that Yearout Energy Service works with helping communities get funding and Energy Audits completed so the community could be more energy efficient. Yearout Energy Service is a process called Energy Performance Contracting to create this process that will not cost the County any money. Mr. Griffith requested the Commission approval to allow Yearout Energy Service Company to provide a no cost, no obligation audit.

Motion made by Commissioner Janice Varela to approve the Yearout Energy Service no cost no obligation audit pending the County Attorney's approval. Second by Commissioner Chris Najar. Motion carried.

3. 2017 POVERTY SUMMIT & FALL BOARD MEETING

San Miguel County Chairman Rock Ulibarri informed the Commission he recently attended the 2017 Poverty Summit & Fall Board Meeting in Fort Worth Texas. At this meeting the nation poverty was discussed. The average poverty level nationwide is 21 percent. For some reason San Miguel County poverty rate for children under the age of 5 years has increased in less than 10 years by 56 percent. Mr. Ulibarri informed the Commission that this is a major crisis that only the policy makers can solve. Mr. Ulibarri informed the Commission that on February 18, 2018 a Poverty Summit meeting will take place at the United World College in Montezuma NM with the State Senate to address working at breaking the cycle poverty in our County.

Luna Community College President Ricky Serna informed the Commission that Luna Community College is in the process of developing a Show Call Order Report which will establish policies and procedures that will address a number of concerns. The Higher Learning Commission has pointed out that LCC is looking

forward to working with San Miguel County. Mr. Serna requested the Commission approve the Resolution No. 12-12-2017-CM1 in support of LCC.

Motion made by Vice-Chairman Arthur Padilla to approve Resolution No. 12-12-2017-CM1. Second by Commissioner Maria Martinez, Motion carried.

5. RESOLUTION NO. 12-12-2017-CM2 ENDORSING INDUSTRIAL HEMP RESEARCH AND DEVELOPMENT IN SAN MIGUEL COUNTY

San Miguel County Commissioner Janice Varela informed the Commission she is looking forward to improving the Economic situation in our County. It is estimated that there are over 25,000 Hemp products used in the US. In 2016, 688 million Hemp base products were sold in the US. Right now there are 33 states that allow the Hemp Law in their books, with New Mexico hoisted into joining up with the other 33 states. Ms. Varela stated that she is hoping San Miguel County endorses the research and development of the Hemp Research. Ms. Varela requested the Commission approve the Resolution No. 12-12-2017-CM2 endorsing Industrial Hemp Research and Development in San Miguel County.

6. ORDINANCE NO. 06-13-2017 ESTABLISHING A CODE OF CONDUCT AND ETHICS-UPDATE

San Miguel County Manager Vidal Martinez informed the Commission in June 13, 2017, the proposed ordinance was tabled for legal review. The following now will take place. (1) Dave Romero will review the proposal. (2) Dina Holcomb, Union Lawyer will also review proposal, seek union input, and approval. (3) San Miguel County will create employee committee to review proposal and make recommendations. (4) San Miguel County will submit for public hearing. (5) The committee currently reviewing the personnel ordinance will review the Code of Conduct and Ethics proposal for commonality or duplication.

10. AWARD OF ENGEERING SERVICES AS-NEEDED

San Miguel County Planning and Zoning Supervisor Alex Tafoya presented to Commission San Miguel County proposals in response to RFP. No. 2017-PZ Engineering Services as needed. Evaluation of the proposals was conducted by a committee that worked independently of each other. The committee then met and determined the five companies that submitted proposals should be interviewed. Interviews were conducted and the evaluation scores were reviewed. The committee is recommending that two companies be selected for award of contract for engineering services as needed. Mr. Tafoya requested the Commission authorize County Manager and staff to enter into contract negotiations with Miller Engineering and Souder Miller and Associates for engineering services as needed.

11. AGREEMENT BY AND BETWEEN SAN MIGUEL COUNTY, NEW MEXICO AND TAOS COUNTY, NEW MEXICO FOR CONFINEMENT OF TAOS COUNTY PRISONERS AT THE SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Warden Matthew A. Elwell presented to Commission an agreement between San Miguel County, New Mexico and Taos County New Mexico for the confinement of Taos County prisoners at the San Miguel County Detention Center, this agreement is being presented for San Miguel County Commission review and approval. The cost per day to house a prisoner is ninety dollars, along with twenty dollar booking fee. Mr. Elwell requested the Commission review and approval the agreement between San Miguel County and Taos County.

San Miguel County Warden Matthew A. Elwell presented to Commission an agreement for Juvenile Detention, for housing and care of San Miguel County Juvenile Detainees at the Taos County Juvenile Detention Center, this agreement is being presented for San Miguel County Commission review and approval. The cost per day for each Juvenile detained is \$130 plus \$10 booking fee. Mr. Elwell requested the Commission review and approval 1st Extension Agreement for Juvenile Detention between San Miguel County and Taos County.

Motion made by Commissioner Maria Martinez to review and approve the Juvenile Detention agreement between Taos County and San Miguel County. Second by Commissioner Janice Varela. Motion carried.

13. AGREEMENT BY AND BETWEEN SAN MIGUEL COUNTY, NEW MEXICO AND MORA COUNTY, NEW MEXICO, FOR CONFINEMENT OF MORA COUNTY PRISONERS AT THE SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Warden Matthew A. Elwell informed the Commission an agreement by and between San Miguel County and Mora County for the confinement of Mora County prisoners at the San Miguel County Detention Center is presented to the Commission for review and approval. The cost per day to house a prisoner is ninety dollars along with a twenty dollar booking fee. Mr. Elwell requested the Commission review and approve agreement by and between San Miguel County and Mora County for confinement of Mora County prisoners at the San Miguel County Detention Center.

Mr. Madrid advised the Commission the lowest qualified bidder for the 2017 Revenue Bond Roadway and Drainage Improvement Project in Los Vigils with approval will be awarded to Rocky Road Gravel and Well Drilling LLC. Mr. Madrid requested the Commission approve awarding the bid to Rocky Road Gravel and Well Drilling LLC.

San Miguel County IT Supervisor Diego Trujillo informed the Commission that during a routine audit San Miguel County addressing data, it was discovered that there are three (3) addressed structures on a single road located off NM Highway 266 between Las Tusas and San Ignacio, New Mexico which is causing an addressing problem as per San Miguel County Ordinance No. SMC-07-13-99-ORD-2, Section 4.1-C. Letters were sent out to the residents on November 8, 2017 informing them of San Miguel County's intent to name the road. All three residents returned a road naming petition agreeing to the name of "Sweet Pea Ln." The new road name has been determined to be acceptable by SMC Rural Addressing staff per San Miguel County Ordinance No SMC-07-13-99-ORD-2. The \$100 fee has been waived because the road name was required and not requested in order to promote the health, safety and welfare of the public. Mr. Trujillo requested the Commission review and approve Resolution No. 12-12-17-RA01 addition of "Sweet Pea Ln." a newly named private road.
