NEW BUSINESS

PRESENTATION: Opioid Law Suit

Presenter: New Mexico Attorneys Cid Lopez, Tim Chelpaty, and Felisha Weingarten

New Mexico Attorney Cid Lopez presented to the Commission the rising Opioid problem which is occurring in Our Country, but stated that they were here to focus on SMC problem. SMC is the 2nd highest in the state for Opioid death rate this past year. SMC is above the national average of Opioid abuse in the Country. Cid Lopez presented the litigation team of New Mexico Attorneys which each introduced themselves to the Board of County Commissioners, Tim Chelpaty, Ray Vargas, and Felisha Weingarten. Mr. Lopez informed the Commission that they are very much aware of SMC problem and are hoping they are given the opportunity to represent SMC.

REGULAR ORDER

1. ELECTION OF CHAIRMAN AND VICE-CHAIRMAN OF THE SAN MIGUEL COUNTY BOARD OF COMMISSIONERS

San Miguel County Chairman Rock Ulibarri informed the Commission the election of Chairman and Vice-Chairman according to Section 4-38-10, NMSA 1978, requires that at the first meeting of each year, the Board of County Commissioners select a Chairman and Vice-Chairman.

Motion made by Commissioner Maria Martinez to appoint Commissioner Chris Najar as Chairman. Second by Vice-Chairman Arthur Padilla. Motion carried.

Motion made by Vice-Chairman Arthur Padilla to appoint Commissioner Janice Varela to Vice-Chairman. Second by Commissioner Rock Ulibarri. Motion carried.

2. ADOPTION OF OPEN MEETING ACT RESOLUTION FOR 2018

San Miguel County Attorney Dave Romero informed the Commission of Section 10-15-1 of the New Mexico Open Meetings Act, NMSA 1978. This Act requires that each year the County Commission adopt a Resolution setting forth the date and time of the Commission Meetings and notice requirements for all meetings. Mr. Romero requested County Commission meetings be held the 2nd Tuesday of each month at 2:00 p.m.

Motion made by Commissioner Arthur Padilla to adopt the Open Meetings Resolution for 2018 as required by law. Second by Commissioner Rock Ulibarri. Motion carried.

3. MANAGER'S REPORT

San Miguel County Manager Vidal Martinez informed the Commission he had several items he would be going over with the Commission. (1) The County has received a discussion in order from the State of New Mexico Alcohol & Game Division in the matter of the transfer of liquor license from Western Refinery Retail to Romeroville Gas Station. (2) Several meetings have taken place with our state delegates to discuss the Legislative Capital Outlay. The County is requesting 3.2 million dollars from the legislation. (3) NM Association of Counties is scheduled to take place the week of the 15th of January. The County will also be conducting a 40 hour mediation class consisting of 20 employees and Supervisors. These classes will take place this Thursday, January 11 thru the 13th and continuing on the 18th and 19th of this month. Each individual attending the mediation classes will receive a certification at the end of the course.

(4) Mr. Martinez informed the Commission that he met with the Warden to go over the Model in Mesa County. Mr. Martinez informed the Commission Commissioner Ulibarri has conducted research on this and will be going over his finding at next month's meeting in February. (5) Mr. Martinez along with the road department met with Steve Copeland & Association along with Mr. Trujillo the lawyer for the association to discuss road abandonment. (6) Budget Hearings are being conducted by Melinda Gonzales Finance Supervisor and himself (Mr. Martinez) starting January 8, 2018 thru January 22, 2018. The reason for the Budget Hearings is to go over the mid-year budget to see what needs to be done to finish up the year. (7) The County has set up a committee to go over the Ethnic Ordinance. A copy of the ordinance has been given to San Miguel County Attorney Dave Romero and Dina Holcomb the County's Union Lawyer to review. (8) Mr. Martinez had a meeting with EDC concerning the contract, and went over the deliverables with Michael Adams and President Joe Stineber. Mr. Martinez informed the Commission more will be discussed in executive session. (9) Mr. Martinez informed the Commission the last item of discussion, he, Melinda Gonzales and Dawn Kryder met with Representatives from Yesco concerning Energy Efficiency to go over how the County can reduce the utility bills.

4. SAN MIGUEL COUNTY HOSPITAL UPDATE

San Miguel County Commissioner Rock Ulibarri gave an update to the Commission looking into the possibility of building a County hospital. Mr. Ulibarri informed the Commission there are over 900 homes within the San Miguel County area that have liens on them with Alta Vista Hospital, also Alta Vista has the highest rates in New Mexico. County Attorney Dave Romero will be working with Sandoval and Rio Arriba Counties to get perspective on their establishment of a County Hospital.

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission at the last meeting County staff was authorized to enter into agreement with Souder Miller and Associates. At this time County staff is still negotiating contract with Souder Miller and Associates and feel that Souder Miller and Associates has not given their best offer yet. Mr. Tafoya requested the Commission table this item till next month's meeting in February.

7. APPROVAL OF ENGINEERING SERVICES AS-NEEDED-MILLER ENGINEERING

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission at the January Commissioners meeting authorization was given to County staff to enter into agreement with Miller Engineering for as-needed engineering services. Mr. Tafoya requested the Commission approve the agreement between San Miguel County and Miller Engineering.

The Detention Center will inspect the living quarters of the jail and also show the Commission where they have been and where they will be going this year. Mr. Elwell informed the Commission that they will be inviting the public to attend as well.
