REGULAR ORDER

1. MILL TAX LEVY 2019 PROPERTY TAX RATES

San Miguel County Assessor Connie Gallegos informed the Commission on the Mill Tax Levy 2019 Property Tax Rates. The rates have been received and there were a couple of changes. Ms. Connie Gallegos informed the Commission the districts that have gone up are school districts 1 & 2. There also were some decreases in the non-residential and also District 21 & 50. Ms. Connie Gallegos requested approval for the Mill Tax Levy 2019 Property Tax Rates.

San Miguel County Finance Supervisor Melinda Gonzales gave a brief summary on how the Mill Tax Levy and property tax rates work. Ms. Melinda Gonzales informed the

Commission that based on and tax rates we are able to tell if our tax revenue will go up for the following year. So it seems there is an estimate of \$234,000 more in property tax then what was initially expected.



Adjournment


Motion made by Commissioner Harold Garcia to adjourn the meeting at 3:46 p.m. Second by Commissioner Janice Varela. Motion carried.



District 4




Vice-Chairman, Harold M. Garcia
District 1



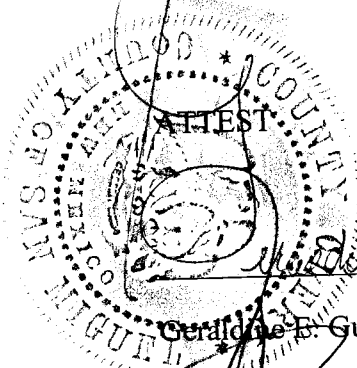
Commissioner, Max O. Trujillo
District 3




Commissioner, Chris A. Najar
District 5


