CALL TO ORDER

The San Miguel County Board of Commissioners held its regular monthly meeting on Tuesday, October 13th, 2015, beginning at 2:00 p.m. The meeting convened at the County Commission Chambers, San Miguel County Courthouse, 2nd floor, 500 West National Ave., Suite 200, Las Vegas, New Mexico 87701.

ROLL CALL

Upon a call of the roll, Chairman Arthur J. Padilla, Vice-Chairman Gilbert Sena and Commissioners Rock G. Ulibarri, Marcellino A. Ortiz and Nicolas T. Leger were present, and a quorum was duly noted by Chairman Arthur J. Padilla.

Joined by staff and all in attendance, the Commissioners pledged allegiance to the U.S. flag and offered their salutation to the NM state flag.

APPROVAL OF AGENDA

San Miguel County Manager Les Montoya notified Chairman Arthur Padilla that San Miguel County Finance Division Supervisor Melinda Gonzales was not present for the beginning of the meeting due to meeting with the auditors and that Item 38 would have an additional transfer of funds for a road construction project.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, and the changing of the agenda was approved unanimously.

NEW BUSINESS

Commissioner Gilbert Sena presented San Miguel County Veteran Sergio P. Abila with a plaque for his hard work and dedication shown for his country.

Commissioner Nicolas Leger presented to the Commission New Mexico Highlands University President Dr. Sam Minner, Jr., the newly hired president for NMHU. Dr. Sam Minner, Jr. told the Commission it is a great pleasure and an honor to serve NMHU and reside within the city of Las Vegas and the County of San Miguel. Dr. Sam Minner, Jr. said he is here to serve NMHU and

the city of Las Vegas and the region. Dr. Minner's goals are to grow the involvement at NMHU, more opportunities for students, the city, and the state of New Mexico.

San Miguel County Sheriff Gary Gold commended Deputy Sheriff Darin Romero. Deputy Sheriff Darin Romero has proven to be a dedicated public servant and shown a level of professionalism worthy of the promotion to Sergeant. Newly appointed Sergeant Darin Romero thanked County Sheriff Gary Gold, Under-Sheriff Anthony Madrid, the Commission and the County Manager for the opportunity and stated he looks forward to better serving San Miguel County.

San Miguel County Planning and Zoning Division Supervisor Alex Tafoya presented Kenneth Alcon who is the District Conservationist for the Natural Resources Conservation Service. Kenneth Alcon is the District Conservationist for Colfax, Mora and San Miguel County. The Natural Resource Conservation Service was established to assist ranchers and farmers deal with any of the natural resource issues they may have, such as forest thinning and brush control and is available for assistance to help anyone who meets the criteria.

Annette Velarde, who is the City of Las Vegas Even Planner/Film Liaison, presented to the Commission the plans and events for the upcoming Las Vegas Day at the Legislature.

AT 3:45 P.M., THE COMMISSION PROCEEDED

TO REGULAR ORDER, AS FOLLOWS:

ITEM 1: RESOLUTION NO. 10-13-2015-SO-SAN MIGUEL COUNTY ANIMAL CONTROL ORDINANCES

The San Miguel County Sheriff's office had been working to revise the existing County Animal Ordinance. The revisions had been reviewed by County Legal and local animal care providers. The ordinance revisions that were included constitute the proposed final draft for review by the Commission.

Commissioner Rock Ulibarri asked San Miguel County Sheriff Gary Gold if the Ordinance included all the concerns recently that constituents have come forth informing the Commission. Sheriff Gary Gold replied yes, he believes it is one of the best ordinances he has seen from a legal standpoint.

Chairman Arthur Padilla asked Sheriff Gary Gold if the Ordinance contains reprimands for citations given to the public in which Sheriff Gary Gold answered yes.

San Miguel County Manager Les Montoya included that the Ordinance sets up the law to enforce the Animal Control issues within San Miguel County. A result of what the Ordinance contains, the County Sheriff's Division compliance and enforcement of the Ordinance, it will

require some operational changes as well. These operational changes will come in the form of additional expenses for the management and enforcement of the Ordinance.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Leger, the adoption of the resolution was approved unanimously.

ITEM 2: RESOLUTION NUMBER 10-13-2015-CLERK- DESIGNATING POLLING PLACES

San Miguel County Clerk Geraldine Gutierrez presented to the Commission a resolution designating the polling places for the 2016 Primary and General Elections.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, the adoption of the resolution was approved unanimously.

ITEM 3: RESOLUTION NO. 10-13-15-RA01; ADDITION OF CAMINO DE VIDA, A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

A taxpayer submitted a Road Name Petition to name a private driveway located off of County Road A-11-E North of Las Vegas. While there are no buildings on this road, San Miguel County Ordinance No. SMC-07-13-99-OED-2 states, "Any private road that provides access to less than three buildings may be named for a fee according to Section 4.3." The San Miguel County Rural Addressing Staff confirmed the payment was made, and that the proposed road name is in compliance with San Miguel County Ordinance No. SMC-07-13-99-OED-2.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the adoption of the resolution was approved unanimously.

ITEM 4: RESOLUTION NO. 10-13-15-RA02; ADDITION OF CAMINO ANGELES, A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

A taxpayer submitted a Road Name Petition to name a private driveway located off of Frontage Road 2116 near the community of Blanchard. While there are only two addressed buildings on this road, San Miguel County Ordinance No. SMC-07-13-99-OED-2 states, "Any private road that provides access to less than three buildings may be named for a fee according to section 4.3." The San Miguel County Rural Addressing Staff confirmed the payment made, and that the proposed road name is in compliance with San Miguel County Ordinance No. SMC-07-13-99-OED-2.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, the adoption of the resolution was approved unanimously.

ITEM 5: ACCEPTANCE OF THE FY15 EMERGENCY MANAGEMENT PERFORMANCE GRANT

The San Miguel County/City of Las Vegas Office of Emergency Management requested acceptance of the FY15 Emergency Management Performance Grant in the amount of \$79,134.76 toward the salary and benefits for the Emergency Manager, NIMS Coordinator and the OEM Administrative Assistant positions.

Upon a motion by Commissioner Ortiz, and the second by Commissioner Sena, the approval of the grant was approved unanimously.

ITEM 6: STATUS UPDATES AND REVISIONS TO COUNTY ROAD LOG

The San Miguel County IT/Rural Addressing department had undertaken the project of revising and modernizing the San Miguel County Road Log. The project is progressing, but at a slow pace. The final product will be a much more accurate and descriptive County Road Log. The new updates include much more detailed descriptions, GPS coordinates for road starting and ending points, and improved road lengths.

Commissioner Marcellino Ortiz asked County Manager Les Montoya if the County Staff can add a page to the Monthly Public Service Road Improvement Report to provide information on the amount of funds spent on County Roads. County Manager Les Montoya informed Commissioner Ortiz the County has records of every dime spent on every County Road and this information can be provided monthly.

Chairman Arthur Padilla asked County Manager Les Montoya to explain the reason for the update and revision of the County Road Log. County Manager Les Montoya informed the public the Department of Transportation requires the County to submit its Road Log every year. Another issue that has come forth is there are roads on the County Road Log that are not being maintained and roads that are not on the County Road Log that are receiving maintenance as County Roads.

This item was for informational purposes only.

ITEM 7: CARE OF PRISONER(S) 3RD RENEWAL AGREEMENT-COLFAX COUNTY, NEW MEXICO AND SAN MIGUEL COUNTY, NEW MEXICO

San Miguel County Warden Patrick Snedeker presented to the Commission the 3rd renewal agreement between Colfax County and San Miguel County. The agreement provides housing and care of Colfax County adult inmates at the San Miguel County Detention Center. The cost of housing is eighty dollars (\$80.00) per day per inmate, with a twenty dollar (\$20.00) booking fee.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Ortiz, the approval of the renewal agreement was approved unanimously.

ITEM 8: UNIVERSAL ADCOM DISTRIBUTION AGREEMENT (SMSO MAGNETS)

The San Miguel County Sheriff's Office requested review of the Universal AdCom Distribution Agreement, in which the community is provided with San Miguel County Sheriff's Office Magnet Calendars. Local businesses can purchase a spot on the magnet to advertise their goods and services. The revenue generated from the sales will be used to help reach the community and talk to them about crimes within the County.

Commissioner Leger expressed his concerns with this form of advertisement.

San Miguel County Legal Counsel advised the Commission to make it part of the record that the Commission is not requesting the public to participate.

No action was required on this item.

ITEM 9: 1ST EXTENSION AGREEMENT CONTRACT-CARE OF PRISONER(S) CONTRACT-CITY OF LAS VEGAS, NEW MEXICO AND SAN MIGUEL COUNTY, NEW MEXICO

The 1st Extension Agreement between the City of Las Vegas and San Miguel County for providing housing and care for City of Las Vegas Municipal Court adult arrestees at the San Miguel County Detention Center was presented to the Commission for review and approval. The cost of housing is eighty (\$80.00) per day/per inmate.

Upon a motion by Commissioner Ulibarri, and a second by Ortiz, the approval of the Extension Agreement was approved unanimously.

ITEM 10: AWARD OF BID FOR THE 2014-2015 LGRF COOP PROJECT FOR LOS ALAMITOS A-6

The San Miguel County Public Service Division recently advertised for bids for the 2014-2015 LGRF Cooperative Project in San Miguel County, specifically County Road A-6 (Los Alamitos). Bids were scheduled for opening on Thursday, October 8th, 2015, after which time County Staff makes a recommendation to award the bid to the lowest most qualified bidder. The lowest bidder was Rocky Road Gravel Products in the amount of \$108,619.50.

San Miguel County Manager Les Montoya requested the motion be made with the contingency of the budget adjustment in Item 38.

Upon a motion by Commissioner Leger, and a second by Commissioner Sena, the approval of the bid award was approved unanimously.

San Miguel County Manager Les Montoya explained to the Commission as to why the County was able to work on County Road A-6 this year as opposed to next year. San Miguel County received LGRF for the Fiscal Year 15/16 for the Los Alamitos Road. San Miguel County has an ongoing project currently in the Tecolotito area for the Fiscal Year 14/15. San Miguel County came across some easement and acquisition cost associated with that project that wouldn't allow completion of the project by December 31st, 2015. Rather than not completing the 14/15 Local Government project this fiscal year by December 31st, 2015, San Miguel County Manager Les Montoya inquired of Commissioner Sena and Commissioner Padilla if it would be ok to switch the funding for the two projects. This would allow the Los Alamitos Road to be completed before December 31st, 2015.

ITEM 11: RIVER STEWARDSHIP PROGRAM IMPROVEMENT PROJECTS AGREEMENT

The Hermits Peak Watershed Alliance obtained notice to proceed to conduct a project called Gallinas Village River and Floodplain Restoration. The project will restore a 1/3 mile stretch of river and its associated flood plain in order to improve water quality and water quantity, buffer river flows from droughts and floods, and improve fish and wildlife habitat.

Commissioner Leger stated that in the agreement it says the owner being San Miguel County. Commissioner Leger asked San Miguel County Fire Chief Russell Pacheco if the County was the owner of the property in which Fire Chief Russel Pacheco answered San Miguel County leases the property from the City of Las Vegas.

Discussion ensued with Legal Counsel advising the Commission.

Upon a motion by Commissioner Leger to table the item pending approval by the City of Las Vegas to proceed with the project given the terms of the lease, Commissioner Ortiz seconded, and the motion to table the item was approved unanimously.

ITEM 12: MAINTENANCE/WORKSHOP BUILDING-SAN MIGUEL COUNTY DETENTION CENTER-AWARD FOR REMODEL/CONSTRUCTION PROJECT-NORTHEASTERN CONSTRUCTION

On May 12th, 2015, the Board of County Commissioners took action to reject bids received for the maintenance/workshop building remodel project at the Detention Center. A new invitation for bids was requested. The Board of County Commissioners took action on August 11th, 2015 to reject those bids. Consistent with NMSA 13-1-131, the construction was solicited in the open market to the lowest bidder. NorthEastern Construction has submitted the lowest bid at \$60,972.64, including tax. Funds are available for the completion of the project.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the approval for the bid award was approved unanimously.

ITEM 13: ADDENDUM TO AGREEMENT BETWEEN COUNTY AND SOLEIL WEST ARCHITECTURAL SERVICES ON AN AS NEEDED BASIS

San Miguel County has an agreement with Soleil West for architectural services as-needed for a one (1) year term that can be extended annually not to exceed four (4) years. Soleil West indicated they wish to extend the agreement for a third year.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the addendum was approved unanimously.

ITEM 14: 3RD RENEWAL AGREEMENT-INMATE HEALTH CARE SERVICES/HEALTH CARE MANAGEMENT SERVICES AT THE SAN MIGUEL COUNTY DETENTION CENTER. THE AGREEMENT PROVIDES FOR THE HEALTH SERVICES TO THE DETAINEES OF THE SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Detention Center Warden Patrick Snedeker presented to the Commission the 3rd Renewal Agreement between Health Care Partner's Foundation, Inc. and the San Miguel County Detention Center.

Commissioner Leger asked Mr. Snedeker if this agreement was the last of the renewals of the underlining contract. Mr. Snedeker then answered yes it was the 3rd renewal and in one (1) years' time, the County will bid for services. Commissioner Leger then asked if Legal Counsel has reviewed the agreement in which Mr. Snedeker answered yes, legal has reviewed the agreement.

Upon a motion by Commissioner Leger, and a second by Commissioner Sena, the approval of the agreement was approved unanimously.

ITEM 15: ADDENDUM TO AGREEMENT-LEE GAMELSKY & ASSOCIATES ARCHITECTURAL SERVICES ON AN AS NEEDED BASIS

The professional services agreement between San Miguel County and Lee Gamelsky & Associates is for a one year term that may be extended each year, not to exceed four years total. Lee Gamelsky & Associates indicated they wished to extend the agreement for a third year.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Leger, the addendum was approved unanimously.

ITEM 16: HERO PRESS 2016 CALENDAR PROGRAM (SMSO CALENDAR)

San Miguel County Sheriff Gary Gold presented to the Commission the advertisement in conjunction with Item 8.

No action was taken on this item.

ITEM 17: REQUEST FOR PROPOSALS FOR BROADCASTING OF SAN MIGUEL COUNTY COMMISSION MEETINGS

During the Regular Meeting of the Board of County Commissioners held September 8th, 2015, the Commission was presented with information regarding the cost of broadcasting Commission meetings on the radio. Given that information, the board made the decision to proceed with the procurement process for these services.

Commissioner Sena asked San Miguel County IT Supervisor John Tiernan if there were any other radio stations within Las Vegas other than the two that had shown interest thus far. IT Supervisor John Tiernan answered Commissioner Sena there is the Highlands radio station and a Christian radio station that also airs audio, as well as Comcast but has no interest in the proposal.

Commissioner Ortiz asked IT Supervisor John Tiernan if there was any type of survey that the County would be able to conduct to see if the public has any interest in hearing live meetings over the radio. IT Supervisor was not aware of any study that could be done but the County Manager Les Montoya notified the Commission a survey is a possibility.

Commissioner Leger requested the Commission to instruct staff to pursue finding means in which to see if the public has any interest in listening broadcasted County Commissioners Meeting over the radio.

Commissioner Ulibarri asked County Manager Les Montoya how many RFP's are put out a year and how many are approved by the Commission, in which Count Manager Les Montoya replied 10-15 RFP's are put out a year and most if not all are approved by the Commission prior to advertising.

Discussion ensued.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Sena, the approval to advertise request for proposals was approved by majority vote.

ITEM 18: ELECTRIC AND ACCESS EASEMENTS PUBLIC SERVICE COMPANY OF NEW MEXICO/WOOD BUSINESS PARK

At the September 8th, 2015 Commission meeting, the Board of County Commissioners voted to table the approval of easements requested by PNM for access through the Wood Business Park for a proposed solar facility until such time that language in the easement documents could be addressed. The County, PNM representatives and the County Attorney have agreed on the language of concern.

Commissioner Leger suggested Legal Counsel to explain the process, the language and the amendments to the easement. Legal Counsel stated they met with PNM and proposed different wording within the easement and PNM accepted the amendments.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the approval of the easement was approved unanimously.

ITEM 19: RECOMMENDATION TO AWARD \$75,000.00 OF ECONOMIC DEVELOPMENT FUNDS TO NON-PROFIT ENTITIES WHO WILL PERFORM ECONOMIC DEVELOPMENT SERVICES FOR SAN MIGUEL COUNTY

Local Gross Receipt Tax revenues were set aside by the San Miguel County Board of County Commissioners in the amount of \$75,000.00 in an attempt to improve upon the economic standing of the County. The scope of work identified by the County includes efforts to expand existing businesses, recruit new businesses, create new jobs, train the local work force to promote San Miguel County as a location to live and work as well as implement the San Miguel County Economic Development Strategic Plan and facilitate the San Miguel County Collaborative to develop collaboration of all members on all existing and future San Miguel County Economic Development initiatives and to manage the Wood Business Park. San Miguel County Manager Les Montoya informed the Commission \$10,000 was set aside for Main Street de Las Vegas, \$40,000 for the purpose of expanding existing businesses, recruit new businesses, create new jobs and train the local workforce to promote San Miguel County as a place to work and live, \$20,000 for the Center of Southwest Culture to work specifically with Agriculture Committee identified in the strategic plan for San Miguel County, and \$5,000 to be used for other Economic Development initiatives that come forth to San Miguel County within the present Fiscal Year.

Commissioner Ulibarri asked County Manager Les Montoya if the County ever asked for a report of how successful the funds given were for the entities. County Manager Les Montoya stated if the recommendation gets approval then the County will turn it into a funding

agreement. As the year progresses, the agency will submit their work as to what has been accomplished and the amount of funding they requested compensated for.

Commissioner Leger expressed his concerns with dispersing funds to multiple entities.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Ortiz, the approval of the award was approved by majority vote with opposition by Commissioner Leger.

ITEM 20: 3RD RENEWAL AGREEMENT-BY AND BETWEEN JUSTICE SOFTWARE, INC. AND THE SAN MIGUEL COUNTY DETENTION CENTER FOR AN AUTOMATED INMATE JAIL MANAGEMENT SYSTEM/B.O.S.S. SOFTWARE SYSTEM, AT THE SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Detention Center Warden Patrick Snedeker presented to the Commission the 3rd Renewal Agreement for the provision of an Inmate Jail Management System/B.O.S.S. Software System between Justice Software Inc. and the San Miguel County Detention Center.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Ulibarri, the approval of the renewal agreement was approved unanimously.

ITEM 21: SIERRA 4 CONSULTING CONTRACT FOR MANAGEMENT OF MILITARY SURPLUS EQUIPMENT (10-33 PROGRAM)

San Miguel County Sheriff Gary Gold informed the Commission of the 10-33 Program in which it is a program to purchase pre-owned law enforcement equipment. Sheriff Gary Gold persisted to notify the Commission he has no intent of militarizing the Sheriff's Office and is looking into purchasing a conics box to be used as storage unit for the Sheriff's Office Equipment. Sheriff Gary Gold then notified the Commission the 10-33 Program can also be used to purchase heavy equipment that would help the Public Service Division.

Chairman Arthur Padilla requested that Sheriff Gary Gold re-paint or alter the equipment's appearance that way it could appear as property of San Miguel County rather than military equipment. Under-Sheriff Anthony Madrid informed the Commission that the Sheriff's Office is unable to alter the appearance of the equipment in any way as it would be a breach of contract.

Discussion ensued.

Upon a motion by Commissioner Leger, and a second by Commissioner Ortiz, the approval of the contract was approved unanimously with the condition San Miguel County Sheriff Gary Gold presents to the Commission prior to requesting any equipment and Sheriff Gary Gold obtain Commission concurrence on the equipment being requested.

ITEM 22: PUBLIC SERVICE DIVISION MONTHLY REPORT FOR THE MONTH OF AUGUST 2015

San Miguel County Public Service Operations Transportation Foreman Arnold Lopez presented to the Commission the monthly report including blading of county roads and/or special projects with the county roads.

Discussion ensued.

ITEM 23: OUT OF STATE TRAVEL REQUEST FOR YOLANDA CRUZ, DWI COORDINATOR TO ATTEND NATIONAL EQUITY SUMMIT IN LOS ANGELES, CALIFORNIA

San Miguel County DWI Coordinator Yolanda Cruz had been invited to attend the 2015 National Equity Summit as part of a New Mexico Delegation. The NM Health Equity Partnership will cover all associated costs for the NM Delegation, including conference registration, travel, lodging and meals. Participation in the Equity Summit offers opportunities to participate in sessions that focus on creating policy and community changes to build more support and resiliency for those most in need. This is an important step in preventing many DWIs, especially subsequent DWIs-as the root causes of many social ills are rooted in the conditions of a person's life.

Upon a motion by Commissioner Sena, and a second by Commissioner Ulibarri, the approval of out of state travel was approved unanimously.

ITEM 24: REQUEST APPROVAL FROM THE SAN MIGUEL COUNTY BOARD OF COMMISSIONERS

ITEM 37: CASH BALANCE REPORT AS OF SEPTEMBER 28TH, 2015

San Miguel County Finance Division Supervisor Melinda Gonzales informed the Commission of the September 28th, 2015 cash balance. The balances that were reflected are unreconciled balances. Reconciliations are done in the following month.

ITEM 38: BUDGET ADJUSTMENT RESOLUTION 2015-10-13-F1

San Miguel County Finance Division Supervisor Melinda Gonzales informed the Commission there will be an increase in the General fund expenditures for the amount of \$20,000 to fund the Samaritan House as well as a transfer out of \$21,000 to Fund 202 tied to change orders within the fund.

In Fund 202, in addition to the transfer of \$21,000 from the General Fund, the 2016 Local Government Road Fund (LGRF) Projects was budgeted, which consists of an increase in revenue of \$243,270, an increase in transfers of \$81,090 and a total increase of expenditures of \$324,360.

In Fund 210, an increase of \$5,000 in revenues from the District Attorney's Office was budgeted for additional cost to the parking lot. The expenditures were also increased by the \$5,000.

In Fund 470, Lodgers Tax was increased by \$18,000 to cover the award to the Pecos Business Association and to cover other costs that will be handles by the County.

In Fund 523 and Fund 527, which are EMS funds, the first budget adjustment was made to each fund due to a reversion that needs to be made to the Department of Health to prior year unused grants. The second adjustment was to account for the difference between the budgeted and actual FY15/16 EMS funds received.

In Fund 704, a transfer was made of \$81,090 to Fund 202 for the 2016 LGRF.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Sena, the approval of the budget adjustment was approved unanimously.

ITEM 39: LETTER DATED SEPTEMEBER 1ST, 2015 AND SIGNED BUDGET REQUEST RECAPITULATION

San Miguel County received a letter informing the County the final budget for Fiscal Year 2015-2016 approved by the Board of County Commissioners had been examined and reviewed by the Local Government Division and had found that it has been developed in accordance with applicable statutes and budgeting guidelines.

Section 6-6-5 NMSA 1978 requires the budgets approved by the division be made part of the minutes.

Section 6-6-6 NMSA 1978 states the approved budget will be binding on local officials and governing authorities. Any official or governing authority approving claims or paying warrants in excess of the approved budget or available funds will be liable for such claims and warrants allowed.

The final matter of the letter advised the Commission that approval by the Local Government Division is required by Section 6-6-2(H) NMSA 1978, of all transfers between funds and all budget increases.

HAVING CONCLUDED ITS BUSINESS AS THE COUNTY BOARD OF FINANCE, AT 6:30 P.M. THE COMMISSION PROCEEDED TO RETIRE INTO EXECUTIVE SESSION AS THE BOARD OF COUNTY COMMISSIONERS OF SAN MIGUEL COUNTY, NEW MEXICO, UNDER THE FOLLOWING ORDER AND PROCEDURE:

The County Manager recommended that the Commission retire into executive/closed session to consider the following matter: Personnel matters, matters subject to the attorney client privilege pertaining to threatened or pending litigation in which SMC is or may become a participant, matters pertaining to the discussion of the acquisition or disposal of real property, and matters pertaining to the discussion of bargaining strategy preliminary to collective

bargaining negotiations, all as permitted by Section 10-15-1(H)(2),(5),(7) and (8) of the Open Meetings Act, NMSA 1978, as amended.

Whereupon, at 6:30 p.m.., Commissioner Ortiz moved and Commissioner Leger seconded, that the Commission retire into executive/closed session to consider the matters noted and recommended by the County Manager, as particularized above. Upon a call of the roll by the Clerk, all five Commissioners answered in the affirmative on the motion to retire into executive/closed session, and the Commission proceeded to close the meeting as permitted by law.

At 7:20 p.m. Commissioner Sena moved and Commissioner Ortiz seconded, that the Commission reconvene in public session, and the motion carried. Whereupon Chairman Padilla noted for the record that the Commission considered and discussed in executive/closed session, only those matters and subjects for which the motion for closure was made.

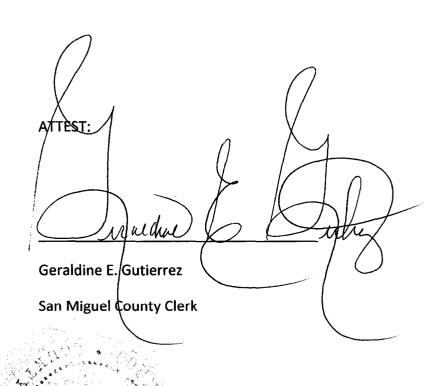

B. Matters subject to the attorney client privilege pertaining to threatened or pending litigation in which SMC is or may become a participant, as permitted by Section 10-15-1(H)(7) of the New Mexico Open Meetings Act, NMSA 1978.

C. Matters pertaining to the discussion of the acquisition or disposal of real property, as permitted by Section 10-15-1(H)(8) of the Open Meetings Act, NMSA 1978.

D. Matters pertaining to the discussion of bargaining strategy preliminary to collective bargaining negotiations, as permitted by Section 10-15-1 (H)(5), NMSA 1978.
