Mr. Madrid is recommending to award bid lots number one and two to Sierra Valley in the amount of \$321,538.19, including gross receipts tax. Bid Lot number three will go to HO Construction in the amount of \$36,857.49. These two companies are the lowest most qualified bidders. Mr. Madrid made a recommendation to approve awarding the bids to HO Construction and Sierra Valley Contractors for the 2017 Revenue Bond Project in East Pecos.
