Mr. Flores along with Mr. Alires got Senator Jeff Bingaman to donate half a million dollars for these projects. Highlands University and Las Cruces did studies pertaining to these dangerous waste hazards but nothing was ever finalized.

Mr. Ulibarri requested Commission approval for \$30,000.00 to fund EDC with deliverables. Luna Community College intern of the EDC Program Mr. Michael Adams informed the Commission of the different projects he is working with to help the community, such as the Commercial Kitchen. Commissioner Martinez requested the Commission go into executive session to further discuss this matter.

Ms. Anaya informed the Commission she has been working on the bill to legalize the Hemp plant. Ms. Anaya informed the Commission that in early 2017 two bills were passed but both got vetoed by the Governor. Ms. Anaya informed the Commission the Hemp Industry would be a great economic development for our communities.

7. SAN MIGUEL COUNTY COMPREHENSIVE PLAN SURVEY



8. ON-SITE FIRE DEPARTMENT APPARATUS MAINTENANCE AND REPAIR

San Miguel County Fire Chief Elauterio "Mike" Montano informed the Commission on recent requested proposals from those vendors who were qualified to provide on-site apparatus maintenance and repair. Three proposals were received, opened and evaluated. All three vendors met or exceed the minimum requested requirements. At this time, authorization is being requested to contract with the three vendors who provided proposals, those being Emergency Maintenance Services, MJM Service and Repair and New Mexico Apparatus. This would allow San Miguel Fire Department the ability to provide on-site apparatus maintenance and repair services as well as emergency repair service to the 12 Volunteer Fire Departments within San Miguel County. Mr. Montano requested approval from the Commission for the on-site Fire Department Apparatus Maintenance and Repair.

9. FIRE TRUCK

San Miguel County Fire Chief Mike Montano informed the Commission on September 28, 2017, San Miguel County Fire Department was notified by Mr. Eugene Pino, from State Forestry, that a 2008 Ford F550 Type 6 Engine would be transferred to Ilfeld Volunteer Fire Department. San Miguel County Fire Chief Elauterio "Mike" Montano and Ilfeld Volunteer Fire Department Chief Ken Aringdale, traveled to Springerville, Arizona for the purpose of picking up the vehicle. Permission was granted and the truck was picked up on October 4, 2017.

Final bidding will take place on December 7, 2017 starting at 12:00 p.m. Purchased items may be picked up on Friday December 8th or Saturday December 9th from the San Miguel County Public Works Department. J & J Auctioneers will be taking 10% of proceeds made. Mr. Gold informed the Commission the San Miguel County Attorney David Romero has reviewed and approved contract for legal sufficiency. Mr. Gold requested the Commission review and approve the "Auction Agreement."




