However, the 3/12th reserve requirement would fall lower than it should. This was not noticed as the Finance Supervisor was taking into account prepaid balances that are not taken out taken into consideration on the DFA budget side.

To adjust the LEPF budget based on the DFA Budget Review.

To budget the CARES Act award. To budget the EMW Award for the Cabo Lucero Volunteer Fire Department.

To adjust budget to Fund 753 based on FY19/20 reallocation of costs.

To budget transfer to Solid Waste of \$30,000

The money received from the Covid fund will be presented to the Commission
