### **UNFINISHED BUSINESS:**

SECOND READING AND PUBLIC HEARING – ORDINANCE NO. 6, SERIES OF 2018 – AN ORDINANCE APPROVING THE WELCH SUBDIVISION IN THE CITY OF STERLING, LOGAN COUNTY, COLORADO; AND APPROVING THE PLAT THEREOF:

City Manager Saling advised Council that first reading of this ordinance took place on May 22, 2018, and it was thereafter published. On May 2, 2018, the Planning Commission held a public hearing on the subdivision application submitted by Marge Welch, and found that the application met all requirements of Chapter 18, Subdivisions. The Planning Commission recommended approval of this subdivision, which will be known as the Welch Subdivision in the City of Sterling, Logan County, Colorado. The ordinance sets forth findings by City Council and approves the subdivision and plat.

City Clerk Forbes read the ordinance by title.

Mayor Torres opened the public hearing.

# RESOLUTION NO. 6-1-18, SERIES OF 2018 – A RESOLUTION BEFORE THE CITY OF STERLING, LOGAN COUNTY, COLORADO APPROVING AN AGREEMENT FOR TRANSFER OF ENTITLEMENTS FOR THE FISCAL YEAR 2018 WITH THE UNITED STATES OF AMERICA FEDERAL AVIATION ADMINISTRATION:

City Manager Saling advised Council this resolution approves an agreement for Transfer of Entitlements. This is a historical practice that the City has exercised in the past, and the formal agreement is requested. Since the City has no current or intended use of the funds apportioned to it for airport improvements in 2018, this transfer allows the funds to be used by the County of Fremont (Fremont County Airport). The City of Sterling has also been the recipient of transferred funds in the past through this practice. The funds being waived are in the amount of \$23,228.00.

Councilmember McCarty made a motion to approve Resolution No. 6-1-18, Series of 2018. Councilmember Appelhans seconded the motion. By a seven-yes vote, the motion was approved.

## RESOLUTION NO. 6-2-18, SERIES OF 2018 – A RESOLUTION BEFORE THE CITY OF STERLING, LOGAN COUNTY, COLORADO APPROVING A GRAZING LEASE AGREEMENT WITH JOSH STIEB FOR CITY-OWNED PROPERTY:

City Manager Saling advised Council the City owns approximately 147 acres of land located by the Sterling Municipal Airport, which is presently not in use for airport purposes, and advertised for bids for a grazing lease on said property. The only bid received was from Josh Stieb in the amount of \$1,100.00 per year. This resolution approves a Grazing Lease Agreement with Josh Stieb. The rental agreement for said grazing lease is \$1,100.00 per year, for a one-year lease.

Councilmember Rice made a motion to approve Resolution No. 6-2-18, Series of 2018. Councilmember Rhodes seconded the motion. By a seven-yes vote, the motion was approved.

# FIRST READING - ORDINANCE NO. 7, SERIES OF 2018 - AN ORDINANCE APPROVING THE HOUSING AUTHORITY SUBDIVISION IN THE CITY OF STERLING, LOGAN COUNTY, COLORADO; AND APPROVING THE PLAT THEREOF:

City Manager Saling advised Council that on May 2, 2018, the Planning Commission held a public hearing on the subdivision application submitted by the Housing Authority of the City of Sterling and Centennial Mental Health Center, and found that the application met all requirements of Chapter 18, subdivisions. This ordinance sets forth findings by City Council and approves the subdivision and plat.
