Remarks Due to above average rainfall for the year and Covid delays with some materials, labor, and equipment supplies, there were scheduling issues for the contractor who had the Annual Bid.
Projects RA-TCP-01-01-2020 and RA-TCP-01-02-2020 were carried over and completed this year, and RA-TCP-02-04-2021 had to be delayed until next year due to the weather and scheduling issues.
Projects RA-TCP 02-01-2021 and RA-TCP 02-02-2021 were resurfaced, and the only work remaining on the routes is permanent stripe.
Project RA-TCP 02-05-2021 is a bridge replacement project that is still in the design phase, so no funding for construction is needed at this time.
