## **COMMISSION MEETING CALLED TO ORDER**

County Administrator Pat Lyle presented to the Commission expenditures for \$455,783.99 and the operating transfers. A motion was made by Commissioner Tony Haynes to approve and seconded by Commissioner Jackie Swinford. Motion carried.

**DISCUSSION ITEMS**







**MEETING ADJOURNED**


