ALWAYS LOOKING FOR SERVICE PROVIDERS WITHIN THE COUNTY.

BBCOC COVERS AN 8 COUNTY AREA, WITH A 31 MEMBER BOARD. LOCAL COUNCILMAN DEMING REPRESENTS PERRY.

YEARLY TRY TO IDENTIFY THE GAPS BY MEETING WITH DIFFERENT ORGANIZATIONS TO SEE WHERE THE HOLES ARE.

BBCOC USE HUD AND DCF FOR FUNDING AS WELL AS SOME STATE AND LOCAL. TAYLOR COUNTY HAS NEW FUNDING AVAILABLE THROUGH REFUGE HOUSE.

TWO PROVIDERS FOR TAYLOR COUNTY ARE CATHOLIC CHARITIES AND BIG BEND HOMELESS COALITION.

PROMOTE HOUSING FIRST, THEN SERVICES.

CURRENTLY UNDERSTAFFED. TAKES UP TO 24 HOURS FOR PLACEMENT UNLESS A COLD NIGHT OR A FAMILY.

WEBSITE IS UPDATED FREQUENTLY.

EVERY JANUARY, BBCOC DOES A COUNT IN TAYLOR COUNTY OF WHO SLEEPS OUTSIDE, IN THEIR CAR OR IN AN EMERGENCY SHELTER.

SHOULD CONSIDER A STRATEGIC PLAN IN CONJUNCTION WITH JEFFERSON AND MADISON COUNTY TO MAKE RESOURCES GO FURTHER.

PARTNERS ARE MOBILE AND COME AT LEAST ONCE A WEEK TO TAYLOR COUNTY.
