## DISCUSSION:

COUNTY ENGINEER - THE BOARD AGREED TO OPTION 2 ON DECEMBER 7 AND THE COUNTY ATTORNEY DRAFTED A LETTER TO PIGOTT. UNFORTUNATELY, PIGOTT ATTORNEY RESPONDED WITH AN UNACCEPTABLE COUNTER OFFER. WE ARE FORMALLY DECLARING WE WANT THE SURETY COMPANY TO COMPLETE THIS PROJECT UNDER THE PERFORMANCE BOND. WE ARE ASKING THEM TO TELL US WHAT THEY ARE PLANNING TO DO TO COMPLETE THIS PROJECT. I AM ASKING THE BOARD TO ENDORSE THIS POSITION.

COMMISSIONER FEAGLE - ASKED THE COUNTY ADMINISTRATOR IF SHE IS IN AGREEMENT WITH THE COUNTY ENGINEER, AND MS. PEMBERTON RESPONDED YES. COUNTY ATTORNEY - IF YOU READ THE CORRESPONDENCE WITH MR. SELLERS, WE MADE A GOOD OFFER AND HE RESPONDS WITH MORE DEMANDS. IF THE BOND COMPANY HAS TO PAY THEY WILL GO AGAINST PIGOTT TO GET IT BACK. COMMISSIONER ENGLISH - HOW LONG TO COMPLETE THIS PROJECT?

COUNTY ENGINEER - THERE IS ABOUT SIXTY (60) DAYS OF WORK REMAINING. THAT THE COUNTY ROAD DEPARTMENT HAS BEEN DOING SOME WORK BY HAND TO FILL POTHOLES.

Mr. Pentecost,

Taylor County is formally requesting project completion under the terms of Performance Bond No. 07208F.

To date, we have exhausted all reasonable means to resolve the Contractor's Default and assert it to be ineffective to continue such efforts. Therefore, we are again requesting that the matter be resolved as provided for within the terms of the Performance Bond. Specifically,

- 1) Pigott Asphalt & Sitework, LLC and Westfield (Mr. Benjamin Campbell) were notified on September 28/29, 2020, that it was intended to declare Pigott Asphalt in default due to non-performance (Bond Para 3.1).
- 2) Pigott Asphalt & Site Work was notified on November 10, 2020 that their work stoppage resulted in Contract Default (Bond Para 3.2) pursuant to their November 4, 2020 notification of Non-Pursuit.
- 3) Surety Counsel (Mr. Pentecost) was notified on November 16, 2020, of decision to seek completion of the project under the terms of the Performance Bond (Bond Para 3.1).
- 4) Taylor County and NFPS (our CEI firm) attended a November 24, 2020, resolution meeting/conference with the Contractor and Mr. Pentecost (Bond Para 3.1).
- 5) Taylor County agrees to pay the balance of the available Contract Price to the Surety or a contractor selected to perform the contract in accordance with the terms of the contract (Bond Para 3.3).

Thus, after having complied with the prerequisite conditions, we are requesting that the options under Bond Para 4 (excluding Option 4.1) be utilized as soon as possible. For expediency, we suggest that Anderson Columbia be afforded the opportunity to complete the work effort as the replacement contractor. They are familiar with the project, have a detailed perspective of potential cost for completion, and are an approved contractor based on their past performance and efficiency.

Lastly, in accordance with Bond Para 5, we respectfully ask that you return your decision concerning this request with reasonable promptness. Our main concern is to finish the project as quickly and correctly as possible. The delay since the Contractor stopped work has only served to require reworking the bulk of the site work and portions of the previously finished roadway segment. Continued delay will only increase those costs further, increase those costs envisioned in Para 6, and unnecessarily present added liability from an unfinished roadway.
