Instructions Village of Tinley Park Monthly Amusement Tax Return

The Amusement Tax Return and the tax is due the last day of the month following the month covered by the return. (e.g. report for January due by February 28th)

Return & tax should be mailed to:

A return must be filed for each month (or part thereof), regardless of whether there is a tax due.

The amusement tax rate is four percent (5%) of the purchase price of admission.

Specific Instructions

Line 1 - Enter the total number of admission tickets sold or issued during the month. This number should include complimentary tickets issued or given away.

Line 2 - Enter the total amount of admission fees or charges including amusement taxes.

Line 3 - Enter the total authorized deductions which includes the following:

3a. Any Tinley Park amusement tax included in line 1. This amount cannot be greater than line 5 (tax due).

3b. Any County amusement tax included in line 1.

3c. Admission receipts from any amusement from which the proceeds inure to the exclusive benefit of organizations listed in section 126.02(C) of the Municipal Code of the Village of Tinley Park.

Line 4 - Subtract line 3 from line 2 to calculate the receipts subject to the amusement tax.

Line 5 - Multiply line 4 by 5% (.05). This is the amount of amusement tax due for the month.

Line 6 - Calculate a 5% penalty on the tax due (line 5) for late payment if the tax is not paid by the due date of the return. (Ordinance 2001-O-007)

Line 7 - Calculate a 5% penalty on the tax due (line 5) for late filing if the return is not filed by the due date of the return. (Ordinance 2001-O-007)

Line 8 - Interest of 1½% per month will be charged on the amount of tax (line 5) due for each month or part of a month the tax remains unpaid. (Ordinance 2001-O-007)
