Furthermore, any candidate who is already a Certified Patrol Officer who qualifies for experience preference points and wishes to exercise his/her right to use these points, must do so (**via email to civilservice@tinleypark.org**) with a copy of their ILETSB Certificate to the Civil Service Commission and such request **must be received by 5:00 p.m. on Friday, November 10, 2023.**

It is the candidate's responsibility to provide email notification to the Civil Service Commission of any change in name, address, telephone number etc. Failure to do so will result in his/her name being eliminated from the Eligibility Register.
