THE PRICE QUOTED HERE WILL BE FOR FAN BACK STYLE BENCH WITH ARM REST'S WITH APPROXIMATE DIMENSIONS OF (48" HIGH X 72" LONG X 28" DEEP) PLANTER BOX DIMENSIONS TO BE (22" HIGH X 17 1/2 " WIDE X 24" DEEP) THESE ARE THE SAME STYLE AND DIMENSIONS USED FOR LAST YEARS MODEL. THE CONSTRUCTION OF PLANTERS AND BENCHES ALSO WILL REMAIN THE SAME. THE FRAME AND LEGS WILL BE CONSTRUCTED FROM PRESSURE TREATED EXTERIOR GRADE LUMBER. THE SEAT SLATS AND ARM RESTS WILL BE CONSTRUCTED OF 5/4" THICK CEDAR STOCK. AS PER LAST YEARS MODEL SEAT BACK AND PLANTER BOXES WILL BE CONSTRUCTED OF 3/4' MDO PLYWOOD.
