

**ORDINANCE NO. 2003-O-036**

**AN ORDINANCE AMENDING ORDINANCE NOS. 2002-O-092, 2003-O-007,  
2003-O-025, 2003-O-026 and 2003-O-027, IN REGARD TO THE  
VILLAGE OF TINLEY PARK MAIN STREET SOUTH TIF DISTRICT,  
TO CORRECT A SCRIVENER'S ERROR**

**WHEREAS**, the President and Board of Trustees have previously adopted Ordinance Numbers 2002-O-092, 2003-O-007, 2003-O-025, 2003-O-026 and 2003-O-027 relative to the Village's Main Street South Tax Increment Financing District (hereinafter the "SOUTH TIF DISTRICT"); and

**WHEREAS**, Exhibit "A" attached to each of the aforementioned Ordinances set forth the description of the boundaries of the SOUTH TIF DISTRICT; and

**WHEREAS**, the map, permanent tax index numbers and common addresses set forth in Exhibit "A" attached to each of the aforementioned Ordinances was accurate, however, a scrivener's error has been noted at one (1) location within the legal description; and

**WHEREAS**, it is in the best interests of the Village to correct said scrivener's error;

**NOW, THEREFORE, BE IT ORDAINED**, by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

**SECTION 1:** That Ordinance Numbers 2002-O-092, 2003-O-007, 2003-O-025, 2003-O-026 and 2003-O-027 are hereby amended by correcting the following scrivener's error as contained therein:

- A. That the first legal description paragraph of Exhibit "A", relative to P.I.N.'s 28-30-302-015 and -016; 28-30-308-017 and -023; 28-30-312-003, -006, -009, -019, -021, -023, -024 and -025; 28-30-313-002, -004, -009, -010, -011 and -012; 28-30-314-003, -004, -005, -006, -007, -008, -009, -010, -011, -012 and -032; 28-30-

500-004-6004; and Pt. 28-30-500-004-6001, is hereby amended to correct a scrivener's error by inserting "(except the North 1/2)" in the sixth line thereof after "8", but before the comma after "8".

**SECTION 2:** That all other provisions of Ordinance Numbers 2002-O-092, 2003-O-007, 2003-O-025, 2003-O-026 and 2003-O-027 not corrected hereby shall remain in full force and effect.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.






