The Village of Tinley Park, population approximately 57,000, currently seeks certified applicants for the position of Firefighter to work variable hours/part time. Shifts are typically 0600-1800, 1800-0600 and scheduled by the employee. **This is not a full time position.**

Basic Minimum Qualifications:

- H.S. Diploma or GED Equivalent;
- Applicants must have reached minimum age of twenty-one (21) years by the date of employee's online application;
- Valid IL Class B non-CDL Driver's License or equivalent, or complete within first 90 days of employment;

For IL Office of State Fire Marshall Certified Basic Operations Firefighter, Firefighter II or higher:

- Valid CPAT (within one (1) year of national testing network pre-qualification test date);
- IL EMT-B or Paramedic preferred;
- IL Fire Apparatus Engineer (FAE) highly preferred;

For Firefighters with a minimum of 5 years' experience, may elect to complete Village of Tinley Park Firefighter ability assessment in lieu of CPAT, date to be scheduled post interview. Must successfully complete all online testing, submission of required documents, and interview prior to ability testing.

- *If not IL Office of State Fire Marshall Basic Operations Firefighter or Firefighter II certified, Must be verified NFPA 1001, **OR** National ProQual Board Credentialed Firefighter or better**;
- If hired, experienced firefighters or better not certified in the State of Illinois may be hired as Recruits* and must successfully complete all Village requirements including IL OSFM Basic Firefighter Operations, HazMat Operations, FSVO exams, practicals and other testing as required, within 60 days of hire date.

Application Process:

1. All applicants must first successfully complete all phases of the pre-qualification testing process at: www.nationaltestingnetwork.com;
2. Applicants who successfully complete online testing will be notified to submit Village of Tinley Park Application for Employment. Include copy of driver's license, applicable certifications from Illinois State Fire Marshall and/or NFPA, Illinois Dept. of Public Health and other certifications (i.e.: CPR, CPAT, etc.) as applicable. **Required documents to be submitted timely to ensure potential consideration;** and
3. Applicants selected successfully complete personal interview process for further consideration; and
4. Applicants selected must successfully and timely complete all pre-employment examinations including medical/physical, criminal background investigation, and physical ability testing.

Start hourly pay and benefits: State of Illinois currently certified Firefighters = \$15.70/hour* (*Non-IL OSFM certified hires earn \$8.46/hour or current IL minimum wage until IL OSFM certification). Illinois Municipal Retirement Fund ("IMRF") after completion of 1,000hr/yr; or deferred compensation (457 plan); plus additional, optional employee paid programs.
